TENNIS REFORM SUGGESTED.—A. D. Wakeman, well-known Multnomah Amateur Athletic Club tennis player, believes that tennis players should voluntarily make all tournaments coincide with the new "work or fight" draft regulations. Not that tennis players are idlers, but tennis tournaments, Wakeman points out, may be made to take time that should go to war work, or can be played when they would in no way interfere with war work. Accordingly, he suggests in the "Winged M" Bulletin, the official Multnomah Club paper, that instead of beginning at 2 o'clock in the afternoon or thereabouts, play in all the inter-club tournaments be set to begin at 5 o'clock. He would have the same rule apply to the Oregon state tennis tournament at the Irvington Club, beginning Monday, July 22.

VETERANS TO TALK.—Stirring word pictures of the western front are expected at the weekly luncheon of the Rotary Club at the Hotel Benson on Tuesday, when Dr. David Hughes, formerly chaplain with the Royal Welsh Fusiliers, and Lieutenant C. R. D. Schagel, formerly private with the Royal Field Artillery, will be the speakers. Both men were wounded while on active duty. Dr. Hughes having been seriously hurt while in the trenches, and Schagel in No Man's Land. Lieutenant Schagel has been retired because of his injuries. Dr. Hughes was discharged and is touring the United States and giving talks to shipbuilders and other war workers.

HOTEL DUMMERS WRECK.—When a strange man was noticed playing the drums in the jazz orchestra at the Multnomah Hotel Saturday night, inquiry as to the whereabouts of Casey Jones ran through the streets. Later Casey and a woman were discovered dining as guests of Manager Cloutier, and it developed that she was Casey's wife, and that their bridal dinner was to be their last in Portland for some time, since Casey has joined the Army. Those in the dining-room started applauding and sang Casey ran to the stage and sang "I Hate to Leave You."

SHIPPING BOARD MEN VISIT.—Edward R. Egbert, chief inspector of the United States Shipping Board, Emergency Fleet Corporation in the Northwest for steel construction, and D. M. Callis, assistant district officer, stationed at Seattle, arrived in Portland yesterday on a short business trip. Egbert was formerly stationed in Portland. Both are attached to the office of Captain John F. Blain, head of steel construction in the Northwest, stationed at Seattle, and were in Portland in connection with steel work under way here.

SIX-YEAR-OLD CHILD KILLED BY AUTO.—Clarence Old, aged 17 years, an employee of the Grand Avenue Garage, struck and fatally injured a 6-year-old child at Park and Davis streets late Friday afternoon. A. L. Roberts, of the Oregon military police, witnessed the accident and placed young Miller under arrest on a charge of reckless auto driving. He was turned over to the juvenile court and later released on \$500 bail. He will be tried in juvenile court today. Mr. Roberts says that Miller was driving 25 miles an hour.

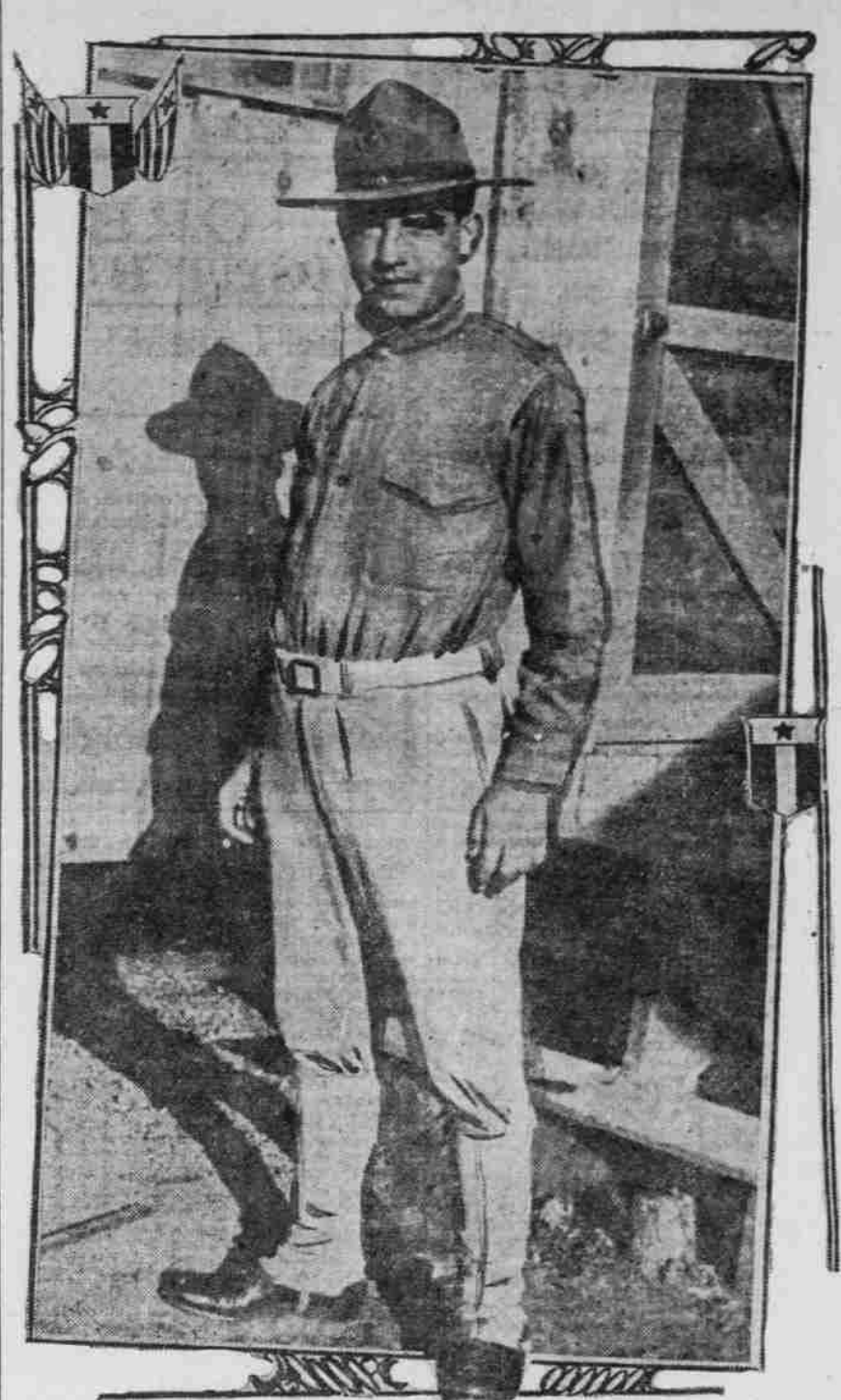

PORTLAND MAN CITED FOR BRAVERY IN ACTION ON WESTERN FRONT.

LOCAL YOUTH CITED

Herman McLeod Proves Bravery in Great Offensive.

BOY LAUDED BY PERSHING

With Three Other Men Private Plays Prominent Part in Defending Sector Occupied by United States Marines.

Herman L. McLeod, of Portland, 20 years of age, and just out of high school, and for some time past a member of the Marine Corps, has been cited for his disregard of danger, and will be awarded the distinguished service cross by General Pershing.

Private McLeod is the son of Mr. and Mrs. John McLeod, 181 Eleventh street, of this city. He has been in the trenches only about a month, but his work in the Bois de Belleu showed the bravery and disregard of danger of a veteran. General Pershing's commendation on the action of Private McLeod, sent to the War Department July 5, says:

"With three other men, Private McLeod was prominent in the attack on enemy machine gun positions on June 5 and 8, and the four men acquitted themselves with such distinction that they were ample for the rest of the command."

"I am the proudest mother in Portland," said Mrs. McLeod, after she had read General Pershing's dispatch in The Oregonian. "It is wonderful to have a son who will do a thing like that. He is my only son, and we are all more proud than I can tell."

Herman McLeod, although formerly of Portland, enlisted in the Marine Corps at Cleveland, O., May 23, 1917. He was sent to Paris Island, S. C., where he spent four months, after which he was transferred to Quantico, Va. He sailed for France after six weeks at Quantico. Letters received from him recently said he was afraid his company would be sent back without seeing action. In his letter he said he hoped they would be sent to the Somme.

The act of gallantry for which he was cited and for which he will receive the distinguished service cross occurred during the noteworthy offensive in the sector occupied by the United States Marines.

He has a sister, Miss Bea McLeod, who lives with her parents at 181 Eleventh street.

SOLOMON DELLAR DIES

Solomon Dellar, for 25 years a resident of Portland and for about 15 years a merchant in this city, died yesterday at the home of his daughter, Mrs. Hannah Ruvenky, 411 East Twelfth street, aged 88 years. He was born in Russia in 1830 and came to the United States with his family in 1882, coming to Portland in 1890. Here he was the proprietor of a cigar and tobacco store at Jefferson and Front streets until he retired from active business.

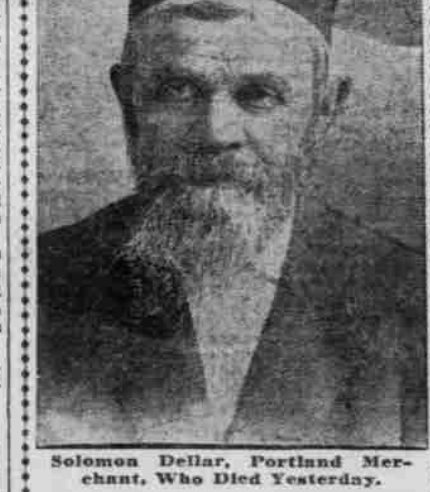
