

ENCOUNTERS OFFICIAL CASUALTY LIST

Passengers on British Ship Tell of Battles While Crossing Atlantic.

FIRST IS SIGHTED JULY 19

Vessel Zigzags Away in Race to Save Itself—Later Another Diver Appears—Third Thought to Be American Boat.

AN ATLANTIC PORT, July 28.—Passengers on a British liner arriving here today said that last Friday their ship gave battle to a German U-boat 750 miles off the New Jersey coast, and last night fired the shots at what is now believed to be an American submarine. Apparently neither undersea craft was hit.

This liner was one of several which was being convoyed with the giant Justicia when that vessel was torpedoned and sunk off the North Irish coast on July 28.

According to the passengers, a torpedo which hit the Justicia passed astern of their own ship and narrowly missed another merchantman before finding its goal.

Three Encounters Described. E. H. Butt, of Augusta, Ga., a brother of Major Archibald Butt, once aide to President Taft, who lost his life on the Titanic, described the three encounters with U-boats. The first, he said, came on July 19, two days after the merchantman was sighted by destroyers, left a British port. The booming of guns and the shrieking of whistles brought the passengers to the deck.

"The sea was smooth as we took our stations at the lifeboats," said Mr. Butt. "We were accompanied by our own destroyers, we left the scene in a race to save ourselves. We heard during the night that the Justicia and another were fighting the U-boats, and later learned that her struggle to survive had failed."

Super-Submarine Sighted. Mr. Butt said that the ship met no more trouble until last Friday afternoon when 750 miles off the New Jersey coast, the call to quarters was again sounded and the ship zigzagged several miles away. "This was a super-submarine," said Mr. Butt. "It made no attempt to come nearer and after firing solid shot, which fell short at least 1000 yards, began to fire shrapnel."

The exchange of shots lasted about 45 minutes, according to Mr. Butt, who said the U-boat then submerged and was not seen again. At the same time, he said, another submarine engaged a British freighter in the same manner and it was thought the U-boat was "if so, the British got a good one," said Mr. Butt, "for these boats are super-submarines which depend more on destruction by gunfire than by torpedoes."

Latest Thought American. "We got our next shock last night," he said. "In a smooth sea, a big submarine broke water three miles away and fired the shots at us. Three shots at the boat, while our commander signalled:

"Who are you?" "The shots fell close to the boat and we could see the flutter of flags but no sign of a flag to denote the nationality of the vessel which was engaged. The commander signalled to the gun crew to cease firing, and we came on, leaving the submarine on the surface. Rumor spread that it was the latest super-submarine was an American."

Among the passengers were Captain John L. Eaton, who was in command of the American steamship George L. Eaton, which was abandoned June 22 in European waters after she sprang a leak.

Attorney Charles J. Schnabel Devises New Plan for Care of Visitors Coming to Portland.

Attorney Charles J. Mr. Schnabel listed all the rooms in his own residence on Park avenue, and then collected the keys to all the homes of his neighbors where those families have gone to the beach for the summer, taking personal responsibility for the safety of the contents of the homes and the neighborhood. The helpful plan adopted by Mr. Schnabel will place quite a colony of old soldiers in that handsome residential section.

Attorney Schnabel is also chairman of the committee which is listing automobiles and drivers for the use of the Grand Army and Relief Corps members who will be sent on the Columbia River Highway trip at the close of the encampment.

"It is going to be quite a job to provide the transportation required for the veterans and their associated bodies, but I have faith in the patriotism of Portland people, and when the time comes they will turn to and put over this task as they have every other task that has been asked of them," said Mr. Schnabel.

Bakers Oppose Defense Council. YAKIMA, Wash., July 28.—Yakima bakers have voted unanimously not to longer follow the war economy programme which E. P. Dahm, of Seattle, representing the State Council of Defense, induced them to adopt a month ago. They claim that the programme of Sunday and evening closing resulted in loss and waste of food products, and that other cities of the state, including Mr. Dahm's own city, are not following the programme.

W. B. Chance Buys Flouring Mill. ALBANY, Or., July 28.—(Special).—Walter B. Chance, of this city, who has served the past 12 years as deputy state labor commissioner, engaged in the inspection of factories and workshops, has resigned his position and will terminate his work for the state at the end of this month. Mr. Chance has purchased an interest in the flouring mill at Aumsville, Marion County, and will move to that city to take charge of the operation of the plant.
