

CASES OF 66 TACOMA TAG SELLERS GO OVER

Continuance Granted Until April 16 on Defense's Plea.

RECALL PLANS ARE MADE

"Citizens' Committee of 25 Meets to Outline Campaign Against Members of City Commission."

TACOMA, Wash., April 7.—While crowds packed the police court, overflowed into corridors and gathered in little groups outside the city hall, Police Judge Blackett this afternoon heard arguments by counsel for the 66 men and women arrested Saturday for attempting to sell tags for the soldiers' and sailors' council despite the order of the city officials forbidding the sale.

In the and the court granted a motion of the attorneys for the defense and continued all cases until Wednesday, April 16, on the grounds that insufficient time had been given to prepare the cases for the defense.

The courtroom crowd cheered W. T. (Paddy) Morris, labor leader, when he entered the courtroom, having been released on \$1000 cash bail Saturday night following his arrest on a charge of inciting riot.

The other seven men arrested on the riot charge, and who are chiefly discharged soldiers, were still prisoners tonight in spite of promises from the council that they would be bailed out immediately. The delay is taken at police headquarters to be explained in the failure of an alleged \$5000 certified check to arrive from Seattle and the fact that the bulk of Morris' bail was paid in nickels and dimes.

"Citizens' Committee Meets." With the temporary disposition of the police court cases, interest shifted to a meeting which was held tonight of the "citizens' committee" of 25, called to develop plans for the recall of the entire Tacoma city administration.

As an answer to the steps taken by the central labor council to attempt the recall of the Tacoma city commission, the city officials today took steps to arrest more of the leaders of the Tacoma soldiers' sailors' and workers' council.

The officials declare this organization is nothing more nor less than a reproduction of a Russian soviet. Members of the city commission expressed little worry over the recall movement. "We will fight it out on this line, despite fifty recalls," F. H. Pettit, commissioner of public safety, who ordered the arrests Saturday, declared.

No blank petitions for recall signatures were taken from the office of the city clerk today.

Council Officer is Sought. Steve Burke, secretary-treasurer of the local soldiers' and sailors' council, is sought by the officers and, it is said, will be arrested soon as found. G. L. Kelling, another of the officers of the local council, who poses as a returned Canadian soldier, was picked up at the police station when he came in to talk with the men arrested Saturday.

"I accept the issue," said Mayor Bidwell. "If we are to have a fight between the Russian bolshevik idea and the American idea of government, I am for the United States. The action of this bunch Saturday justifies the action of the council in refusing them any concession to collect money on the streets of the city. The council went into this thing thoroughly. We knew what we were doing when we refused their request. We made a careful investigation and decided just what this crowd represented and we decided here were not what we wanted to encourage here. The bad phase of the whole thing is that they are hiding their true character and the danger of benefiting the soldiers, whom we all want to help to the limit."

Red Element is Sought. Commissioner Harrison, a member of organized labor, and himself a delegate to the central labor council, absolutely repudiated the element that is in control of the labor council. "If my future depends on the support of the bolshevik element of labor, I want to say that I will get out," said Harrison. "I am just as much a friend of labor as I ever was, but those who have got in power do not represent the interests of labor."

The Tacoma police allege that a number of the leaders in the soldiers' and sailors' council have criminal records. "The soldiers' and sailors' council announced the purpose of a fund to aid discharged soldiers and sailors, members of the council, in securing employment and maintaining those out of work. The attitude of the city was that 'tag days' were becoming so numerous that they threatened to be a nuisance and that a step had to be made somewhere. City officials deny the ban on 'tag sales' was aimed particularly at the council."

OREGON MAN'S NEPHEW SOUGHT John L. Johns Wanted in Tacoma for Inciting Riot.

SEATTLE, Wash., April 7.—(Special.)—John L. Johns, nephew of a supreme court justice in Oregon and an ex-soldier, is sought by the police here today for the Tacoma authorities, who telegraphed they have obtained a warrant charging him with inciting a riot. Johns is a member of the soldiers' and sailors' council of Seattle. He came to Tacoma from Seattle last Friday to manage the sale of tags for which a permit had been refused.

Warrants also were issued for the arrest of E. L. Kelling, recording secretary of the soldiers' and sailors' council of Tacoma, and E. T. Burke, secretary-treasurer, on charges of inciting riots.

Obituary.

JESSE C. REMICK, 40, died yesterday at his home, 264 Thurman street, from injuries suffered in an automobile accident near Garibaldi, Or., two weeks ago. Mr. Remick was a heavy stockholder in the Cummings-Morley company and came here from New Orleans in July, 1918, to superintend the construction of their new sawmill near Garibaldi, on Tillamook bay. The mill was completed recently, and Mr. Remick took great pride in erecting what he called model camps for his men.

Mr. Remick is survived by his widow and two daughters, Misses Frances and Martha Remick. Funeral services will be held today at 2 P. M. at the family residence, Dr. A. A. Morrison will officiate. An escort of Knights Templar will accompany the body from the home to the Portland crematorium, where that lodge, of which Mr. Remick was a member, will conduct the services.

CORVALLIS RESIDENT DIES

PETER A. MOSES PASSES AWAY AT AGE OF 90.

Funeral Services Will Be Held This Afternoon in Charge of Masonic Lodge.

CORVALLIS, Or., April 7.—(Special.)—Peter A. Moses died this morning at his home in this city. It was the first anniversary of his marriage and he had lived till November he would have been 91 years old. Funeral services will be conducted Tuesday afternoon in charge of the Masonic lodge, of which he had been a member for 41 years.

Mr. Moses leaves his widow and six children—Susan Jenks of Tangent, Jesse Moses of Alsea, Amasa Moses of Hoopla, Cal; Samuel Moses of Philomath, Josephine Trask of Corvallis and Victor P. Moses, postmaster of this city.

Up to the time of his death Mr. Moses was the oldest living graduate of Randolph Macon College, Va., from which he was graduated into the Methodist ministry in 1881. He served as president of Wallace Institute, Arkansas, in 1899, and of Quintan college in the same state in 1891.

During the civil war Mr. Moses served as chaplain in the confederate army and after the war was elected state senator from Arkansas. He was married in 1888 and moved to Oregon in 1894. He served as principal of the schools in Brownsville, Albany, Lebanon and Jefferson and as pastor of the South Methodist church at Brownsville, Lebanon, Junction, Tangent, Lewisburg, Dayton, Roseburg, Jacksonville, Myrtle Creek and Corvallis.

After resigning his pastorate here Mr. Moses found life with nothing to do too irksome, so at the age of 80 he enrolled at the Oregon Agricultural college as a student in agriculture. He was a student of Hebrew up till a few weeks before his death.

FOSTER ROAD PLAN MADE

CITY ENGINEER COMPLETES IMPROVEMENT SPECIFICATIONS.

Residents Urge Paving and Moving of Portland Railway Tracks to Center of Wide Street.

City Engineer Laurgaard yesterday completed the specifications and cost of the improvement of Foster road from East Fifty-second to Seventy-second street. The improvement, which has been urged by the residents of the district, will cost the property owners approximately \$113,000 and the Portland Railway, Light & Power company approximately \$12,000, providing the traction company decides to move its tracks to the center of the roadway. The traction company now owns a right of way on one side of the roadway and City Engineer Laurgaard has worked out a plan whereby the company will relinquish its franchise rights on the one side of the roadway and accept a franchise for the use of the center of the roadway.

If the company agrees to do this it will cost approximately \$20,000 to move its tracks and about \$12,000 for paving. On the other hand, should the street go through as it is the company will be forced to pay for its improvement of the street itself, as well as the installation of curbs, which will be about three times the cost of the city engineer's plan.

OLDEST MAN IN IDAHO DIES

Russell Newman, Reported Oldest Oddfellow in U. S., Born in 1811.

BOISE, Idaho, April 7.—Russell Newman, perhaps the oldest man in Idaho and said to be the oldest Oddfellow in the United States, is dead at the home of his son in Midvale. Mr. Newman had been a resident of Weiser, Idaho, for a number of years and up until within two weeks ago enjoyed good health. Mr. Newman was born in Kentucky, March 20, 1811, and was a pioneer in Missouri, Colorado and Idaho.

TRAIN SERVICE RESTORED

Conditions Following Recent Heavy Snowstorm Remedied.

DENVER, April 7.—Train service, both northwest and east of Denver, had been restored tonight virtually to normal conditions, following the heavy snowstorm of yesterday in Wyoming, Montana and Nebraska. Trains were posted tonight as running on schedule. Wire service, reported interrupted by the storm, also has been virtually restored to normal.

SOLDIERS REDEEM PLEDGE

Of late years he left the law practice and engaged in mining and mining law. He leaves a widow and three sisters, Mrs. J. Robb and Mrs. Addie Evans of this city and Mrs. Laura McDonald of Antelope, Or.
