

## RUSSIAN ARMY DISRUPT RED HUNGARIAN ARMY

Part of Force Captured, Balance Put to Flight.

## COMMUNISTS ARE LOSING

End of Soviet Government in Budapest Believed to Be Near—Germany Becoming Quieter.

BERNE, April 25.—(French wireless service.)—Part of the Hungarian communist army facing the Roumanians southeast of Budapest has surrendered and the rest is in flight, according to a Roumanian official statement received here.

West of Budapest the Czechoslovakians have occupied Komorn, on the Danube and Raab (Gyor).

GENEVA, April 24.—The Roumanian bureau at Berne announces that after the visit of General Franchet d'Esperey to Budapest recently Roumanian troops were ordered again to take the offensive against Hungary. It is said the order provoked great enthusiasm and that a number of Saxon officers and troops from Transylvania joined the Roumanian army, which, in a rapid march occupied Grosswardein, capital of the province of Bihar.

BERLIN, April 25.—(By the Associated Press.)—Hungary has hermetically closed all her borders in an effort to control the Roumanian invasion and prevent unfavorable news from escaping from the country. Reports from Budapest therefore are contradictory, but all indicate the situation is grave.

**Soviet Power Is Waning.**

The days of the soviet government are perhaps numbered. The entire powers are said to have 60,000 colonial troops in Neusatz, which are advancing as a Roumanian reserve. The Czechs are believed to be preparing to attack the people of Transylvania have revolted and are advancing with the Roumanians because of the anti-soviet measures imposed by the soviet regime.

A panic is said to reign in Budapest where the communist authorities are reported to be ruthlessly arresting scores of the bourgeoisie. Thousands of the citizens are fleeing, according to reports.

**Police Start Movement.**

The Budapest police have begun a counter revolutionary movement, but it is said that all involved have been arrested. Government troops are leaving for the front unwillingly, having in mind the experience of their comrades who capitulated to the Roumanians.

GENEVA, April 24.—Czechoslovakians have attacked the city of Wlatzen, 20 miles northeast of Budapest, which is expected to fall soon. French troops are said to be aiding the Roumanians in their advance in eastern Hungary, according to advices received here from Vienna.

BERLIN, April 25.—(By the Associated Press.)—Almost as suddenly as the recent strikes began here, there and everywhere, Germany appears to be quieting again. The coal miners in the Ruhr district are returning to work and those in the Danubian and Silesian districts, as well as half a dozen other places, have returned to their collieries.

**Communist Plans Ignored.**

The men are resuming work, though communists have urged a continuation of the strike.

A big factor has been distribution of American food.

In Brunswick the authorities have been able to tighten regulations incident to martial law. Hamburg is almost the only city, with the exception of Munich, where matters have not quieted.

## FOOD SUPPLY INADEQUATE

U. S. CIVILIANS IN OCCUPIED GERMANY IN STRAITS.

Proposal Made That Relief Be Sent by Parcel Post—Inter-Alleed Commission in Session.

COBLENZ, April 24.—(By the Associated Press.)—A number of American civilians in various parts of occupied Germany are in serious straits because of the food situation, according to reports reaching American army headquarters here, and efforts are being made to reach them with supplies as soon as possible.

Among those who have requested the civil affairs officers of the third army to take some action toward the relief of the Americans in question are several members of congress who have been in Coblenz recently. It is proposed to send the food required by parcel post. Switzerland has been doing this for some of her nationals and Holland this week began sending various kinds of provisions to Dutch subjects in the unoccupied districts of Germany.

An inter-alleed food commission of 25 members will begin a three days session tomorrow in Coblenz. The principal question to be decided is that concerning the rationing of civilians in occupied Germany. In the American area of occupation there are approximately 850,000 Germans, in the British area 2,000,000, in the French 2,000,000 and in the Belgian 1,500,000.

## TWO STORES ARE ROBBED

Burglars Make Away With Money and Merchandise.

DALLAS, Ore., April 25.—(Special.)—During the past few days two stores, one at Monmouth and the other here, have been entered by burglars and goods to the amount of several hundred dollars have been carried away. No far officers are without a clew leading to the identity of the prowlers.

The W. R. Ellis confectionery store here was entered Monday, the robbers securing about \$45 in cash and \$100 worth of tobacco and other goods. Tuesday night the store of the Miller Mercantile company, at Monmouth, was entered and merchandise valued at \$300 was taken.

place of food products for large sections of Europe, while oleomargarine factories will be started again in Germany, using vegetable oils.

Some European countries have decided to get along for the balance of this year without any corn from the United States.

"As far as America is concerned," Mr. Barnes said, "we have at present no intention of asking any change in

the milling processes now maintained and which are not under any supervision whatever. We do propose to relax the strain on our own flour supplies by contributing to the general European relief programme a 'victory' flour with a mixture of corn flour, rice flour, or barley flour under prescribed percentages and are today advising the milling trade that offers will be received next Thursday for these mixed victory flours for export.

"We are also taking steps to secure the co-operation of American mills in making rye flour from the large stocks of rye at present owned by the corporation.

**Shipments Are Disappointing.**

"We have known for some time that shipments of wheat from Australia and Argentina to European countries were sadly disappointing.

"We have repeatedly emphasized in the last two months that America was still the main reliance of Europe against famine and that probably it must continue to be that way for many months. We have no direct advice that there is contemplated abroad a war bread, in the sense indicated by this cable, but we have no doubt that the allied and other importing countries have increased their extraction of flour from wheat and may even contemplate admixture of other flours, such as rye and barley flour.

The new winter wheat crop in this country promises to be very early, Mr. Barnes said, adding:

"With us it is solely a question of how much we can fairly contribute to alleviate distress abroad, and we shall do that to the uttermost without relinquishing hardship on our own people."

## McADOO'S FUTURE TALKED

CANDIDACY FOR PRESIDENCY IS EXPECTED BY MANY.

Sentiment in Washington Reported by Joseph J. Fitzsimmons, Former Watchman in White House.

Many are of the opinion in Washington, D. C., that William G. McAdoo will seek the democratic nomination for president in 1920 and that President Wilson will gladly retire from public life, according to Joseph J. Fitzsimmons, who returned yesterday from the nation's capital, where for the past six years he has been employed as a watchman on the White House grounds.

Mr. Fitzsimmons was formerly a special police officer in Portland and has returned to this city with his wife to make Portland his home again. He stated that President Wilson was exceptionally popular with the attaches of the White House and that in spite of the turbulent times during the past few years, the nation's chief executive was always ready to jest with the employees.

For the past year the Portland man was in charge of the traffic detail of the White House guards and in that capacity was often called upon to assist the Washington officers in dispersing crowds of ardent suffragettes who gathered at the White House gates in demonstrations.

**FRENCH CLAUSE OPPOSED**

Wilson to Make No Alliance Not in Spirit of League.

PARIS, April 25.—(Special wireless.)—The French continue to press urgently for the Anglo-French-American alliance as an indispensable French security against Germany, but President Wilson authorized the announcement today that nothing would be done contrary to the spirit of the league of nations.

There will be an interval between the signature of the peace treaty and the time when the league of nations comes into operation, during which period an alliance will be France's only sure safeguard, but its necessity will disappear with the appearance of the league.

The French, with customary diplomatic skill and their familiar methods, are striving to commit the powers to an extension of such a temporary alliance, made for the purpose, into the permanent instrument. This scheme will not succeed.

## REFERENDUM DECISION DUE

Supreme Court to Rule on Action of Wine Growers.

SALEM, Ore., April 25.—(Special.)—A decision in the mandamus proceedings brought by the California Wine Growers in an effort to procure a referendum of the ratification by the recent legislature of the national prohibition amendment, expected from the supreme court next Tuesday.

The wine growers are seeking to compel Attorney-General Brown to prepare a ballot title for the referendum. If they succeed in this they will then be compelled to go to court once more to compel the secretary of state to place the measure on the ballot.

## TRAINING CORPS BIG ONE

One Hundred Thousand Students at 308 Institutions.

WASHINGTON, April 25.—Units of the reserve officers' training corps are being maintained at 308 institutions and comprise 100,000 students.

An official statement by the war department today shows that 563 officers and 450 non-commissioned officers have been detailed as instructors.

## PRISONER SEEKS FREEDOM

GEORGE HARRISON ALLEGES ILLEGAL COMMITMENT.

Petition for Writ of Habeas Corpus Directed at Warden Stevens and Governor Olcott.

SALEM, Ore., April 25.—(Special.)—George Harrison today filed in the circuit court a petition for a writ of habeas corpus demanding his release from the state penitentiary on the grounds that he is being unlawfully restrained by Warden Stevens and Governor Olcott. The petition was filed by Attorney Tom Garland of Portland. The hearing was set for May 13 by Judge Kelly.

Harrison was indicted by the Multnomah county grand jury for assault with a dangerous weapon. While intoxicated, it is alleged he attempted to hold up several persons at a filling station. He was captured when an old man hit him on the head with a hammer.

His petition, as filed in the circuit court today, alleges that the records of the Multnomah county circuit court show that the indictment against him has been dismissed. He further alleges that there is no record in Multnomah county to show that he ever pleaded guilty to this or any other indictment.

The commitment in the hands of Warden Stevens shows that Harrison was given a term of from one to two years. He has been in the penitentiary for 11 months.

## PORTLANDER HAS CONTRACT

Joplin & Eldon Unable to Handle Pacific Highway Work.

EUGENE, Ore., April 25.—(Special.)—Joplin & Eldon, to whom has been awarded the contract by the state highway commission to grade the new stretch of Pacific highway between Walker and Cottage Grove, a distance of nearly four miles, yesterday reported that they would be unable to do the work on account of other contracts that require their attention and that W. P. Ryan, of Portland, has taken it off their hands.

Mr. Ryan was in Eugene yesterday and made a trip over the route of new construction, expressing his willingness to take the contract. He will start work about May 1.

## WOMAN HURT IN AIRPLANE

Air Currents Force Landing; Machine Badly Smashed.

BILLINGS, Mont., April 25.—The wife of Lieutenant Fletcher Woolston of Forsyth sustained injuries this afternoon when the Curtiss airplane in which they were traveling from Billings to Forsyth was unable to maintain its equilibrium owing to cross-air currents, compelling a forced landing at the eastern edge of the city. The airplane was badly smashed.

Mrs. Woolston is the daughter of Senator J. E. Edwards of Rosebud county.

Lieutenant Woolston was uninjured.

## TRACTOR SHOW BIG EVENT

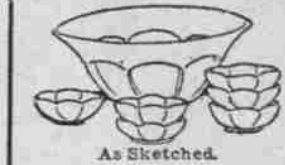

## PERJURY HEARING IS SET

WALLOWA MAN ACCUSED OF FALSIFYING REPORT.

Eight Cases Slated for Supreme Court Hearing During Sessions at Pendleton.

SALEM, Ore., April 25.—(Special.)—An appeal by the state in the prosecution of George S. Craig, wealthy Wallowa county resident, charged with perjury, will be one of the most important cases heard by the supreme court when it convenes at Pendleton on May 5 for its semi-annual session east of the mountains.

Mr. Craig is alleged to have perjured himself in making a return of his personal property to the county assessor of Wallowa county. The state alleges he failed to account for approximately \$20,000 of personal property. The case was tried before Circuit

Judge Knowles, who gave Mr. Craig his freedom on a demurrer. The district attorney then appealed to the supreme court.

Of eight cases coming before the court at the Pendleton session, five are appeals in criminal prosecutions. They are: State vs. Radtke; State vs. Newlin; State vs. Craig; State vs. Moss; State vs. Pacific Livestock company. The three civil cases are: Grace E. Fuller vs. O. W. R. & N. company; Horr vs. Reece; McAllister et al. and Grant Chrome company vs. J. T. Marks et al.

## TWO ACCIDENTS ARE FATAL

Industrial Accident Commission Issues Weekly Report.

SALEM, Ore., April 25.—(Special.)—Two fatal accidents were reported to the industrial accident commission during the past week, according to the weekly accident report made public today. One man was killed in a lumber mill and the other by an electric train at Goodin.

There were 493 accidents reported for the week, of which 448 were subject to the provisions of the workmen's compensation act.
