

GOVERNOR SELECTS AUTOMOBILE BOARD

Formal Appointments Will Be
Announced Today.

ALL OREGON REPRESENTED

M. L. Granning of Corvallis, H. B. Fancher of The Dalles and E. E. Bogge of Portland, slated.

SALEM, Or., May 28.—(Special.)—The board of the automobile department at the Oregon Agricultural college; H. B. Fancher of The Dalles and E. E. Bogge of Portland will be the three members constituting the board of automobile mechanics' examiners provided for by an act of the last legislature which becomes effective tomorrow. Announcement that he will appoint these three men was made by Governor Olcott today.

The men were selected according to their qualifications. All applicants for places on the board first conferred with Professor Granning who reported to the governor on the question as to whether or not they were qualified. With these reports before him the executive named the members of the board with as due regard to geographical location as possible.

He has been actively engaged in the automobile business in both garage and repair shops for more than 14 years, at first as a mechanic, later as shop superintendent and as proprietor. He also served a two years' mechanics apprenticeship in Minnesota and has a three years' course in the mechanical engineering department of the University of Minnesota.

Committee to Organize.
E. E. Bogge of Portland received the endorsement of both the repair and garage men's association and the motor dealers' association, as well as that of a large number of leading business men. He has been in the garage business in Portland for practically 13 years, has been superintendent of one of the largest industrial garages in the city, was for three years with a leading manufacturer of automobiles handling both tractors and autos, and has a thorough familiarity with all branches of auto mechanics work.

Within the next 30 days the board is to meet and elect a secretary and treasurer and to provide for rules regulating the examination of auto mechanics. The board is to hold at least bi-monthly examinations at Portland, LaGrande, Astoria, Klamath Falls and Eugene.

Appointments Are Laid.
Persons desiring to secure licenses as automobile mechanics must take the examination provided for by the board and pay a license fee of \$5. An additional license fee of \$5 will be imposed annually thereafter to successful applicants. Failure to follow provisions of the act within six months after its passage shall constitute a misdemeanor punishable by fine of not to exceed \$100.

Members of the board are to receive \$10 a day and actual and necessary traveling expenses for each day necessarily employed. Fees collected for issuance of licenses go into the general fund of the state. James H. Stewart, who is here managing the campaign for Marion county's market roads and who is joint author with Senator Shanks of the auto mechanics bill, said this evening he was delighted with the splendid personnel and high qualifications of the board appointed by Governor Olcott.

91 Enlist, Eight Die.
CENTRALIA, Wash., May 28.—(Special.)—Ninety-one former Centralia high school pupils and teachers served in various branches of service during the world war, according to a list just compiled. Eight of these died in service. Those who paid the supreme sacrifice were: Lieutenant Elmer Noble, killed in action; Albert Cobb, who died at the naval training station in Seattle; Charles Case, killed at Camp McArthur, Tex.; George Rardin, who died at Vancouver; Lieutenant Homer Ward, who died of disease in France; and Earnest Teacher, reported missing in action since July, 1918.

Pendleton Church to Build Soon.
PENDLETON, Or., May 28.—(Special.)—Preparations for the erection of the new \$100,000 Presbyterian church building here were completed last night. Most of the needed money is raised. The church already has the property and was ready to build last fall, when the government restrictions halted its programme. It is expected that ground will be broken for the new building within six months.

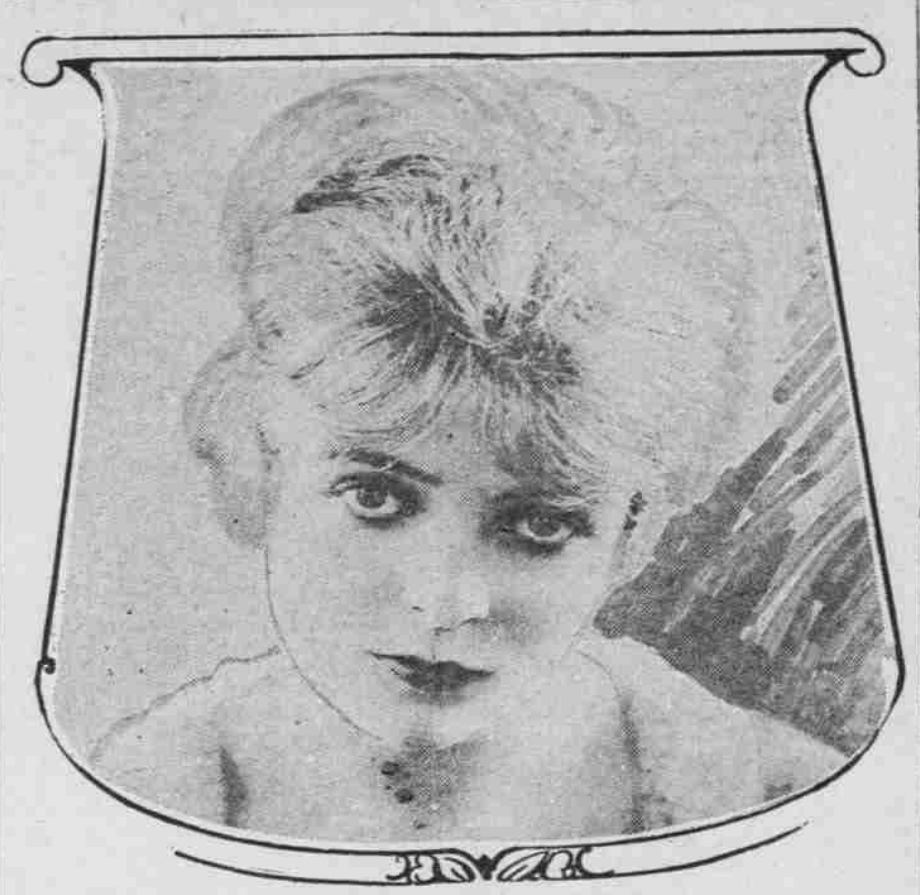

"A REGULAR FELLOW" is a regular comedy. This Taylor Holmes fun-film is a picture full of surprises. MOB HANGS SLAYER OF TWO

GUARDS OVERPOWERED AND ROPE PLACED AROUND NECK.

Jay Lynch, Confessed Murderer of Sheriff and Son, Dies in Courthouse Yard.

LAMAR, Mo., May 28.—Jay Lynch, confessed slayer of Sheriff John Hallow of Barton county, and the sheriff's son, was hanged today by a mob which took him from the hands of officers in the courthouse and lynched him in the yard of the building. Lynch had been given a sentence of life imprisonment by Judge B. G. Thurman. The murder of which he was convicted took place on March 3.

After sentence was passed Judge Thurman, fearing violence, had the prisoner taken into his private office. About 500 persons were in the courtroom. Lynch was guarded by seven officers.

Shortly after 3 o'clock, 24 men came into the private office of the judge, overpowered the guards, and putting a rope around Lynch's neck, dragged him into the yard of the courthouse and hanged him. The courtyard was filled at the time of the hanging by persons who had come out of the courtroom.

Lynch's wife, baby, mother and sister were in the judge's office when he was taken out by the mob. His handcuffs had been removed so that he might hold his baby, and he had just given the child back to its mother when the men entered.

TEACHER'S APPEAL HEARD

Dismissed Woman Declares Presence Necessary at Divorce Hearing.

SOUTH BEND, Wash., May 27.—(Special.)—Edith Soper, county superintendent, is considering the appeal of Miss Lenore Sullivan, former commercial teacher in the Raymond high school, who was dismissed by the school board for alleged absence without leave. Attorney E. M. Bond for Miss Sullivan and Martin Welch for the school board argued their cases before Miss Soper this afternoon.

The testimony of C. L. Henkle, president of the school board, was practi-

cally expected to justify her "past" that Mary gets into trouble.

CONFISCATED DOORS BACK

Police Return Barriers to Chinese, Who Put Them Up Again.

Chinatown is overjoyed. Smiling countenances greeted police officers last night as they returned the doors removed and seized a short time ago in an effort to break up gambling in the district. The doors were seized under provisions of a city ordinance which was recently held invalid by Judge Kavanaugh, when several cases were appealed from the municipal court by the incensed Chinese.

Several patrolmen on loads piled high with the doors were distributed by the police and identified by the Chinese as their property. The doors were to be placed in the truck and be replaced by the Chinese.

Victory Arch Razed.

Victory arch, constructed as a part of the architectural embellishment of Liberty center to commemorate the proud record of Portland and Oregon in preceding loans and to stimulate interest in speedy completion of the Victory loan drive, was yesterday demolished by workmen.

For several days the removal of Victory hut, erected at the Morrison and Sixth street corner of the old postoffice building, has been in progress, and the force was diverted to the arch that formed an imposing entrance to the enclosed court.

Forest Grove Starts Post.

Application for the second charter in the state for the American Legion was made to State Chairman Elvers yesterday by Forest Grove, where a post has been organized with more than 100 members. Portland organized the first post last Saturday night. Charters are expected shortly from the national organization.

EXTREME SABOTAGE BY I. W. W. CHARGED

Copy of Seized Pamphlet Identified at Trial in Seattle.

RAID IN 1918 IS RECALLED

Counsel for Defense Accused Government Operative of "Planting" Inflammatory Literature.

SEATTLE, Wash., May 28.—(Special.)—Further evidence that certain members of the I. W. W. knew no limit in sabotage to accomplish their aims was adduced today when Ludwig Frank, former department of justice operative, identified a copy of "a few hints to active saboteurs," a typewritten pamphlet seized by him May 3, 1918, in the trial of James Bruce, I. W. W. organizer, who is facing a charge of criminal anarchy before Superior Judge Walter M. French.

Frank seized the document, he told the jury, when he raided the I. W. W. headquarters at 202 Second avenue. South, five months after federal officials inaugurated a nationwide raid on I. W. W. headquarters. This admission caused George E. Vanderveer, chief counsel for the defense, baldly to charge that the inflammatory pamphlet was "planted" for the purpose of "jobbing" any I. W. W. the government sought to prosecute.

Over Vanderveer's bitter objections Judge French ruled that the jury was entitled to have the document read to them. "The hints to saboteurs," as read by Deputy Prosecuting Attorney Charles E. Claypool, contained detailed instructions as to the manufacture and handling of such agents of sabotage as nitroglycerine, dynamite, gun cotton, blasting quicksilver, fire bombs, red pepper and poisoned bullets and daggers.

Instructions Passed Along.

"Never give your real name or address," the document cautioned its readers. "Do not call on revolutionists who have been compromised by the federal authorities. Pass these instructions on as soon as you have memorized them."

"What spy planted these instructions in the files of the I. W. W.?" Vanderveer hotly demanded on cross-examination.

"No spy that I know of," responded Frank.

Coupled with "hints to saboteurs," as identified by Frank, was a photographic copy of a letter, as identified by E. R. Tobey, deputy United States marshal, as revealed by the I. W. W. "playing ball" with Germans and pro-Germans of Seattle during the war.

Attorney Protests Bitterly.

Over Vanderveer's emphatic protest the following letter, typed on a letterhead purporting to be that of the Lumber Workers' Industrial union No. 500 of the I. W. W., and addressed to William D. Haywood, head of the I. W. W., dated August 2, 1917, was read to the jury:

"Fellow workers—There has been considerable agitation among the lumber mills, shippards and other industries, and the old bugaboo of 'patriotism' is being revivified and spread. The government has been asked to interfere, and it is reported that government agents here are active.

"We have the good will of the German people here, and we feel sure that they are in sympathy with our cause. We do not call them Germans, however, but refer to them the same as we do the others—as fellow workers. We are going to carry our points if we have to stop every industry on the Pacific coast."

As soon as the letter was read to the jury Vanderveer branded it a "cold plant." The letter, he said, Tobey testified, when he raided I. W. W. headquarters in the Union block, on September 5, 1917.

REALTY MEN ASK PERMITS

State Department Gets 1000 Applications from Brokers.

SALEM, May 28.—(Special.)—Nearly 1000 applications have already been received by the real estate department from realty brokers who want to take out licenses for the current year. C. V. Johnson, who has been appointed manager of the real estate department by insurance Commissioner Wells, began his duties today. Although the law does not go into operation until tomorrow.

"Under our interpretation of the law it will be practically impossible for curbstone real estate dealers to operate in Oregon," said Mr. Wells today. "We are going to be strict, so far as giving licenses is concerned, and any dealer with a past record for shady transactions is apt to have hard luck when he attempts to procure a license."

The law provides a license fee of \$5 a year, which will make the new department more than self-sustaining.

Seattle Men Visit Centralia.

CENTRALIA, Wash., May 28.—(Special.)—A delegation of more than 40 business men of Seattle, constituting a committee of the Seattle Chamber of Commerce, visited Centralia today. A luncheon in the hotel was held this noon at the local Chamber of Commerce. The Seattleites are making an attempt to break up the strike in Chehalis, where they will spend the night.
