"Agriculturist Can't Work 18 Hours to Support Laborer on 6-Hour Basis," Says Kansan

CORVALLIS, Or., Oct. 12 .-- (To the Editor.)-Should farmers choose to strike back at organized labor they might find a more convenient and reputable method than the technical strike, according to H. B. Walker, Kannas state irrigation engineer, who ends the boycott of labor.

In his annual address before the Kansas state irrigation congress Mr. Walker advocated a return of the farm to family production basis. which would help solve the farm labor problem by forcing industrial labor to accept farm employment or starve. He thinks that a good many of the families of urban laborers would sattle on lands now forced into disuse by lack of workers.

"We can't have the farmer work 18 hours a day to support the laborer on a six-hour basis." Mr. Walker declared, according to the Kansas Ag-ricultural college press bulletins. "Much of the labor shortage is due not so much to lack of men as to de-creased hours on work and ineffic-tent service rendered."


