

PEACE TREATY VOTE IN COLLEGES MIXED

Compromise With Immediate Ratification Leads.

LODGE RUNNING BEHIND

Mild Reservations Strongly Supported—Small Number Favor Rejecting Covenant.

NEW YORK, Jan. 13.—Ratification of the peace treaty by compromise polled the heaviest vote in 32 colleges and universities throughout the country which reported complete returns tonight in the intercollegiate referendum voted upon today by the student bodies of 400 institutions of higher learning. In the 32 colleges, which include the great eastern universities of Harvard, Yale, Princeton, Columbia, Cornell and the University of Pennsylvania, a total of 29,910 votes were cast. Of these 11,182 were in favor of ratification by compromise and the next highest vote cast, 9,002, was for ratification without reservations or amendments.

The students voted on four proposals, unreserved ratification, opposition to ratification in any form, ratification with the Lodge reservations and ratification by compromise. The 32 completed returns showed 6,563 votes for the Lodge reservations and 5,183 cast against adoption of the treaty in any form.

The results in the total returns received so far represent virtually the same division of opinion as indicated by the individual returns for 32 colleges, all of which are situated in the east, south or middle west. Returns from the western states are not expected before tomorrow, when the total vote for the country will be tabulated and made public by the intercollegiate treaty referendum committee here.

BOSTON, Jan. 13.—Mixed results were shown in the balloting in New England colleges today on the ratification of the peace treaty and the League of Nations. In most of the colleges four propositions were voted upon:

1.—Favoring ratification without amendments or reservations.
2.—Opposing ratification in any form.
3.—Favoring ratification with the senate majority reservations.
4.—Favoring any compromise which would make possible immediate ratification.

Two additional propositions were on the ballot at some of the colleges as follows:

5.—Favoring a separate peace with Germany, leaving the question of a League of Nations to be settled afterward.
6.—Favoring a compromise on reservations at which would avoid danger of defeating ratification while still making clear that congress has sole power to declare war; domestic questions and the Monroe doctrine are outside the jurisdiction, league plural votes are disqualified in any dispute in which this college has an interest from voting and this country is to be sole judge whether its obligations have been met if it withdraws from the league.

At Harvard both students and faculty polled the highest vote for No. 4, with No. 1 running second. Smith and Mount Holyoke, both women's colleges, also cast the heaviest vote for No. 4, with No. 2 running second. In the four Maine colleges No. 4 led. Colby, Maine and Bowdoin gave second place to No. 3. Boston college cast a majority for No. 3, with No. 2 second. At Brown No. 6 led, with No. 5 second. Amherst and Tufts gave No. 4 second. Massachusetts Agricultural College polled the heaviest vote for No. 6, with No. 1 second.

NEW HAVEN, Conn., Jan. 13.—Compromise between the Lodge and democratic reservations was the peace treaty proposal which received the greatest number of votes from both the students and faculty of Yale university today. Summary of the vote: Students—For ratification, compromise, 520; for ratification with Lodge reservations, 215; for ratification without reservations (Wilson stand), 205; for rejection of treaty (Borah stand), 10. Faculty—Compromise, 156; Wilson, 45; Lodge, 18; Borah, 2.

SEATTLE, Jan. 13.—Students of the University of Washington, expressing their views on the peace treaty and the League of Nations, today voted by a large majority in favor of ratification of the treaty in some form or other. Only 275 ballots out of a total of 2,045 cast were opposed to ratification of the league and treaty in any form.

SPOKANE, Jan. 13.—Opposition to the league of nations and to the treaty of peace in any form was expressed by a plurality of students of Gonzaga university in a vote tabulated here today. Thirty-four op-

STUDENTS DUST OFFICERS

MASS VIOLATIONS OF RULES LAID TO LEADERS.

Robert Warrens, Junior Class President, and Henry Anderson, Yell Leader, Ousted.

OREGON AGRICULTURAL COLLEGE, Corvallis, Or., Jan. 13.—(Special.)—The double responsibility of student officers in accounting for their organizations when involved in violation of college regulations was confirmed in the action just announced by the student affairs committee barring from office two student leaders.

The men eliminated from their present offices and barred from holding any others for the rest of the college year are Robert Warrens of Portland, president of the junior class, and Henry Anderson of Aberdeen, Wash., student body yell leader. Both men were charged with having, as leaders of the student body and class respectively, been responsible for the violation of certain college regulations just prior to the Oregon Agricultural college-Oregon game.

Certain of the college rules were deemed by some students to be too strict and it was thought that infraction of them by whole classes or the entire student body would prevent punishment being dealt. This view was not taken by the committee, and the protection of numbers did not prove sufficient.

A student body meeting will be held tomorrow when the faculty committee on revision of rules expects to have suggestions for changes made by students.

WHEAT BODY ORGANIZED

Farmers of Washington to Co-operate in Marketing.

SPOKANE, Wash., Jan. 13.—Organization of the Washington Wheat Growers' association was perfected here tonight and plans were made for organization of similar associations in Oregon and Idaho, whereby farmers of the three states would co-operate in marketing their wheat by means of their own warehouses and elevators.

Under the plan adopted, the three state associations will have an interest in the marketing of wheat in order to conform to the co-operative laws of the states. The plan contemplates formation of a central association, which shall receive the wheat from the growers, giving warehouse receipts therefor. The receipts would be used as collateral to obtain funds with which to pay the growers in part for their crops, the remainder to be paid when the crop is finally sold by the association.

A series of farmers' mass meetings will be held in the three states February 23, when efforts will be made to have all wheat growers become members of the association and sign contracts for delivery of their crop. A campaign of publicity will be carried on at the mass meetings under the direction of J. F. Langner, a newspaperman of Portland.

WOMAN'S PARTY SCORED

Miss Helen Taft Says Women Ought to Work by Side of Men.

PHILADELPHIA, Jan. 13.—Miss Helen Taft, acting president of Bryn Mawr college, in an address today to the Pennsylvania League of Women Citizens, opposed the woman party idea. "Nothing could be more disastrous than for women voters to endeavor to organize a separate women's party," she said.

Miss Taft declared "women should stand independently for interests peculiar to their own and in which their interests are keener than men's. These interests would be such questions as child labor and protective legislation for women."

"When elected to office we should insist upon serving side by side with the men and not allow ourselves to be shoved off into separate committees merely for the purpose of blowing off steam," she said.

SUPPORT ASSURED PAPERS

County Agricultural Agents Interested in Press.

OREGON AGRICULTURAL COLLEGE, Corvallis, Jan. 14.—(Special.)—The recognition of the part the newspaper plays in developing community life and realizing the difficult position of the farmer in the country occupied at this time because of the newspaper shortage, the county agricultural agents unanimously adopted a resolution pledging the newspapers of the country their full support.

One of the ways in which they decided to help local papers is by advertising in the farm bureau publications and by refraining from carrying competitive advertising in the columns of the farm bureau publications. C. J. McIntosh, editor of the press bulletin, addressed the county agents on how to help the papers by interesting local dealers in the projects advocated by the farm bureau.

LANE TO BUY HOLSTEINS

Bank of Commerce of Eugene Has Plan to Aid Farmers.

EUGENE, Or., Jan. 13.—(Special.)—William Steuding of this city left last night for the northern part of the state and Washington to purchase two carloads of pure-bred Holstein cows for the Bank of Commerce of Eugene, the animals to be sold to farmers of Lane county under a plan inaugurated by the bank at its annual meeting a few days ago. The bank has appropriated \$50,000 to lend to farmers of the county at a low rate of interest, in order that they may buy pure-bred stock to improve the quality of their dairy herds.

CENSUS TAKEN AT JAIL

Inmates Not Asked if They Own Place in Which They Live.

That portion of Portland's population residing temporarily at the city jail were enumerated by Uncle Sam's census taker yesterday, in compliance with the law the proprietors of that "hotel" give the census man every co-operation in securing the names and other information desired of the boarders and residents there. The census man found 42 men and 12 women in the jail, and an additional 34 men working at Kelly Butte.

The census taker failed to ask any of the inmates if they owned the place in which they lived.

Prohibition Directors Named.

WASHINGTON, Jan. 13.—Appointment of E. C. Boon of Moscow and W. Truxon Boyce of Stanton as federal prohibition directors for the states of Idaho and Delaware, respectively, was announced today by Internal Revenue Commissioner Roger.



WOMAN ORGANIZER HERE

BRANCHES OF "GIRLS' FRIENDLY SOCIETY" TO BE FORMED.

Miss May Case Marsh of Detroit Is Visiting Portland and Working With Bishop Sumner.

For the purpose of organizing branch affiliations of the "Girls' Friendly Society in America," the national field secretary of the order, Miss May Case Marsh of Detroit, is in Portland on a brief visit.

She is working with Bishop Sumner and other churchmen and women in the city.

"Although the society is of the Episcopal church, we take girls of all denominations," said Miss Marsh. "There are 500,000 girls in the international organization in every English-speaking country. Girls over 12 belong, but we have classes for younger girls, who are called candidates until they are 12."

"The work is well known in eastern cities. It was established in 1875 in England by the archbishop of Canterbury and has for its aim protection and protective work for girls, the upholding of a high standard of Christian womanhood and an earthly high ideal of purity of life, faithfulness to parents, faithfulness in work and thrift."

"There are 900 branches in America. Girls who are members may be contacted with any religious body, or with none. It is practically a Christian sisterhood within whose limits every member looks for sympathy, kindness and information. Wires of the Oregon City Commercial club went on record as being opposed to the possession of land in this country, either through ownership or operation, by Japanese and Arthur G. Beattie, L. Henderson, Rev. Melville Wire and Dr. L. A. Morris were named as a committee to draft a resolution for transmission to the Oregon legislature.

It developed during the luncheon today that Japanese have secured farms along the lower Clackamas river, and have obtained possession of valuable property adjoining country places purchased within the last few years by wealthy residents of Portland.

POLL TAX LAW IS UPHELD

Alaska Cannery Justified in Taking Money, Court Finds.

SAN FRANCISCO, Jan. 13.—A decision upholding the poll tax law of the territory of Alaska following efforts of employees of the Alaska Packing company to collect the amount of the tax from the company was handed down by United States District Judge Rudkin of Spokane here today. Judge Rudkin is sitting in the district court here.

Under the law the company collected \$5 each from the men of its Alaska fishing fleet to meet the tax. The men resisted on the ground that they were not residents of Alaska, putting the payment by the company, one of their number, John Henderson, who brought suit against the company to recover. Judge Rudkin upheld the payment by the company, saying that the law applied to the men and was constitutional in every way.

MIDDLEMAN IS BLAMED

Vancouver Hears Advocate of Non-partisan League Plan.

VANCOUVER, Wash., Jan. 13.—(Special.)—The elimination of the middleman, as a step to reduce the high cost of living, was made tonight by J. L. Freeman at a meeting of the Central Labor council, held in the boiler-makers' hall. C. H. Moran presided.

W. P. Mills, representing the non-partisan league of North Dakota, described the league as a cure for economic ills. He said the league's movement was on foot to procure control of the Washington state government and the railroad men forming the "triple alliance." The voters representing the alliance, he said, numbered 219,000 at the last election. A collection was taken to support the movement. William Bouck, master of the Washington state grange, was a speaker.

ABERDEEN RACE GROWS

Two Contests for City Council Already in Sight.

ABERDEEN, Wash., Jan. 13.—(Special.)—Two contests for the city council already are in sight. O. T. Hermann, secretary of the Moore lodge, will contest the seat of L. L. Alexander, who also has filed for re-election.

J. A. Taft has filed as candidate in the 5th ward. This ward is represented by J. D. Walker, who is expected to be a candidate. T. H. Hill, city treasurer, has filed for re-election. Registration for the first week the books were open here totaled \$89. This is considered an exceptional figure for the first week of registration.
