

\$160,000 PLEDGED TO HOSPITAL FUND

Good Samaritan Campaign to
Be March 1 to 10.

AIMS AND WORK OUTLINED

Much Free Public Work Done Re-
quires Additional Support; Com-
mittee Discusses Plans.

New impetus was given the Good Samaritan hospital building fund campaign yesterday when further subscriptions were announced by Bishop Walter T. Sumner, bringing the total to \$160,000. Members of the campaign committee, meeting at noon yesterday at the Hotel Multnomah, signified their readiness to bring in further funds during the campaign, which will be conducted between March 1 and March 10.

Exposition of the hospital situation in Portland was furnished by Bishop Sumner, Mayor Baker, Dr. A. E. Mackay and Frank C. Jackson. The reason for appealing to the public in behalf of Good Samaritan hospital was explained by Bishop Sumner, who pointed out the altruistic and non-sectarian nature of the work performed by the institution.

"There is no reason that a church should have a hospital," he said. "If conducted along strictly business lines, a hospital having such public confidence behind it as the Good Samaritan would be a very safe money-making institution."

Much Work Is Free.
The \$300,000 addition proposed could be built by the hospital and paid for in a very few years without public assistance. The reason for making this a public drive is that Good Samaritan hospital handles a large amount of free work, and with such support as this, will be able to handle a great deal more.

The need of adequate hospital service in Portland was revealed by Mayor Baker on the basis of experiences undergone during the past two years. "Portland's hospital facilities at the present time are miserable," he said. "We are not only unable to provide hospital space in such emergencies as an influenza epidemic, but the space available under normal conditions is about 50 per cent short."

The value of Good Samaritan hospital from the physician's standpoint was discussed by Dr. Mackay, who cited several cases coming under his own observation where the services of the hospital had been entirely without charge.

\$300,000 Total Sought.
Another phase of the public service rendered by Good Samaritan was presented by Frank C. Jackson, manager of the present campaign, who showed how free service was provided in many cities by public subscription rather than by the hospitals themselves.

"New York City carried on a general hospital campaign during the months of November and December, 1919, in which a million dollars was asked to provide free service in the various city hospitals. If Good Samaritan is successful in the way we are asking, there will be no necessity for such an annual subscription."

The total amount for which Good Samaritan hospital is asking is \$300,000.

WASCO DONATES \$1000

Near East Relief Campaign Is
Meeting With Success.

THE DALLES, Or., Feb. 27.—(Special.)—When the near east relief campaign closes tomorrow night in Wasco county, the citizens of the community will have contributed more than \$1000 to the aid of suffering humanity, according to figures at local headquarters.

At this time, with a considerable portion of the county not reported and some of the city donations not in, the coffers of the relief organization are filled past the \$700 mark. Duff and several other heavy contributors are yet to be heard from. Mrs. Lulu D. Crandall is county chairman.

THE DALLES PLANT SHUT

Preparation of Dehydrated Products Is Suspended.

THE DALLES, Or., Feb. 27.—(Special.)—The Dalles Kings Products company has temporarily closed the dehydration plant, following a long and successful season. The plant will reopen from time to time to take care of seasonal products. In May the concern plans to open and handle spinach. The plant chiefly handles fruits, but probably will not run again at full capacity until next fall. Even then it is expected that certain fruit crops, principally peaches and apricots, will be light, owing to the hard and continuous spell of the past winter.

4-STORY FALL NOT FATAL

C. E. HOLMES, 22, SUSTAINS FEW MINOR INJURIES.

Window Washer Drops When Safety Strap Breaks; Crash Through Awning Saves Life.

Clifford E. Holmes, window washer, fell from the fourth story of Henry Jennings & Sons store, Fifth and Washington streets, to the sidewalk below on the Fifth street side yesterday afternoon at 1:45 o'clock and lives to tell the tale.

The man was not fatally injured by the fall is probably due to the fact that his fall was broken by the glass awning, one story from the sidewalk, through which he crashed. Kenneth D. Houser and Ray Clark of the Multnomah hotel were standing on the corner waiting for a street car at the time the man fell, and when he struck the glass and hung for a moment they seized a couple of repairs of springs which were standing

on the sidewalk in front of the store and placed them beneath the man.

The window washer, who lives at 2461 Russell street, was rushed to the St. Vincent's hospital where he was reported to be suffering from a fracture of the right wrist and cuts and bruises about the head, face and body. The hospital attendants reported that his injuries were not serious and that he would recover.

The man's fall was caused by the breaking of the tackle with which he held himself to the side of the building. He is 22 years old.
