Research to Be Extended. "Plans for the improvement of the school as at present outlined involve the continued extension of the present facilities for teaching and research work and the construction of special hospitals for the care and study in special fields of medical and surgical endeavor," he said.

He said there was especial need for a children's hospital and for a hospital for cripples. He referred to the county hospital on the present campus site on Marquam hill, which is now being built, and said that the advantages of having that institution adjoining the laboratory facilities of the medical school would soon be a matter of recognition.

Another feature, which he said was greatly needed by the school and which would be established, it was hoped, is an endowed foundation for medical and surgical research. The next building to be built on the campus he said, would be a university hospital and he hoped to get started on this work within the next two years.
