The claim that the daughter had an interest in this \$2000 was refuted by a deposition introduced yesterday from a banker in Greenwood, who told of paying the money over to Mrs. Laffier, as provided in the will of her husband.

GARDINER, Or., April 20.—(Special.)—Captain Gus Westergaard (Gardiner), retired navigator and former master of the steam trawler Ituna, wrecked off San Francisco on the night of March 13, expressed surprise when he learned of the report that he is to be summoned for inquiry.
