

NEW CHARGE FOND CASE

Police Refuse to Reveal Nature of Evidence.

MURDER THEORY IS KEPT

Participation of Woman Is Doubtful—No Significance Given Hairpin or Roses.

That some sensational developments in the investigation of the mysterious disappearance of Harry Dubinsky, for-hire driver who is believed to have been murdered, would be forthcoming within the next 24 hours was predicted last yesterday by Lieutenant of Inspectors Goltz.

He based his prediction on some evidence obtained yesterday, the nature of which he refused to disclose.

Eight men, arrested in various sections of the city, were taken to the police station yesterday for investigation in connection with Dubinsky's disappearance. All were freed after being questioned.

One of the suspects, who answered very closely the description of the man who was seen to abandon Dubinsky's automobile Sunday afternoon, even to the gray suit and straw hat, was released only after he proved he was in Seattle at the time.

All surrounding cities have been asked by the Portland authorities to aid in the search for the supposed murderer, and descriptions of the suspect have been telegraphed to all sections of the northwest.

Fake Phone Message Sent.
Someone telephoned the Dubinsky home at 122 Second street yesterday and announced that the body of the missing man had been found on the East Side.

"My name is Jamison," the man was said to have announced over the telephone. "I have just found the body of Harry Dubinsky on the East Side. What do you want done with it?"

Meyer Dubinsky, young brother of the missing man, who answered the telephone, did not know what reply to make. His mother was ill in the next room and the fact that the missing boy was believed to have been murdered had not been told her.

"Wait a minute," she replied. "All right, I'll call again," returned the voice and hung up.

The man failed to call again and when the police and the corner's office failed to get any news of the discovery of the body the family decided it was a hoax.

Father Offers Reward.
Abraham Dubinsky, father of the missing chauffeur, announced yesterday a reward of \$500 for information leading to the discovery of his son, dead or alive.

The lap robe of the automobile is still missing. The police say that the man's body may have been wrapped in it. Another theory is that it may have been hidden in the car, but the man's body may have been hidden to conceal a crime.

John Lowe, colored, 58 Gilman street, told the police yesterday that he saw a car he thought to be Dubinsky's going east on the Broadway bridge about 8 o'clock Sunday morning. He said that there were two men in the machine which he thought Dubinsky was driving and that they resembled Italian. He said that he thinks he saw the same two men riding west in a taxicab on Gilman street in the afternoon.

Lieutenant Goltz was inclined yesterday to doubt that a woman entered into the murder. He said that the discovery of a hairpin in the auto had little significance. The roses also, he said, might have been worn by a man.

STREETS TO BE KEPT CLEAR FOR SHRINERS

Auto Parking Down-Town to Be Prohibited.

GASOLINE SUPPLY SURE

Standard Oil Stations to Remove All Restrictions for Week. Parade Rules Issued.

GASOLINE AND CITY REGULATIONS FOR AUTOISTS SHRINE WEEK.

The ban will be taken off the sale of gasoline, so far as the Standard Oil company is concerned, Monday next. The gasoline status after Shrine week will depend upon how much is consumed. Some form of restriction is certain.

No autos may be parked at street intersections or on streets traversed by parades.

No automobiles at all will be allowed in congested district, bounded by Third and Tenth streets and Oak and Yamhill streets. Cars may be parked in other places if not in conflict with police regulations, except on Sixth street from the depot uptown.

Shrine cars will get first call on gasoline.

Auto parking and auto traffic will be prohibited absolutely in the downtown district bounded by Third, Tenth, Oak and Yamhill streets during the whole of next week.

The only exceptions will be for a very limited number of machines for Shrine committee chairman and delivery wagons for firms in the congested area.

Elsewhere on the west side, travel and parking will be permitted, unless contrary to police regulations. Sixth street, for instance, will be kept clear for arrivals.

Moving Grandstands Barred.
The family automobile may be kept home so far as being used as a perambulating grandstand for the parade. Parking at street intersections, long a favored pastime, is under the ban. Cars may be parked only along the curb and well away from the intersection.

The gasoline supply is chaotic. Each company has a different version of what the Standard Oil company portends next week.

As for the Standard Oil company, it will be temporarily removed next Monday morning. There will be no discrimination as to cars, for the regulation by company officials that many cars not officially designated will carry Shrine cars will be using gas.

Portland has saved up to about 200,000 gallons.

Situation of Others Vague.
A very vague outline was offered by the Associated Gas and Petroleum Association. Parker asserted that rigid conservation had been practiced and that, far as possible, Shrine cars and their regular "trucks" would be cared for.

The Union, through V. H. Kelly, manager, promised to make good requirements of all Shrine cars, bearing recognized Shrine insignia or gasoline orders from the automobile committee of the Shrine.

The Shell company, Manager Storey asserted, would be unable to tell what it could do for day or two until it checked up its gasoline on hand.

SHRINERS TO RECEIVE ROSES

Roses and other flowers will be received at the depot by a committee, where they will be made into appropriate bouquets and given to young women to distribute to the travelers.
