

RATIFICATION ACTS ATTACKED IN COURT

Suit Would Prevent Declaration of Suffrage Victory.

FRAUD BASIS OF ACTION

Legislatures Declared to Be Without Power Under State Constitutions to Act.

WASHINGTON, July 7.—Proceedings asking that Bainbridge Colby, secretary of state, be enjoined from issuing any proclamation declaring the suffrage amendment ratified were instituted in the District of Columbia supreme court today by Charles S. Fairchild of New York, president of the American Constitutional League.

Mr. Fairchild also seeks to prevent Attorney-General Palmer from enforcing the amendment. Justice Bailey issued an order summoning Secretary Colby and the attorney-general to show cause July 13 why the motion should not be granted.

Ratification Held Illegal.
The basis of the proceedings is the assertion that the ratification of the amendment by the West Virginia legislature was illegal because accomplished by fraud and that the proposed ratification by the Tennessee legislature also will be illegal on the ground that the legislature lacked authority under the state's constitution to act on the measure.

Only 35 states have ratified the amendment, and as ratification by one other is necessary, the attack on the amendment through the courts at this time came as a surprise in suffrage circles here. An attack on the validity of the action of the Tennessee legislature had been expected, but not until the legislature actually had acted.

Application for the restraining order was made by the national women's party in a petition which sought to indicate "the bitterness of the opposition to suffrage and the demonstration of the states which have signed their approval of the enfranchisement of the women of the nation."

Women's Confidence.
"We are convinced that, as in the Ohio referendum case," said the statement, "the validity of action of the various state legislatures in ratifying the suffrage amendment will finally be upheld by the courts. Anti-suffragist interests are evidently grasping at straws in their attempt through court proceedings to lengthen the suffragist struggle and force the expenditure of more money and time by suffragists for the success of their cause."

"The grounds cited for the injunction petition are matters already passed upon by the attorney-general and the legislatures of the states concerned, and in the case of Tennessee also by the United States supreme court of the United States. By filing certificates of ratification with the secretary of state the legislatures have completed, in the manner prescribed by the constitution, the process of ratification of the 19th amendment, and we believe the courts will uphold the validity of their action."

SUFFRAGE SESSION CALLED

North Carolina Governor to Ask Ratification; Fight Expected.

RALEIGH, N. C., July 7.—Governor Bickett of North Carolina today issued a call for a special session of the legislature for August 10, at which ratification of the suffrage amendment is to be considered. Governor Bickett did not mention suffrage in the call for the special session, but he has telegraphed President Wilson that he will recommend to the special session that the amendment be ratified.

A bitter fight is expected for by state officials. The North Carolina branch of the Rejection league has been very active in the month, and thousands of citizens have pledged their opposition to ratification. The national women's party already has workers on the ground.

COAL COMMISSION MEETS

WASHINGTON STATE OFFICERS TO PROBE WAGE AWARD.

Engineer Named by President to Confer With Commission on Labor Situation.

SEATTLE, Wash., July 7.—Washington's state coal commission, with James H. Alport of Burnsville, Pa., appointed by President Wilson as the fifth, or engineer, member, began its sessions today at the offices of the Washington Coal Operators' association here.

The commission is to investigate and report to a joint conference of miners and operators of Washington as to the effect of the application of national coal commission's award to the operations of this state. Washington was accepted from the national award made by the national commission last March.

Besides Mr. Alport, the commission consists of Robert H. Harlin, president of district No. 10, United Mine Workers of America; D. E. Buckingham, manager of the Roslyn Fuel company; and N. D. Moore, vice-president of the Pacific Coast Coal operators.
