MILK DISTRIBUTORS TO ABIDE BY COMMISSION FINDINGS.

Mayor Says Probing Body Will Be Appointed if Council Will Provide Funds.

Agreement of the Portland Milk Distributors to abide by the findings of a milk commission, assures the appointment of such a commission by Mayor Baker probably before the end of the present week.

Several days ago the Oregon Dairy-men's Co-operative league filed a letter agreeing to abide by the findings of a milk commission appointed by the mayor.

Mayor Baker announced yesterday that he would not appoint a commission to consider the milk problems until he was assured of sufficient financial aid from the city council to insure a thorough probe.

There is no use attempting to solve this question until it is done right," said Mayor Baker. "I must place some funds in the hands of the commission to provide the necessary facilities to learn all the facts. This will take the work of expert accountants and will cost the city money."

"But I am determined that this milk investigation does not revolve into a price-raising campaign. As I have often said, the city must have a reasonable profit over cost of production and the distributor is entitled to a fair profit. But it must be determined what costs of production actually are and what it costs to distribute milk in Portland. We cannot learn if the present prices are excessive."
