

\$8,000 SAVED On Automobile Liability By Travelers Service

A Pennsylvania newspaper man was killed when an automobile in which he was rid-ing as an "economy run" observer was in collision with a motor truck.

The sales corporation owning the automobile was sued for \$20,000. It carried TRAVELERS automobile liability policy FG1478196, with limits of \$5000 for one person killed or injured and \$10,000 for more than one in a single accident.


