

WOMAN PROHIBITION DIRECTOR REMOVED

Deposed San Francisco District Agent Charges Plot.

POLITICS ARE BLAMED

Mrs. Glad K. Warburton Declares Every Obstacle Has Been Thrown in Her Path.

SAN FRANCISCO, Oct. 8.—(Special.)—In the midst of charges and counter charges and in the face of whisperings and insinuations concerning the easy manner in which bootleggers have been operating in San Francisco for the last month, Mrs. Glad K. Warburton, prohibition supervisor and director today by orders from Washington, Prohibition Supervisor John L. Considine, was temporarily named prohibition director.

"I am shocked and surprised to find that a woman should be appointed to this office," she said. "I am glad to do my duty in the face of all kinds of whisperings and insinuations. I am the victim of a political plot. But Mr. Considine's appointment is not the result of politics. He is appointed because he is the only one in a position of authority in the prohibition department who has not been actively against me since I assumed office. His appointment is a matter of expediency and not of politics. I have received no co-operation, but, on the other hand, every obstacle has been placed in my way to make my work impossible."

Considine said that his appointment to the office temporarily was a big surprise to him. "One of Considine's first acts after taking the reins from Mrs. Warburton was to confer with Collector of Internal Revenue Wardell relative to the release of a large number of legitimate permits, which have been held up by Wardell, said Considine, 'have been held up because of the suspicion that liquor was being withdrawn for illegal use. Many legitimate permits were held up for the purpose of liquor for non-beverage purposes have been so held up and should be released immediately."

Records Declared in Bad Shape. Prior to leaving her office, Mrs. Warburton declared that the records of her office were in bad shape because of inefficient appropriations and clerical help.

There are many permits for the removal of liquor, she said, "that do not appear on our records at all. There has been a large number of illegitimate permits issued by the collector. I am informed, has been withdrawn from the warehouses without permits being issued."

Whether the appointment of Considine and the removal of Mrs. Warburton will help matters is not known. Edward Kenny, chief deputy prohibition director, was mentioned as a possible successor of Mrs. Warburton. It was also reported that Colonel John L. Flynn, chief deputy under Collector Wardell, was being groomed for the place.

MANNIX ARREST ORDERED California Attorney and Others Held Dry Law Violators.

SAN FRANCISCO, Oct. 8.—Warrants for the arrest of Francis J. Mannix, prominent attorney, and five other persons on a charge of conspiring to violate the federal prohibition enforcement law were issued by United States Commissioner Francis Krull today after having been sworn to by the United States district attorney.

TOWN COURT IS MISSING First Prisoner in Three Years Released, Magistrate Lacking.

LAJARA, Colo., Oct. 8.—The first arrest in this town in three years was made today. A man, after being here but a short time, was accused of stealing an overcoat from a garage. The town marshal, whose sole duties have been to care for the town streets and parks, placed the man in jail.

LONDON, Oct. 8.—(By the Associated Press.)—Emma Goldman and Alexander Berkman both want to return to the United States, according to Boris Sokoloff, former professor of biology, who has been invited to return well-known as a socialist writer, who has just arrived in England. BANK ROBBED OF \$3800

TWO MEN LOOT VAULT AT PLUMMER, IDAHO.

Woman Cashier and Depositor Are Locked in Safe—Escape Is Made in Auto.

SPokane, Wash., Oct. 8.—(Special.)—Two armed men robbed the State bank at Plummer, Idaho, just before 3 P. M. today, according to reports received here, and locked Miss Myrtle Wynne, cashier, and Miss Eva Usury, a hardware store employe, who had entered the bank to make deposit, in the vault. Then they looted the bank of \$3800 in currency, all the available funds. The robbers were believed to have escaped in the direction of Spokane in an automobile.

WASHINGTON, Oct. 8.—The bolshevik submarines, supposed to be bent on intercepting munition shipments to Poland, have been reported off the Easthonian coast, presumably en route to the Baltic, according to an announcement tonight by the state department. The information came to the navy department, the announcement said. "To Vice-Admiral Huse, commanding the American naval forces in the Baltic, that the United States is not at war with Russia and that the submarines in question are not to be treated as hostile vessels."

CHICAGO, Oct. 8, (Special.)—Dates of Senator Harding's next tour were issued here tonight by national republican headquarters. The tour will last five days, the senator reaching home just in time to speak at the America first celebration in Marion, Ind., on October 15, at which time between 60,000 and 70,000 are expected to attend.

OFFENDING BREWERS WARNED. WASHINGTON, Oct. 8.—Breweries which fail to confine the alcoholic content to their products within the half per cent limit of the Volstead prohibition law hereafter will be punished by revocation of their license to do business, Commissioner of Internal Revenue Williams ruled tonight. It has been found, the commissioner's statement said, that the imposition of double taxes and penalties in the nature of fines which the law also allows, is not sufficient to prevent the production of cereal beverages carrying an illegal "kick."
