

CANCEL WAR LOANS, IS REQUEST BY ALLY

Houston, However, Refuses
to Name Nation.

SENATE HAS WRANGLE

Judiciary Committee Considers
Proposal of Senator Reed to Pro-
hibit More Money Advances.

WASHINGTON, Feb. 7.—Declaration by Secretary Houston that an allied government had proposed to the United States cancellation of its war obligations to this country, a wrangle over status of war loans to Russia and Russian embassy financing, and a decision to divide the investigation as to foreign loans with the foreign relations committee, marked today's session of the senate judiciary committee. The proposal of Senator Reed, democrat of Missouri, to prohibit additional foreign loans was under consideration.

Secretary Houston said that "one government" had proposed cancellation by the United States of loans. He preferred "not to say" what government.

Loans Policy Discussed.
Most of the session was taken up with discussion of Mr. Houston's assertion that he did not propose to make further loans to foreign governments.

Senator Reed said Secretary Houston's assurance as to his plans would not bind his successor, which he said his measure sought.

The Russian loan came up in testimony of N. Kelley, assistant treasury secretary, in charge of foreign loans, who testified that before the fall of the Kerensky government Russia had received \$187,000,000 in war credits. No additional payments, he said, were made until 1920, when Russian embassy officials were allowed to draw \$200,000 with the understanding that it would be replaced.

Executive Session Held.
Objection of senators caused an executive session at which it was decided to leave international aspects of loan matters to the foreign relations committee.

PASTORS INCENSED BY MOVIE DEFENSE

Insult Charged; Judge Lindsey, Denver, Apologizes.

MEETING IS BROKEN UP

Heinous Offenses Committed on
Floor of Churches, Ministers
Told in Reply to Question.

DENVER, Feb. 7.—Charges that Judge B. B. Lindsey of the juvenile court had insulted the city's clergy in a defense of the Sunday closing law, and a statement from one of the ministers that the judge ought to go to jail on a recent contempt charge, broke up a meeting of the Denver Ministerial alliance and resulted in a public apology tonight by Judge Lindsey.

The meeting was called for the discussion of movie censorship and repeal of the Sunday closing law for theaters and other amusements. Several theatrical managers had preceded Judge Lindsey. After the judge concluded he proposed to answer questions.

Temperance Is Impaired.
"Judge, would you say that if a child passed two hours in a picture show on Sunday that he would not be tempted to crime before entering the show or after it was over?" a clergyman asked.

"I have been on the bench for 21 years—21 years, yes, sir," replied Judge Lindsey. "I am here today to tell you ministers that never have I had half a dozen boys come before me for delinquency caused directly or indirectly from motion pictures. I have twice that many cases of children who have been attending church or Sunday school just before they committed their offenses. I have known of the most heinous form of offenses to be committed right on the church floor."

Insult, Says Chairman.
Chairman L. C. Hills sprang to his feet. "We have given you the courtesy of the floor, Judge Lindsey, and you have insulted us. You were not invited here to insult the ministry," he said.

Rev. Robert T. Caldwell, pastor of Montview Presbyterian church, rose. "There is a newspaper reporter presently," he said, "I want to go on record as saying that Philip Vancise (district attorney) was absolutely right when he said Judge Lindsey ought to go to jail."

Someone moved to adjourn and the meeting ended.

His statement tonight Judge Lindsey said that it was never "my intention to say there was more crime found in the churches than in the movies." He admitted the statement regarding Sunday movies.

Lindsey Explains Statement.
"I was then asked a question," the statement continues. "I was limited in both my discussion and answer, since the watch was being kept on me. What I tried to say was that in my 21 years of experience in the juvenile court I did not recall a half dozen cases of crime among children that could be directly traced to the influence of a picture at a movie."

He said that he had known of cases right in the church of Sunday school where certain evil happened, for example, that boys had robbed the collection box. But I did not mean to say a thing that I never dreamed or intended to say, I said that there is more crime found in the church than in the movies.

"If the effect of my remarks were to justify such a conclusion, it was not intended, and I apologize to the churchmen if such has been the effect."

RECRUITING IS STOPPED
WAR SECRETARY DOES NOT
WAIT OFFICIAL NOTICE.

Beginning Today No Recruits Will
Be Accepted Except Those
Having Already Served.

WASHINGTON, D. C., Feb. 7.—Complete cessation of army recruiting was ordered tonight by Secretary Baker in accordance with the direction of congress as embodied in a joint resolution adopted over President Wilson's veto.

The house resolution directed that army enlistments be stopped until the army was reduced to 175,000 men and became a law late today. The senate placed the resolution on the statute books by voting to override the veto. The house voted overwhelmingly to overturn the veto late Saturday.

The senate vote was 87 to 1. Senator Kirby, democrat, Arkansas, alone voted to sustain the veto.

The war secretary acted to stop all recruiting shortly after congress had completed adoption of the resolution which directs cessation of all recruiting until the army is reduced to 175,000 men.

Notification of the action commenced through a vote in the senate and, beginning tomorrow, no recruits will be accepted except those who have served one or more enlistment periods.

Army officers have estimated that it will require nine months, or until November 1, to reduce the army from the more than 213,000 enlisted men strength to the 175,000 figure. The army appropriation bill, up for passage tomorrow in the house, however, provides maintenance for only 150,000 men after July 1, and should it be enacted in that form, the reduction process will have to be carried beyond November 1. Recruiting has averaged about 100,000 men a day.

The senate voted 47 to 1 late today to override the president's veto of the reduction resolution, Senator Kirby, democrat, Arkansas, alone recorded as sustaining the president.

FERTILIZER KILLS WEEDS
Dream of Gardeners World Over
Realized by Discovery.

KINGSTON, R. I., Feb. 7.—Discovery of the long-sought fertilizer that will grow grass and kill weeds, was announced by the experiment station of Rhode Island state college as the result of 20 years' research.

The realization of the dream of gardeners the world over—a weedless lawn—is possible without trouble or expense, according to the official college statement, merely by the use of ammonium sulphate instead of nitrate of soda in annual application of fertilizer.

MAN HELD IN FIRE DEATH

CHILDREN OF WOMAN TELL OF
ALLEGED ATTACK.

Help Comes When House Is Ablaze;
Two Shots Heard; Assaultant
Suspect Found Intoxicated.

GROVELAND, Cal., Feb. 7.—S. J. Billett is in jail at Sonoma pending further investigation of the death of Mrs. Annie Blanche Gann, whose charred body was found in the ashes of her home, destroyed early Saturday morning.

The house was on a ranch four miles from Groveland. During the absence of the woman's husband, who is in a hospital, Billett, an employee, entered the house in an intoxicated condition, according to testimony of Mrs. Gann's children at the inquest today. They said he attempted to force his attentions on their mother, who procured a revolver and threatened to shoot unless he desisted.

In the early morning hours Mrs. Gann sent them to a neighbors' house for help. When L. E. Wiley arrived the house was ablaze. Wiley and his father-in-law saw nobody, but suddenly they heard two shots fired. They said they met Billett, who appeared to be intoxicated.
