

TARIFF DIFFERENCES ARE SNATCHED OUT

Measure Sent Back to House
for Final Action.

IMPOST ON HIDES DENIED

Flat Rate of Two Cents on Sugar
Amounts to Doubling of Import
Duties on Sugars.

WASHINGTON, D. C., Feb. 24.—Differences in the emergency tariff bill were smoothed out today by conference committees of congress and the battle-scarred measure was sent back to the house for final action.

Although the bill has a parliamentary right to consideration tomorrow, it was unlikely that it would be called up before Saturday. Supporters may compel earlier consideration, however.

As the bill now stands it carries a flat rate of 2 cents a pound tariff on sugar, in substitution for the present tariff. The proposed tariff amounts to a doubling of the import duties on sugars of all grades, making Cuban sugar pay a duty of \$1.60 each 100 pounds and a similar rate on sugar products.

The house conference stood pat on a refusal to permit a tariff on hides and leather products. The senate rate of 4 cents a pound on cherries was cut to 3 cents.

Arguments on a duty on rice compelled a rewriting of that item with a flat rate of 1 cent a pound on all except cleaned rice and rice used for the manufacture of canned foods.

There was speculation tonight whether the house would concur in the agreement of its conference committee on the sugar duty.

The rates changed in the conference are: Wheat, 35 cents a bushel; rice (cleaned), 2 cents a pound, 1 cent a pound on other; olive oil (in bulk), 40 cents a gallon; less than five gallons, 50 cents a gallon; cotton (staple of one and one-eighth inches or longer), 3 cents a pound; sugar, 2 cents a pound; butter and substitutes, 6 cents a pound; wrapper and filler tobacco, the product of two or more countries, when mixed, 3 cents a pound if unstemmed and \$3 a pound if stemmed; filler tobacco, unstemmed, 25 cents a pound, stemmed, 60 cents a pound; cherries, 3 cents a pound; olives, in solution, 25 cents a gallon, not in solution 3 cents a pound.

HOUSE UPHOLDS SMOKER

Plan to Bar Use of Weed in Government Buildings Fails.

WASHINGTON, D. C., Feb. 24.—The house, composed largely of smoking men, stood up tonight for the man who smokes peacefully while working at a government desk.

There was a shouting of "Noes!" when a senate amendment to the sundry civil bill, directing heads of departments to issue anti-smoking orders in government buildings, came up for its first test.

Less than a score of members supported it. The law was designed as a protection against fire.

President Wilson was asked by the conference to veto the Yellow-Towson bill as an "unjustified and unjustified concession to the railroad owners, who have shown a wanton disregard for the law and lawful processes."

The declaration of principles adopted yesterday was declared by labor leaders to be one of the most important and most militant instruments ever approved by representatives of organized labor.

Meetings Will Continue.
Whether the principle of boycotting "a flat refusal on the part of labor to recognize or abide by the terms of injunctions" will be carried out generally by labor unionists, it was explained, will depend on the attitude of each individual national and international union. The principle is not a new one with the federation, however, as it was first adopted at the 1916 convention.

The proposal made yesterday that congress be asked to repeal the Volstead act was not reported on today by the executive council. The council, it was stated, will take whatever steps it deems advisable.

The executive council will resume its meetings tomorrow and will probably continue in session for another week.

HARDING PROCEEDS WARILY

President-Elect Wants to Be Free to Make Last-Minute Changes.

ST. AUGUSTINE, Fla., Feb. 24.—(By the Associated Press.)—President-elect Harding emphasized today that he was proceeding warily about definite commitments as to his cabinet appointments and would keep himself free until the last minute to make changes.

He announced that eight of the ten selections still were susceptible of cancellation, although he said that his declaration, however, to suggest changes as probable.

Reorganization of the executive departments, however, is one of the first steps planned by the new administration. So far as formulated, Mr. Harding's plan contemplates a reorganization commission, with one outside the cabinet in direct charge and responsible to the president and congress.
