LET ENGLAND AND ERIN ALONE, IS PLEA

Bishop Leonard Addresses Progressive Business Men.

FRIENDSHIP IS URGED

Appeal Made to Prevent Break Between American and British Over Question.

An appeal that the people of the United States permit no break between this country and England on account of the Irish question was made by Bishop Adna W. Leonard, of San Francisco, in an address delivered at the luncheon of the Progressive Business Men's club at the Benson hotel yesterday noon.

"Let us," he said, "regard the question from the standpoint of Americanism as one of local importance to be settled between England and Ireland themselves and let us not allow any break between the two great peoples who have the destinies of the world in their hands."

Bishop Leonard urged the importance of England and America getting close together for the protection of the liberty of the world in what he termed this hour of crisis.

The speaker declared that President Harding and Secretary Hughes are right in declaring to the allies that Germany must pay for the ruin which was wrought as a result of the war.

He also referred to the immigration of the red element to this country and declared that those who came with ideas that the ideals of this country could be overturned by force should be sent back whence they came and only those admitted who were ready to abide by the traditions of this democracy. He further asserted the employers and employees of the country are getting along together on the big problems which have made for unrest in the past and declared this to be important in the working out of the destiny of the nation.

DRUG RINGSTERS CONFESS

SENTENCES METED OUT FOR LOOTING ARMY HOSPITAL.

Two Women and Man Admit Their Guilt—Third Man Denies Complicity, Fourth Fugitive.

Three members of the narcotic ring that looted the Vancouver barracks hospital of morphine, heroin and opium worth a fortune at retail prices pleaded guilty yesterday before Federal Judge Bean and were sentenced. A third alleged member was arraigned and entered a plea of not guilty.

Estelle Clark pleaded guilty to having had stolen government property in her possession and was sentenced to 30 days in the county jail. She received the stolen narcotics and kept them for a time for the other members of the ring.

Joseph J. Boyle, a soldier, and Coral R. Everett pleaded guilty to the same charge and were sentenced to serve six months in jail.

Phil Shipman, accused of complicity, denied any part and was held on \$500 bail. He will be tried later, although the date has not been set.

George H. Nelson, another alleged member of the ring, is still a fugitive.

Howard Brown, who is held by the army authorities at Vancouver, and Boyle will both face court-martial by the army.
