

ULSTERITES READY FOR PEACE MEETING

Irish Widow Thought to Have Won Over Lloyd George.

SINN FEIN DEBATES ISSUE

Proposed Conference of Delegates for North and South of Ireland Occupies Officials.

BELFAST, June 28.—(By the Associated Press.)—Sir James Craig, the Ulster premier, announced today that the Ulster cabinet had accepted the invitation of Mr. Lloyd George, the prime minister, for the proposed conference between representatives of Northern and Southern Ireland and the British cabinet.

Sir James will be accompanied by all the ministers of the Ulster cabinet, with the exception of Sir Dawson Bates, home secretary.

Eamon de Valera, the republican leader, is in Dublin, still consulting with his colleagues regarding the invitation. It is understood here that he has paid a visit to Mountjoy prison to see Arthur Griffith, founder of the Sinn Fein, who is under confinement there.

LONDON, June 28.—Mrs. F. Sheehy Skeffington, widow of an Irish leader, who was executed following the Easter Monday riots in 1916, has played a prominent part in bringing about recent developments relative to peace in Ireland. It was said in statements printed in the Graphic and Sketch today.

Mrs. Skeffington is now in London, and the two newspapers say she is an official ambassador of Eamon de Valera and has acted as an intermediary between him and Prime Minister Lloyd George.

Interviewed by the Sketch, which asked whether a definite proposal from the British government regarding the necessary preliminary to the proposed meeting of De Valera and Sir James Craig, premier of Ulster, Mrs. Skeffington said:

"No, I think there will have to be a meeting first. Probably it will be necessary to ask the government to arrange for such a meeting. Most of the cabinet of the Irish republic are in jail, and arrangements must be made for them to attend the meeting."

DE VALERA DELAYS ANSWER

Republican Leader Writes Letters to Opposition Heads.

DUBLIN, June 28.—Arrangements for the opening of the southern parliament of Ireland had been completed this morning, the council room of the department of agriculture in this city being selected as the meeting place of the new parliament.

Mr. de Valera has written to Sir James Craig, the Ulster premier, Earl Middleton, who in 1920, advocated one parliament for southern Ireland, with the six Ulster counties under the imperial parliament, Sir Maurice Dockrell, member of parliament for the Rathmines division of Dublin county, who was returned as a unionist supporter of the coalition government, except as to its Irish policy of home rule; Sir Robert Henry Woods, member of parliament for Dublin university and ex-president of the Royal College of Surgeons in Ireland; and Andrew Jameson, asking them to meet him at the mansion house, Dublin, on Monday for a conference. He wished, he said, to learn from them at first hand the views of the people they represent.

SOUTHERN PARLIAMENT OPEN

Few Attend Session and It Ends in 15 Minutes.

DUBLIN, June 28.—(By the Associated Press.)—The southern Irish parliament established by the home rule act opened here this afternoon. Comparatively few members were present and the proceedings lasted only 15 minutes.

Probably have to take less than par and this will displace the counties. Bids for state highway bonds yesterday were the lowest since the commission. Considering the foregoing factors, the highway commission simply may decline to award more road work until fall, by which time many jobs now under way will be completed and contractors may be willing to shelve down their figures in order to keep going. Bond Dealers to Be Made

Offers for \$1,500,000 of state highway bonds yesterday were under advisement and the commission will announce a decision this afternoon. Under the new law, the bidders for the interest charge. its kind, there was very little bidding on the proposed bridge across the Willamette river at Oregon City. A. Guthrie & Co. bidding \$213,662.50, was low bidder. While the bid was considered satisfactory, it was referred to the bridge engineer for some minor adjustments, in making this explanation to the crowd of contractors in the room. R. Booth, chairman, took occasion to compliment the Clackamas county court for the fine spirit displayed in the negotiations and publicly thanked Judge Cross and his associates.

Negotiations between the commission and the county have covered a long period and at the first of the year the situation was about as bad as it could be, but it has all been worked out to the satisfaction of all parties concerned. The proposed new structure will replace the present suspension bridge, which was erected some 30 years ago at a cost of \$20,000. The present bridge was not built to withstand the demands of modern traffic.

New Projects Limited. New projects undertaken by the commission yesterday were limited. The commission agreed to advertise for paving from West Dayton to Lafayette, in Yamhill county, to close a gap. The fills in this four-mile strip will not be paved, but permitted to settle a couple of years longer. A proposal to do work from Amity to McMinnville failed to find a response from the commission.

In Deschutes county the commission agreed to advertise for graveling the 10-mile stretch between Bend and Horse Ridge, on the Central Oregon highway, and to order a survey from Horse Ridge on this highway to the Harney county line. Also the commission ordered the section on the Dalles-California highway from Allen's ranch south to the county line.

County Judge Sawyer proposed that the road from Sisters to Bend be known as the McKenzie-Bend highway, to distinguish it from the McKenzie-Dechoc highway, which also strikes out from Sisters. The highway commission adopted the name. Also it accepted as a state road the Warren construction company at \$4369.55.

Little Grading Awarded. Only 3.79 miles of grading was awarded yesterday and but 1255 lineal feet of hard-surface. The grading included Ochs creek, to Russell creek, in Curry county, being a section of the Roosevelt highway. Bates & Rogers received the job at \$26,700. The hard-surface job is the Newberg viaduct and Chehalis creek trestle, on the West Side highway in Yamhill county. Award was made to the Warren construction company at \$4369.55.

CHARLES BONAPARTE DIES

RELATIVE OF NAPOLEON, 70, Succumbs in Baltimore.

Unique Political Figure Attorney General During Roosevelt Reign in White House.

BALTIMORE, Md., June 28.—Charles J. Bonaparte, attorney-general during the Roosevelt administration, died at his country home near here today.

Mr. Bonaparte had been in poor health for about a year. He was 70 years old.

He was the son of the late Jerome Napoleon Bonaparte and the late Susan May William Bonaparte. His paternal grandfather was Jerome, King of Westphalia, whose romantic wedding to the beautiful Betsy Patterson of this city has become popular legend. The great Napoleon was the granduncle of the deceased.

Entering the cabinet of President Roosevelt in 1905 as secretary of the navy, Mr. Bonaparte was transferred to the attorney-generalship in 1907, continuing in that position until the end of the Roosevelt administration.

Mr. Bonaparte first came into national prominence when he helped organize the National Civil Service Reform league and took a great part in securing the adoption of the merit system in the federal service. He also was active in the organization of the National Municipal league and was its president for a time.

WOMEN AFTER OFFICES

Petiteau Government Is Likely in Erstwhile Badlands.

The city recently purchased a combination fire truck and with a partially paid department, is entitled to a material reduction, Chief Loomis declares.

TIME-AND-HALF PAY BY RAILWAYS ENDED

Labor Board Decides on Working Rules Also.

OLD METHOD TO STAND

Conditions Laid Down Under National Agreements Continued by Temporary Decision.

CHICAGO, June 28.—Railway employees will be paid for overtime in excess of eight hours daily at the pro-rata rate instead of time and one-half under a temporary decision of the United States railroad labor board today.

This order, effective on July 1, applies to all employees except those who have reached individual rate agreements with the roads or those mostly in the south, who were being paid time and one-half after eight hours before federal control of the roads.

The ruling is operative pending settlement of disputes now before the board, and it is later decided that the penalty rate for overtime on lifted roads will be directed to pay back to their employees the amount to be deducted after July 1 under the present decision.

Today's decision also provided for the continuation of the rules established by or under the authority of the United States railroad administration until such time as such rules are considered and decided upon by the board, with the further exception of rules agreed upon at individual conferences which are to become effective on July 1.

PAPER LABOR TO ARBITRATE

America and no disposition thereof made except as shall have been heretofore or specifically hereafter shall be provided by law until such time as the imperial German government and the imperial royal Austro-Hungarian government or their successor or successors, shall have respectively made suitable provision for the satisfaction of all claims against said governments respectively, of all persons whose domicile, who owe permanent allegiance to the United States of America and who have suffered through the acts of the imperial German government or its agents, since July 31, 1914, loss, damage or injury to their persons or property, directly or indirectly whether through the ownership of shares of stock in German, Austro-Hungarian, American or other corporations, or in consequence of hostilities or of any operations of war, or otherwise and shall have granted to persons owing permanent allegiance to the United States of America most favored national treatment whether the same be national or otherwise, in matters affecting residence, business, profession, trade, navigation, commerce and industrial property rights, and until the imperial German government and the imperial royal Austro-Hungarian government or their successor or successors, shall have respectively confirmed to the United States of America all fines, forfeitures, penalties and seizures imposed or made by the United States of America during the war, whether in respect to the property of the imperial German government or German nationals or the imperial and royal Austro-Hungarian government or Austro-Hungarian nationals, and shall have waived any and all pecuniary claims against the United States of America.

Criticism Action Stated. Sec. 6. 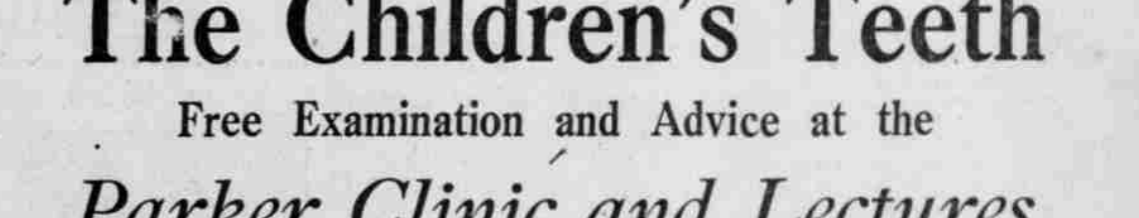
