ENACTMENT OF SOLDIER BONUS BILL NOW WOULD IMPERIL NATION, SAYS PRESIDENT

Executive, Mindful of Already Overburdened Treasury, Would Defer, Not Repudiate, Obligation to Defenders, and World Never Faced Before.

WASHINGTON, D. C., July 12.—Following is the full text of President Harding's address to the senate:

Mr. President and Gentlemen of the Senate.—There has come to my attention pending unfinished business before the senate, and it is an imperative duty to convey to the probable effect of the passage at this time of the proposed act providing for adjusted compensation to our service men in the world war.

If this measure could be made effective at the present time without hindrance to the nation's finances and adjustment of our affairs it would represent an entirely different question than that which is before you in a personal as well as a public manner.

In such reference as has been made to general compensation there has been reservation as to the earliest consistent time for such action if it is taken even without such reservation, however, a modified view would wholly justify it at the present moment because the enactment of compensation bill in the midst of the struggle for readjustment and restoration would hinder every effort and greatly impair the financial stability of our country.

World Faces New Problems. I am addressing the senate directly because it is immediately before you, as your unfinished business, but the executive branch of the government owes it to both houses and to the country frankly to state the reasons for the delay called upon to meet and the added peril this measure would bring.

Our land has its share of the financial chaos and the industrial depression of the world. A little more than the growth of indebtedness or the limits of expenditure during the war have we sought not stop to count the cost.

Children Flay Father. HENRY SCHWEITZER ACCUSED OF MALTREATING WIFE. Litigation in Family Develops Bitter Rejoinder to Petition Filed by Parent.

Far from being the ungrateful children they are painted in the recent complaint of Henry Schweitzer, Sigmond, Joseph, Mary and Anton Schweitzer answer in papers filed in the circuit court yesterday that they have contributed regularly to the support of their father and mother in sums ranging from \$20 to \$40 a month each, and that their father makes his wife in more than manner that he is "either the meanest man who ever lived, or not in command of his mental faculties."

Schweitzer asked the court to enjoin his children from bothering him, to compel them to leave his home at 1215 S. Taylor street, and to make them desist from attempts to have his wife divorced from him.

In reply, the children and L. Doern, son-in-law, allege that the father is a man of violent temper, a heavy drinker, and that he has driven the house of them because they object to his abuse and beating of his wife. The defendants state they have supported their mother and father and minor children almost entirely for eight years, saying that their father never makes more than \$40 a month, while their contribution monthly is more than \$90.

The only child of the father, a son, is a deaf and dumb idiot. The father is said to have been violent and abusive toward his wife, they say, when they "told him that if he thought he could beat up their mother like he could when they were little he was mistaken."

Schwitzer had said that the children had installed machinery in the house which kept him awake at night and that they were molesting the children by their electric washing machine. He said that his mother had to lighten her work and a last child, which a crippled brother Sigmond is learning a trade.
