

OD DEALS IN WAY OF PEACE IN IRELAND

Contending Parties Seem to Cling to Aspirations.

TWO FACTORS ARE VITAL

Will Valera Consent to Home Rule
Amendment and Will Craig Be
Met Are Big Questions.

LONDON, July 22.—(By the Associated Press.)—The future course of the Irish negotiations seems to turn on two important points—first, whether another meeting between Sir James Craig, the Ulster premier, and Eamon de Valera, leader of the Sinn Féin, will be held in Ireland, and second, whether Mr. de Valera can be induced to consent to a solution of the situation through an amendment of the existing home rule act, presuming that such a solution can be worked out.

The second question appears to hinge on a desire on the part of the contending parties to hold to their ideals. Mr. Lloyd George, as a concession to the unionist section of the coalition, wishes to save the home rule act and Mr. de Valera, on the other hand, would prefer to destroy the "partition act."

Mr. de Valera is expected to pass the week end in Dublin, in informal talks with his colleagues and probably will summon a meeting of the Dail Eireann to examine the government's offer. The convening of the Dail Eireann, it was understood here, would be an indication that the offer was regarded as the possible basis for further negotiations.

The supposition was that if the draft offer is not approved by Arthur Griffith and other leaders, the Dail Eireann will hardly be convened, while if the leaders accept the draft the sanction of the Dail Eireann is certain to follow.

Ten-Day Wait Expected.
Among the Sinn Féin leaders in London no definite development in the negotiations seemed to be expected for ten days or more. The terms of the government's proposal apparently will not be announced without a preliminary agreement between Lloyd and de Valera.

According to apparently inspired statements, however, they are of a somewhat tentative character, intended to indicate the lines on which the government contemplates a solution of the situation possible, provided both Ulster and the Sinn Féin are able to agree to a permanent government to amend the act.

It was predicted in some quarters that publication of the governmental proposal would reveal that the prime minister has offered each section of Ireland dominion home rule, with reservations as to England's naval and military position.

The Irish leader took with him a document, it was expected, from David Lloyd George, setting forth definite proposals by the British government as a settlement of the Irish problem.

These proposals will be submitted to members of the Dail Eireann as well as other prominent Irish republicans and Mr. de Valera will hear from time to time how the discussions are proceeding. CAPTAIN AFTER ENEMIES

MURDER CHARGE TO BE RUN
DOWN, SAYS ROSENBLUTH.

Congressional Investigation to Be
Asked and Punishment of
Guilty Ones Demanded.

NEW YORK, July 22.—Captain Robert Rosenbluth will seek a congressional investigation of the means by which charges, following the killing of Major Alexander P. Cronkite, were brought against him, he announced yesterday after his release from jail by Judge Shepard in federal court.

Bail in the amount of \$25,000 was refunded to Felix Warburg, Colonel Herbert Lehman and Walter Frank, his bondsmen. The order for his release was issued last Saturday by Attorney-General Daugherty after an investigation of the case.

"Only when I have drawn my last breath will I cease to fight, not only for personal vindication but for the re-establishment of justice so sadly ravaged in my case," said Captain Rosenbluth after his release.

"I wish to express my thanks to the press for its fairness. I hope the papers will help me obtain a congressional inquiry so that irresponsible and secret statements of guilty persons will be forced into the open under oath."

John J. Goldstein, counsel for Captain Rosenbluth, said:

"I regret that the department of justice seemed to be expected for ten days or more. The terms of the government's proposal apparently will not be announced without a preliminary agreement between Lloyd and de Valera."

According to apparently inspired statements, however, they are of a somewhat tentative character, intended to indicate the lines on which the government contemplates a solution of the situation possible, provided both Ulster and the Sinn Féin are able to agree to a permanent government to amend the act.
