If the application is finally approved by the corporation, the money will at once be made available to the borrower.

The circular issued today by the war finance corporation for the information of bankers applying for adcances and those desiring to sell to the corporation notes secured by agricultural products, including livestock

"The war finance corporation is authorized to make an advance to any bank, banker or trust company which may have made advances for agricultural purposes; that is, for any purpose connected with the growing, harvesting, preparation for market, and marketing of agricultural products, or the breeding, raising, fattening and marketing of livestock; or which draft, bill of exchange or other negotiable instrument issued for an agricultural purpose. The term 'bank, banker or trust company' includes any reputable and responsible financing institution incorporated under the laws of any state or of the United States, with resources adequate to the undertaking contemplated.

### Advances Are Limited.

#### Jury Out Three Hours.

The coroner's jury deliberated more than three hours, after an examination of witnesses which started last Monday. Arbuckle, sensing the near approach of a verdict today, was intensely nervous throughout most of the session, twisting and clutching his fingers and flushing deeply at times. The round, boyish face was solemn and at times sullen. Although apparently deeply moved, he accepted the verdict with an attempt at composure and resignation.

The verdict was the outstanding event of the Arbuckle case today. Other developments were:

The starting of an investigation by R. McCormack, assistant Robert United States attorney-general, investigating prohibition violations, in Arbuckle's rooms in the St. Francia hotel, at which Miss Rappe was alleged to have suffered the attack which caused her death.




