

AS DRUG SMUGGLER

Engine Wiper on West Cayote Is Caught on Tip.

INFORMANT USES PHONE

Underworld Intrigue Said to Have Resulted in Capture of Edward Wolf by Police.

Underworld intrigue was said last night to be responsible for the arrest of Edward Wolf, 21 years old, engine wiper on the West Cayote, on a charge of having cocaine in his possession, although Wolf was booked by Patrolman Burdick and Sheriff of the police narcotics squad, Patrolman Burdick, 402 Knott street, at the same time confiscated 19 one-ounce bottles of cocaine and took charge of a \$200 automobile belonging to Edward Wolf, 422 Knott street, father of the prisoner.

Apparently, in the catch of a drug importer, a victory was recorded for the law. In reality, the old and firmly established ring of drug importers and peddlers was but strengthened by the arrest of Edward Wolf, in the opinion of the police.

Two Trips Made by Wolf. Wolf is a Portland boy, who has made two trips on the West Cayote. He was said to have confessed to Patrolman Burdick that he bought the 19 bottles of cocaine in a Japanese port, paying \$75 for the lot and that he was about to wholesale it to a negro here for \$35 a bottle. He declared it was the first time he had ever tried to flout the law, police said.

The West Cayote arrived early last week and Wolf began looking for a market for his smuggled cocaine. Being a novice, the fact that he had a quantity of cocaine for sale was soon noised about among the circles of Portland's underworld, whose connections have long been established, and have been tried in the past. It was reported to have decided that there was no room in the field for another smuggler, and that an over-supply of cocaine would bring prices down and ruin business.

As Patrolman Burdick, on his day off, was working about his home in Everett streets in the early evening. He tried to get hold of his partner, Patrolman Shaffer, 658 East Eighth street, North, and drove to the corner in his automobile.

A handsome touring car was drawn up at the curb. The driver, Wolf, was talking to a negro, Burdick placed him under arrest and upon searching the car, found the 19 bottles in a suitcase containing silken shirts and some other apparel.

The young sailor broke down when he was taken to police headquarters. He had heard of his father, who he said, to leave the stuff alone, but the huge profits appealed to him and he took a chance. He said his father thought he was driving to the boat to get a shipment to bring home to dinner, and that he had no knowledge of the use of which his automobile was to be put.

Bottles Sealed With Wax.

The 19 bottles of cocaine, after being adulterated with quinine and making soda water, were sealed with wax and carried a label of a Japanese firm, and the fact that there was English on the labels indicated that the cocaine had been prepared by the Japanese wholesalers for smuggling into the United States.

ZERA SNOW DIES IN CITY

Bar in Portland. The funeral will be held this afternoon at 2 o'clock from Trinity Episcopal church, Nineteenth and Everett streets, and concluding services will be at the Portland crematorium.

Zera Snow, prominent Portland attorney, whose funeral will be held today.

Zera Snow died late Saturday night in the Campbell sanitarium, after two weeks' illness. He was 67 years of age and lived with his wife, Mrs. Emily W. Snow, at Alexandra Court, 53 1/2 East 11th street, for nearly 35 years. He was a prominent member of the bar in Portland.

Mr. Snow was born in Salt Lake City, Utah, and spent the early years of his life in that city, receiving part of his education there. He attended law at the University of Michigan, and afterward took up his practice in the city of his birth. He remained in Utah until 1884, and came to Portland in 1884.

Almost at the start of his career he became interested in democratic politics, and during the period of his practice attended as a delegate from Oregon several national democratic conventions, the first at Chicago he withdrew from the Bryan faction and went over to the gold democrats. In this connection he accompanied the late Senator Thurston to the United States.

In law he was first associated with Judge William S. Gilbert through partnership. This lasted until Mr. Gilbert was elected to a judgeship, when he retired from the bar and went on the bench. Mr. Snow then associated with the late Judge Wallace McCamant, and this firm endured until the former retired four years ago.

One of the notable cases in Mr. Snow's career was when the Oregon-Washington Railway & Navigation company went into the hands of a receiver and he was associated with Senator Thurston of Nebraska, attorney for the Union Pacific system.

He is survived by his widow, Mrs. Emily W. Snow, 53 1/2 East 11th street; two sons, MacCormac Snow, a Portland attorney, and Berkeley H. Snow, manager of the Pacific Power & Light company at Hood River; also by three brothers and two sisters, George W. Snow of Los Angeles, Cal.; Captain Elliott Snow, U. S. N., Washington, D. C.; Herbert W. Snow of England; and Mrs. Adeline Gilmer of Wells, Nev., and Mrs. Susan Pratt of Salt Lake City.

670,000 IN SAN FRANCISCO

Population Estimate Is Made by Telephone Company.

SAN FRANCISCO, March 11.—This city's population now is 670,000, according to an estimate made by the telephone and telegraph company, and announced yesterday. The estimate, company officials said, is based on an elaborate checking system, including telephone installations and ordered registration of voters and daily average attendance at the public schools.

The last federal census gave San Francisco a population of 506,676.

DAYTON BONDS VOTED

\$50,000 of \$10,000 for School Is to Come From Estate.

WALLA WALLA, Wash., March 12.—Citizens of Dayton, Wash., yesterday voted a \$70,000 bond issue 127 to 44 as a result of which they will receive a \$20,000 school structure. Fifty thousand is to come from the estate of the late Dr. Marcel Pietzki and \$50,000 additional from the estate will be used for maintenance.

DRASTIC DANCE LAW ASKED IN NEW YORK

Bill Would Provide Number of Steps Minute.

WOMEN BACK PROPOSAL

First Offense Would Cost \$50 and Second \$250; 'Familiarity' Would Be Banned.

NEW YORK, March 12.—(Special.)—Dancing without a stop-watch and metronome will become an expensive proposition in this state if the Duke dancing bill, sponsored by the New York civic league and introduced in the legislature last week by Assemblyman Duke Jr., chairman of the assembly code committee, becomes a law.

The bill provides for the arrest of any one doing more than 60 one-steps or 40 fox-trot steps a minute and imposes a fine of \$50 for the first offense and \$250 for repeaters. Count to 48 if you want to wait and 54 if you two step. But have your check ready if you want to speed up the pace.

The bill has other pet aversions. It is designed to put an end to dancing exhibitions in New York ballrooms and dance halls, considered so shocking by the Civic league that it cannot describe them in its reform bulletin" and still send the bulletin through the mails.

'Familiarity' Is Banned. First and foremost, says the bill, "undue familiarity" between dance partners has got to stop. Five commissioners would be appointed by the bill to make a survey of the things the bill seeks to prohibit:

- 1. Vulgar jazz music which influences dancers to use jerky half steps and irregular variations.
2. The holding of partners tightly. Both dancers should assume a light, graceful position.
3. Check to check dancing.
4. Neck-hold dancing. The right arm should encircle the partner's waist, his hand resting lightly on her back, just about the waist line and he should place his other hand in the opposite hand of his partner's, or to the side and free from his or her body. The woman's hand should rest lightly on the man's arm or shoulder, but not extend to his neck or back.

Shaking Dance Is Banned. Dancing which consists of a shaking or jerking of the upper body while taking short steps or standing still or which consists of alternating right and left short side steps.

Dancing which consists of exceptionally long or short steps.

Dancing characterized by movements above the waist rather than from the waist down.

Dancing which consists of suggestive movements.

The extreme dancing seen upon the modern stage.

The presence of any dancers who violate any of the foregoing prohibited variations.

The bill also would ring a curfew for sub-debs at 9 P. M. for all under 21 occupying their parents' or guardians. So-called "moonlight" dances would be prohibited and quitting time for parties and other such things would be set at midnight.

LABORER SHOTS FRIEND

ATTACK IN BUNKHOUSE HELD TO BE MISTAKE.

Mexican Railroad Worker at Divide Sent to Eugene With Serious Wound; Assault Flees.

EUGENE, Or., March 12.—(Special.)—Alberto Cruz, a Mexican railroad laborer in the employ of the Southern Pacific company at Divide, was shot in the back by Ramon Gamino, a fellow laborer, at 6:15 o'clock this morning. Cruz is now at the Eugene hospital suffering from a serious wound.

According to officers who made an investigation of the shooting, Gamino had been on duty at the bunkhouse drunk. He fired two or three shots outside the bunkhouse, entering fired two more, the second striking Cruz as he slept.

The two men were friends and on that account the officers state that they believe the shooting of Cruz was a mistake. The bullet struck in the left side of the back and lodged near the left shoulder. It was extracted by surgeons at the hospital, and Gamino, after the shooting, disappeared and has not yet been found.

WOMEN REFUSE JURY DUTY

Four of 14 Called Claim Exemption in Marion County.

SALEM, Or., March 12.—(Special.)—Four of the 14 women selected to serve on the Marion county circuit court jury during the March term have declined, and have sent their exemption cards to the county clerk. Unless the women accept jury duty, it may be possible that the court will be compelled to dismiss the cases against two men now confined in the Marion county jail on statutory charges. The law provides that in cases of this character at least six of the 12 jurors shall be women.

These defendants have been in jail for several months, but by continuing to refuse until enough women accept jury service to comply with the law.

FATHER, 80, SHOTS SON

Joseph Felton, 45, Killed in Row With Aged Parent.

SAN JOSE, March 12.—Joseph Felton, 45, was shot through the head and killed tonight by his father, Joseph Felton, 80, after a row over whether a neighbor should be given permission to erect a shed on their property. The son threatened to knock him down and then only to frighten him. He exhibited a bruised head and a swollen eye, which he said occurred.

The son is survived by a bride of two weeks, ill at a local hospital.

MORE WARS PREDICTED

Zion Overseer Declares Britain Will Lose Many Colonies.

MILWAUKEE, March 12.—In addressing several hundred persons, Wabur Glenn Wolff, overseer of Zion, today prophesied that Great Britain would lose many of her colonies in the near future. Wolff followed by the formation of a great northeastern confederacy, with Russia, Germany, Japan, China forming a combined nation already allied with the United States.

"There is no peace for the world—nothing but hell," he declared.

BRIBERY EVILS SCORED

FAIR COMPETITION IN BUSINESS IS URGED.

Cure Lies in Souls of Individuals, Says Federal Trade Official; Abuses Are Cited.

BOSTON, March 12.—With a plea for fair competition in business as a "solid foundation" on which to construct national commerce, Huston Thompson of the federal trade commission speaking today at the Algonquin club, described some phases of unethical procedure with which the commission has come in contact through its study of American industries.

Commercial bribery, the speaker said, has taken on a tremendous impetus since the war. "representatives of many industries having come to the commission and declared it was impossible without the assistance of a government body to root the evil from their own establishments.

"Frequently it is said that commercial bribery is greatly superinduced by the breakdown of character through the un-American habit of accepting tips," Mr. Thompson declared. "Such a practice cannot be wholly eliminated by any governmental institution. The cure lies in the souls of the individual."

One of the greatest character-building forces in America, the speaker said, is the boy scouts organization, each of whom is pledged and taught to abhor tipping.

"The harvest of speculation" having been gained in the country districts, is now being reaped in the cities, Commissioner Thompson said, but he expressed disapproval of the proposal that a federal official be clothed with authority to say what securities could or could not be issued. A more effective law, he suggested, would be one requiring those selling securities to give all vital information concerning them, and to

EMPLOYMENT IS GAINING

Nearly All Industries in New York Show Increases.

ALBANY, N. Y., March 12.—Increases in employment in virtually all of the industries in New York state were shown in an analysis of employers' reports, issued tonight by Henry D. Sayer, state industrial commissioner. A 3 per cent increase in factory employment, the second largest gain since "the beginning of the depression," was featured in the report.

Improved business conditions and seasonal demands were the chief factors causing these gains in employment," said the report.
