

4 DEAD, 30 MISSING IN FLOOD DISTRICT

Body of Unidentified Negro
Woman Is Found.

REFUGEES ARE RESCUED

Thousands of Men Work to Prevent
Further Breaks in Levee of
Mississippi River.

FORT WORTH, Tex., April 28.—(By the Associated Press.)—The finding of the body of an unidentified negro woman in the flood district of Sycamore Heights late today brought the total number of bodies of flood victims to four with more than 30 still unaccounted for.

NEW ORLEANS, April 28.—Interest in the Mississippi river flood situation today was divided between the thousands of men working to prevent further breaks in the levee and the smaller groups who, in small boats, labored throughout the day after spending the night in the same kind of work locating refugees and removing them to safety.

Rescue work was carried on without intermission in both the Ferriday flooded area and at the Poydras area, the refugees being taken to camps set up at strategic points by the Red Cross and private enterprises. Reports from the Ferriday area late today said the flood waters were spreading over larger areas, although the first rush lost much of its force. The flood is spreading through Tensas parish and is nearing the towns of Vidalia, Arceneaux and Delta Bridge. At Ferriday, four miles from the break, the water is about six feet deep with a swift current running through the streets.

Plantations are inundated. Plantation homes more than a century old have been swept away and great trees which have withstood the force of many previous floods, have been uprooted. Many prosperous plantations have been ruined, ruining every prospect for a crop this season. Many homes and farm buildings have been destroyed, the flood carrying away or ruining valuable stores of food and feedstuff. Some livestock also has been lost.

Due to the quick action of local organizations and the Red Cross, no real suffering has been reported among the hundreds of residents of the inundated area, who are being concentrated in camps where they are being housed in tents furnished by the Red Cross and the war department.

Approximately 500 refugees have crossed the river into Mississippi and Natchez and are being cared for there. The Red Cross (today took charge of the camp established yesterday at Harrisburg, where it is reported 150 are being cared for. Approximately 2000 others are in camps at Jena, Louisiana and Marlinville.

Exodus in Boats Begun. Large numbers of refugees were taken from Moreau, Frogmore, Chevy Chase and other villages to Jonesville today, the steamer Howell bringing many others to that point tonight, mostly women and children picked up along the route of the Missouri Pacific railroad.

More than 250 persons who had previously announced they would remain in their homes at St. Bernard, surrounded by water from the Poydras crevasse below New Orleans, began a general exodus in boats to Violet today.

At Braithwaite, six miles below the Poydras crevasse, approximately 450 people were marooned late today and plans now are under way to bring them to Violet, where the New Orleans Red Cross has opened a canteen and provided all necessary supplies for refugees from the St. Bernard flooded area.

Music Educator Honored by Local Clubwomen. Notable Concert Reveals High Esteem for Emil Enna.

EMIL ENNA, composer and pianist, honoring his 25th anniversary as a music educator and as a citizen of the United States, was presented last night by the Portland Women's club at the Pythian temple in a notable program made up entirely of his own compositions. The numbers given represented various phases of musical effort extending over a period of many years and included a sonata for piano, two groups of piano studies, songs for baritone voice and a song cycle for soloists and women's chorus. All of the compositions are still in manuscript form, but arrangements are now being made for publication of the sonata and the song cycle, "Legends of Seaside."

The "Sonata in D Minor" follows the true sonata form. This composition was written some ten years ago, and at that time received the approval of Edward MacDowell, then a professor at Columbia university. Later it was revised and the final movement entirely rewritten. So it is a thoughtful product. The andante movement is built upon an old Danish air, and the whole sonata, written as it is in minor key, has about it a note of sadness and an intense melodic feeling.

It was interesting to hear it played by the composer. Two groups of piano numbers, composed within the year, included "Chanson d'Amour," a charming waltz that is being played by Henri Keates at the Liberty theater this week, "Springtime," a joyous composition for which the publishers predict great success, and "The Sea," which is the composer's interpretation of the sea and the movement of the ocean. There is a striking effect of undertone in the use of the base in this composition. "Dance Characteristics," a group of five variations, is original in theme cleverly worked out. Added to the programme were three numbers unusual in form from a suite composed for children. These are songs of great playfulness and freshness and are called "Happiness," "Mystery" and "The March." The "March" on Annie Laurie" was an enjoyable number and displayed his technique as a concert pianist. All accompaniments were played by the composer in a particularly pleasing manner and the piano scores for the vocal numbers are well written.

"The Legends of Seaside" (words by Virginia Drake) is unique and intensely interesting because of its local color. When published it undoubtedly will be often used in the northwest and should be more widely known. The choral numbers are effectively harmonized and the incidental solos are melodious, with the spirit of the words admirably interpreted in the music.

The recitation, with piano, "To Tillamook Head," was splendidly given by Mrs. Herbert Carr Reed. This number has a delightful bit of writing

representing the waves as they dash against the head. Sentiment and feeling pervade the musical setting of the "Legends." One song for contralto and chorus tells the story of the three graves of unknown sailors washed ashore after a wreck at sea. The song depicting the storm and telling of the nameless men who now rest beside the sea adds a dramatic touch.

This song cycle was charmingly rendered by the Calverath Bel Canto chorus, whose soloists and members are the Misses Elizabeth Bruere, Lois Thayer, Wilma Rinehart, Florence Johnson, Rose Parker, Cora Walker, Hazel Bradbury, Ruth Zander, Jessie MacLeod and Evelyn Calbreath.

Dr. Enna's songs, ably sung by A. E. Davidson, made an interesting group. They included "How Long and Drearly Is the Night" (words by Robert Burns), "Tenderness" (words by Robert), and "When Allah Spoke," which was written with the idea of its being used in the Shrine ceremonies.

During the evening Judge Ekwall presented Dr. Enna with a loving cup in behalf of his present and former students. Following the programme a short address by Frederick W. Goodrich, told of the composer-pianist's work as an Oregon musician. Dr. Enna comes from a distinctly musical family. His uncle, August Enna, is at present one of the national composers of Denmark, mentioned by the government that he may devote all his time to music. His operas and other compositions are produced by the government in the development of their national music.

Dr. Enna's compositions are the expression of a fine musical spirit, and his work stands out as that of one of the successful Oregon composers.

UNION MEN DISAPPOINTED

COAL STRIKE SETTLEMENT NEGOTIATIONS DRAG.

Presence of John L. Lewis at New York Conference Fails to Exert Expected Force.

NEW YORK, April 28.—The presence of John L. Lewis, head of the mine workers' international union, here today failed to have the predicted effect of speeding up negotiations toward settlement of the national anthracite coal strike.

Instead, labor members of the joint subcommittee on wage contract negotiations returned to their respective districts tonight without that which they had battled all week to obtain—a statement from the operators announcing what wage reductions they would seek as opposed to the increases demanded by the miners. The "psychological moment" to reveal their programme had not yet arrived, the operators asserted at the close of the session. Perhaps Tuesday, when conferences of the subcommittees are resumed, they said, this might be disclosed.

While the miners appeared disgruntled at the lack of progress toward the strike's end, the operators, for the first time since negotiations began March 15, appeared sanguine of the outcome.

Prior to the conference union delegates had repeatedly expressed a belief that "big developments" would take place today. Their disappointment tonight was evident.

Both operators and labor officials expressed satisfaction with the bituminous situation.

DIVA WILL SEEK DIVORCE

Mme. Matzenauer Takes Advantage of Husband's Default.

WHITE PLAINS, N. Y., April 28.—Attorneys for Mme. Margaret Matzenauer have filed an official notice that they will seek for their client a decree of divorce by default from her chauffeur husband, Floyd Glatzbach.

The defendant, who is in San Francisco, was served with a summons and complaint in the divorce action January 27 and had been in default since February 17. It was asserted that Glatzbach, under the law, now has no authority to appear or file an answer except upon consent in the motion made by an attorney resident in the state of New York.

CONLEY CASE PROGRESSES

State and Defense at Helena in Clash When Court Adjourns.

HELENA, April 28.—(By the Associated Press.)—Conversations here today alleged to have had with former Warden Conley of the Montana penitentiary regarding machinery, horses, harness and blankets paid for by the state and alleged to have been taken by the veteran prison official for his own use were detailed on the witness stand this afternoon by H. MacDonald in the trial of the suit for accounting before Judge Horsley.

Court adjourned at 12:30 in the middle of a battle between the state and defense over a number of typewritten sheets of notes which the witness made just after Conley had taken him to his home and shown him a pile of prison blankets.

WOMAN BURNED TO DEATH

Body of Invalid, 64, Discovered in Room by Neighbor.

SPOKANE, Wash., April 28.—Mrs. Esther Waters, 64, was found burned to death in her residence, 5003 North Madison, here today. Mrs. Waters had been crippled with rheumatism for many years, and the police have advanced the theory that her clothing caught fire from an open stove.

The room in which the tragedy took place was a small bedroom. The body was found by Mrs. Mary McFadden, a neighbor.

VISIT PLEASES JOFFRE

FRIENDLY FEELING TOWARD FRANCE OBSERVED.

Marshal Declares Heart of America, Once Won, Is Never Lost.

Quiet Day Passed.

NEW YORK, April 28.—Marshal Joffre passed his last full day in New York quietly, with only one or two short trips from his room. But as the day closed he issued a statement addressed to the people of the United States.

"I had indeed retained an ineffaceable remembrance of my stay in America in 1917, but the indications of sympathy and friendship which have again come to me have proved that the heart of America, once won, is never lost."

"I carry away with me the conclusive proofs of the faithfulness of the American people and their friendships. But I cannot take for my own all the friendships that have been mine, for the greater part of them. I consider, were meant for my country. But I like to see in these the evidence and the promise that the feeling of affection of your great country for mine is not in danger of extinction."

ILLICIT FISHERS ESCAPE

Quantity of Salmon Seized After Battle at Goble.

About 1000 pounds of "bootleg" salmon was confiscated by E. H. Clark, deputy game warden, and P. O. Haldeman, deputy, after a shooting affray with Columbia river poachers at Goble Thursday night. The fish

were brought to Portland yesterday. A tip was given that a big cargo of salmon caught during the closed season was being landed at Goble, and the officers were detailed on the job. They approached the fish pirates' boat as the men were unloading their catch on the dock. The poachers cut their hawser and put out into the stream. The wardens emptied their revolvers at the boat and the bullet tore up splinters on the deck. So far as known, none of the illegal fishermen were hit.

Linn's Registered Voters 10,644.

ALBANY, Or., April 28.—(Special.)—Linn county now has 10,644 registered voters, which is an increase of 487 over the registration on record last year. Completion of this year's registration was completed at the county clerk's office here yesterday. The registered voters include 3306 male republicans, 2487 female republicans, 2244 male democrats, 1387 female democrats, 71 male prohibitionists, 144 female prohibitionists, 116 male socialists, 57 female socialists and 322 independent and miscellaneous voters.

Clackamas Veteran Gets Loan.

OREGON CITY, Or., April 28.—(Special.)—Orval E. Hall of Oregon City is the first man in Clackamas county to receive a loan from the state under the so-called veteran's bonus bill. Hall's loan of \$3000 was received here today and the mortgage will be entered Saturday. The loan will be applied on a bungalow, recently completed above the Barclay school.

Woman Prisoner Going East.

Pearl Vargos, convicted Thursday in federal court of violation of the Harrison drug act, will while away 18 months in the federal women's reformatory at Rockwell City, Ia. The government directed that she be sent on to that institution, since there are no accommodations for women at the

McNeil's Island prison, the usual destiny of federal convicts sentenced here. Mrs. Vargos, now in the county jail, will start on her journey to Iowa as soon as a deputy United States marshal finds time to escort her.

Boy, 20, Weds Girl, 17.

VANCOUVER, Wash., April 28.—(Special.)—Roy L. Stout, 20 years old, was married here today to Evelyn Alice Campbell, 17. Stout said he was a longshoreman. He said he lives in Milwaukee. Stout was accompanied by his father, H. E. Stout, and the girl by her mother, Mrs. E. T. Cheever, 5604 Fifty-second street, Southeast. The parents gave their consent to the marriage and acted as witnesses. Justice F. E. Vaughan performed the ceremony.

Bonus Bonds Delivered.

SALEM, Or., April 28.—(Special.)—Officials of the world-war veterans' state aid commission today delivered to Portland so-called "soldiers' aid" bonds aggregating a value of \$1,600,000. There are yet \$10,000,000 of

these bonds to be sold. Under the law all persons eligible to bonus or cash loans who desire to take advantage of the benefits must file their certificate of qualification with the commission before May 25.

Judge Asked to Be Candidate.

KLAMATH FALLS, Or., April 28.—(Special.)—Petitions are being circulated in an attempt to obtain the consent of Circuit Judge Stone, appointed two months ago by Governor Olcott, to be an independent candidate for the judgeship this fall. Two aspirants for the republican nomination and one democrat are in the field. Judge Stone's brief judicial career has won a strong following.
