

CIRCUS BAND CHEERS SICK YOUNGSTERS

Musicians on Lawn Play for Children of Hospital.

CROWDS SEE ANIMALS

Sightseers Wander Through Big Tent; Parade to Commence at 10:30 This Morning.

Happiness—pure happiness—reigned in the hearts of scores of little sick youngsters at the Good Samaritan hospital yesterday afternoon, for a band, and a real circus band at that, stationed itself on the lawn of the hospital and played as only a circus band can play.

The treat of the elephants, the gentle sway of the "big-top" tent, and the antics of the clowns seemed to visualize under the stirring strains of the band music, and the youngsters, heavily blanketed in their ominous wheel chairs, smiled their joy and contentment.

The youngsters, though, were not alone in their enjoyment of the concert. Those patients at the hospital who were well enough to be moved outdoors, were banded around the band, some on crutches, some in wheel chairs. And the windows of the hospital were lined with those who were unable to go out-of-doors.

Hundreds Gather on Porches. Hundreds of nearby residents, drawn by the music, gathered on Levee street and on neighborhood porches. Bishop Walter Taylor Summer of the Episcopal diocese of Oregon officially welcomed the band on behalf of the hospital, and personally thanked Bandmaster Edward Weekender for his services.

The concert, which has become an annual custom on the part of the Al G. Barnes circus, came about through an accident. Three years ago by Miss Beale Harvey, prima donna of the circus. On May 19, 1919, Miss Harvey was thrown from her horse while leaving the circus grounds for the parade, and she sustained serious injuries, which confined her to the hospital for 13 weeks.

Such fine treatment did she receive that every year since then when she has visited Portland, she has gone to the hospital with the band to show her gratitude for the kindness. Miss Harvey yesterday sang "Mother Ma Chere" for the patients, a song of rare charm and power. She was formerly connected with the San Carlo grand opera company.

Youngsters Are Appreciative. Probably the most appreciated piece rendered by the band was a cornet duet, "Somewhere a Voice is Calling." The cornet players stationed themselves on the lawn of the hospital, and their notes blended well with the accompaniment from the band below.

The concert was primarily for the youngsters at the hospital, and their appreciation was manifested in countless ways. They were grouped around the band in the sun, and there in the charge of Miss A. Glosso, assistant superintendent, keeping watchful eyes on the children, and those who were so excited by the music that they wanted to be up and dance.

The youngsters this morning will be taken to a corner near the hospital, where they can watch the parade, which will leave the circus grounds, Twenty-fifth and Raleigh streets, at 10:30.

Even Old Sol, who had been playing hide and seek behind a bank of heavy clouds all morning, seemed to join in the general merry-making, for a short time before the concert was scheduled to begin, he came out and raved in all his glory, and bathed the lawn in warm sunshine.

Crowds Glimpse Animals. Life was added to the general scene by a little yellow pup and an equally small black-and-white one, who romped about with the abandon generated in some humans even by modern jazz music.

Throughout the day, large crowds wandered through the tent world erected early in the morning on the circus lot at Twenty-fifth and Raleigh streets. The usual thrills were obtained by glimpses of the elephants, the tigers, the kangaroos, bears, monkeys and all other wild animals that go to make up the circus menagerie. Tusko, "the largest elephant in captivity," proved to be a real spell-binder. The smelly, the horses and cook tents, all added to the general interest for sightseers, while visitors in the late afternoon were rewarded by the spectacle of the "big top" being erected.

H. S. Tyler, general manager of the show, and his assistant, Rex de Rosell, accompanied the band to the Good Samaritan hospital. The circus will give two performances today and two more tomorrow.

HOTEL HAS MORNING FIRE

BEN HUR HOSTELRY DAMAGED TO EXTENT OF \$1000.

Officials Investigate to Find Out if Blaze Was Due to Carelessness or Incendiarism.

Damage of approximately \$1000 was sustained and lodgers were forced to flee into the street in their nightclothes when a fire broke out shortly after 2 o'clock yesterday morning in a room on the second floor of the Ben Hur hotel, 347 Oak street.

Fire bureau officials are now investigating to determine whether or not the blaze was due to carelessness or incendiary. The room had been occupied by two soldiers from Vancouver. Shortly after midnight they had been put out of the hotel for drunkenness and it was in their room that the fire was discovered.

The fire was discovered by Mrs. E. Goldstein, landlady, after it had burned its way through from the third floor to the second floor in a room occupied by her. Before calling the fire department she sounded the hotel alarm and lodgers were rushing down stairs scantily attired when the fire apparatus arrived.

The fire loss was confined to two rooms on the second and third floors, although some loss by water was suffered by the Cohn Bros. furniture store, directly beneath, at 351 Oak street.

The building is owned by the Beck Investment company. The loss was divided at about \$500 to building and an equal amount to contents.

A stinkier chimney blaze which ate its way into the roof gave fire fighters a battle at about church time yesterday morning at the home of Dr. K. Bronckah, 1929 East Market street. The damage was nominal and was confined to the roof.

SO IN QUALIFYING ROUND

TOURNAMENT FOR DIRECTORS' CUP IS ATTRACTIVE.

Rudolph Wilhelm Wins Medal Honors With Gross of 76; Clare Griswold Second With 81.

The qualifying round of the handicapped tournament for the directors' cup at the Portland Golf club yesterday drew an entry list of 90 players. In addition to the championship flight of 16, Lester W. Humphreys, chairman of the handicap committee, found it necessary to provide nine additional flights to take care of all the entries.

Rudolph Wilhelm won the qualifying medal honors with a gross of 76, while Clare Griswold was second with an 81. The luck of the draw brings Wilhelm and Griswold together in the first elimination round. 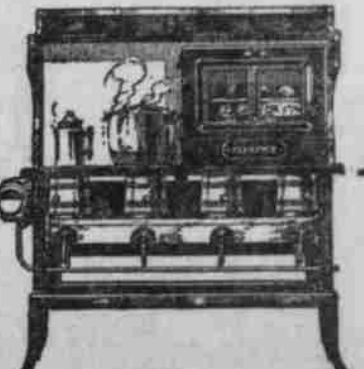
