

JACKSON CLUBBERS STAGE NEAR RIOT

Proposal to Indorse Compulsory School Bill Cause.

MOTION TABLED FINALLY

W. T. Vaughn Introduces Resolution, Stirring Up Oglesby Young to Counter-Attack.

The Jackson club had what might well be termed a regular meeting last night in the Central library. It was regular and characteristic in that it broke up in a near-riot. This came following the introduction by W. T. Vaughn, past president of the organization, of a resolution calling for the support of the compulsory public school bill.

In introducing this resolution I am not seeking to inject any religious question into the meeting, but simply asking that the Jackson club go on record as favoring the greatest institution in this country, the American public school," declared Mr. Vaughn.

School Bill Denounced. As soon as the resolution had been read, Oglesby Young, long a wheel horse in the affairs of the club, was on his feet with a denunciation of the school bill.

Mr. Young protested against not only the bill, but against its authors and declared in eloquent terms that a resolution asking for its support had no place in a meeting of the Jackson club.

Following Mr. Young's speech, Mrs. Bertha Slater Smith, who occupied the chair in the absence of Harvey Starkweather, restored order and again recognized Mr. Vaughn.

Resolution Is Tabled. "I will ask that the resolution be laid upon the table until our next meeting," declared Mr. Vaughn. "I have no doubt but what more than three-fourths of the democrats gathered here tonight would vote for the resolution, but I am asking that such men as Brother Young be given ample time to acquaint themselves with the resolution before being called upon to vote upon it."

The resolution was laid upon the table as requested by Mr. Vaughn. The chairman failed utterly to restore order again and the members of the club fled flocking to the exits of the hall and voicing their sentiments as they went out.

Introduction Is Difficult. It was with some difficulty that Mr. Vaughn was able to introduce his resolution. Elton Watkins, candidate for congress and Mrs. Maria L. T. Hidden, candidate for the legislature, had spoken when Mrs. Smith, occupying the chair, announced:

"We have a letter to read and then we will adjourn."

Mr. Vaughn, at his feet, obtained the recognition of the chair and immediately started talking for his resolution. Once into his speech he would not be stopped, although some of the members of the club started to leave the meeting.

In his campaign address Elton Watkins came out in favor of the public school bill. He also advocated the soldier bonus and the employment of none but American citizens in any public capacity.

Text Quoted. The text of Mr. Vaughn's resolution follows:

We, the Jackson club of Oregon, in regular meeting assembled, realizing the importance of keeping abreast of the times and meeting the live issues of each campaign honestly, fearlessly and unreservedly, and that no question may be raised in the mind of anyone as to where and how we stand, deem it essential to establish and proclaim to the world the policy, in this campaign, of the principal democratic organization in this state, and be it known that our policy is to condemn that which is false, deceitful and unjust, and commend that which is honest, straightforward and righteous.

Therefore be it resolved, that we condemn the act of Ben W. Glott, governor of this state, for his uncalculated, infamous political proclamation which was intended to, and did, inject into politics a religious question which caused many democrats to change their registration that they might vote in the republican primaries for a governor whose bid for their votes rose to him on the basis of race, color or creed, and the effect of which was to violate his sacred oath of office and the spirit of our constitution in seeking to unite church and state.

School Bill Favored. And be it further resolved, that whatever we may have wished to the contrary, we nevertheless, in this campaign, are confronted with a dominant issue, and one which lies at the very root of our government; believing as we do that education is the bulwark of our liberties, and our chief anchor of safety, and that our educational system, manufactured from American ideas stands firm and foremost among the educational systems of the whole world; and further believing that American citizenship is best secured by citizens educated in our free school educational institutions.

Therefore be it resolved, that we stand first and foremost behind our free school educational system and approve and endorse the recent bill introduced by over 70,000 of Oregon voters, between the hours of 9 in the forenoon and 5 in the afternoon, who signed their approval of said bill, and thereby inspired us with the hope of complete victory at the polls at the election to be held next November.

Walter M. Pierce, democratic candidate for governor, was to have been the chief speaker at the meeting, but was unable to attend.

WAR MOTHER EN ROUTE

HEAD OF LEGION AUXILIARY TO BE PORTLAND GUEST.

Mrs. Lowell F. Hobart, National President, Devoted Friend of Disabled Veterans.

Mrs. Lowell F. Hobart of Cincinnati, O., first national president of the American Legion auxiliary, will arrive in Portland either Saturday or Sunday for a stay of several days during which she will visit local hospitals in which veterans are being cared for, vocational centers and points of scenic interest, according to word received yesterday by Mrs. W. A. Eivers, president of the auxiliary in Oregon. Preliminary plans are being laid for a dinner in her honor, to which the 70 auxiliary units throughout the state will be invited to send representatives.

Mrs. Hobart is one of those "war mothers" who served in the great "second army." When her son joined the colors and was sent to Camp Zachary Taylor, Kentucky, she went with him, working there daily as a Red Cross supervisor and at night instructing a class in Red Cross work.

She declared after her election at the first national convention of the auxiliary at Kansas City that the first thought of legion women would be for the war's sick and wounded.

"The young men of the legion have been carrying on the work practically unaided," she said. "The government gives the poor boys in the hospitals nothing but coldly impersonal official attention, and little enough of that. We will mother the lonesome, unhappy service men wherever we can reach them in the hospitals and out. They are our boys and our boys they always will be."

The 1932 programme of the auxiliary calls for a unit for each of the legion's 11,000 posts. As each legionnaire has an average of at least two relatives eligible for the auxiliary, the latter organization promises to become stronger, numerically, than the legion itself.

SOUTH BRIDGE PLANS LAID

SPAN TO RELIEVE TRAFFIC TENTATIVELY LOCATED.

Proposal Locates Big Structure Between Beacon Street, East, and Grover or Gibbs, West.

Last night at the city hall at a meeting of the sub-committee comprising representatives from various district improvement committees, the south of the city, rudimentary plans were formulated for the erection of a bridge across the Willamette river south of Hawthorne avenue.

After considerable discussion the site finally agreed upon as the local one for the structure to relieve traffic congestion on the Hawthorne and other bridges was at Beacon street on the east side of the river and at Grover or Gibbs street on the west side.

Several sites were in the minds of the committee members for consideration. The principal question was whether to build the next bridge close to or far from the farthest bridge south. The latter plan was adopted.

City Commissioner Barbur, representative of the Brooklyn Improvement club, pointed out that the immediate demand for the bridge was principally to relieve the dangerous traffic congestion on the other bridges.

C. M. Ross, chairman of the committee and representative of the Mount Scott Improvement club, advocated the Beacon-street site. The bridge there would connect with the main traffic arteries leading both to the farming district southeast of the city and to Foster road as a future approach to the Columbia highway. He also pointed out that a bridge there might connect with Ross island should the city ever come into ownership of that land.

No particular type of bridge was advocated at the meeting because of lack of knowledge of what would be the government requirements for a bridge at that point.

It was never made public whom McHugh represented, but the supposition was that he was backed by the republican national committee. McHugh endeavored to have legislators violate their statement No. 1, but that they vote for Charles W. Fulton, whose seat in the United States senate Chamberlain was about to take. There were offers of patronage, but the McHugh programme failed through. A few legislators filed protests when they voted, but Chamberlain was elected. After the fiasco McHugh left the state.
