

TILLAMOOK SECTION
MENACED BY FIRESGrave Situation Reported by
Forest Patrol.

SMALL BLAZES SPREAD

Railroads and Lumber Companies
Send Crews to Woods to Com-
bat Dangerous Flames.

The forest fire situation in the Tillamook country is becoming rather grave, according to the latest reports received from there. Carl C. Scott, secretary of the Forest Fire Patrol association, returned yesterday from a trip into the forests in that district, where he investigated conditions.

Mr. Scott says the country is especially favorable for any kind of a fire and that the small blazes which were reported early in the week have spread considerably into more serious blazes. The winds which are springing up in the afternoon are causing the fighters much trouble.

Brush Fires Prevalent.

Thus far the majority of the standing timber in the country has not suffered as greatly from fire as might be expected. Mr. Scott says that most of the blazes are confined to the underbrush and the lower parts of the trees, so that timber in the fire area is still loggable. The worst of the fires are located about Timber, Cochran and Belding and new conflagrations are reported in the properties of the Wheeler Lumber company at Wheeler. Their timber is at Nehalem bay.

In view of the grave situation in Tillamook county, the Southern Pacific company sent two fire-fighting trains on Wednesday into that region to assist the private agents in combating the blazes, and sent an additional one yesterday. The Hammond Lumber company of Astoria, for protection against fire in its properties in the Tillamook district, has also sent a special train equipped with fire-fighting apparatus.

Large Crews Fight Blazes.

Most of the blazes being fought by large bodies of men and do not threaten particular danger to the surrounding country. As a matter of precaution, however, calls are being sent in to local protective associations for all available men to be sent out.

The government forest fire bureau received no reports of any new fires yesterday. Those in the Lake Chelan and Fish creek districts have been brought under control. E. N. Kavanagh, assistant district forester, said yesterday that the conditions in Oregon and Washington were better yesterday than they had been for some time in the government reserves.

LOGGING CAMPS MAY CLOSE

Indications Are That Fire Pre-
caution May Be Taken.

OLYMPIA, Wash., July 6.—(Special.)—Messages of general approval of Governor Hart's request that logging camps remain closed until rain wipes out the present forest fire menace were received from loggers in all parts of the state today. It was announced at the office of State Forester P. E. Pape, with indications that quite general closing of the camps would result. The loggers offered their co-operation in every way possible, even to keeping their camps closed a month or more if necessary.

Continued hot weather with dry northeast winds fanned into flames several more of the Washington fires that had been subdued.

First detailed reports from eastern Washington came today from Spokane, Stevens and Ferry counties. In Spokane county there are five fires beyond control, one of which has covered 300 acres near Chataway and another burning in the northeast corner of the county. The Pend Oreille county boundary. Location of the other three was not given.

WOLF CREEK FIRE REPORTED

Big Blaze Breaks Out Southwest
of Eugene Near Crow.

EUGENE, Or., July 6.—(Special.)—A big forest fire was reported today on the headwaters of Wolf creek, southwest of Eugene and eight or ten miles from Crow. It has covered 40 acres, according to O. V. Olesky, supervising warden of the western Lane County Fire Patrol association.

Another fire is reported by Warden Olesky to be burning near Beecher rock, on the old stage road to the Siuslaw. It came near destroying a donkey engine in the Beecher Graves logging camp, but by hard work the loggers checked the blaze.

A brush fire which started Sunday

in the Spencer butte section just south of Eugene has destroyed fences and is threatening outbuildings on a number of farms.

Polk County Fires Controlled.

SALEM, Or., July 6.—(Special.)—Frank A. Elliott, state forester, today received word from Polk county to the effect that a number of forest fires that have been raging in that section of the state are under control. None of the fires resulted in serious losses, according to Mr. Elliott.

Coweman Fires Fought.

KELSO, Wash., July 6.—(Special.)—State Forester Fred Pape and Fire Warden George Joy are on the upper Coweman supervising a fight against a forest fire which crossed the Coweman spring from Polk county and the Kalamia river, menacing thousands of acres of timber. The situation is also serious north of the Coweman, where a fire has burned for several weeks. Rain alone will check fires.

DEPORTATION IS FOUGHT

Writ of Habeas Corpus Filed in
Lodging House Case.

On the ground that his client is illegally held by immigration authorities and threatened with deportation, Paul Dormitzer, local attorney, filed a writ of habeas corpus with the United States district court yesterday seeking the release of George Takis, lodging-house proprietor of 1044 Fourth street. Takis was arrested by the police moral squad several weeks ago after two women, taken in a raid on his house, had testified about conditions there. Tony Kosakis, a partner in the venture, also was arrested. Investigation by immigration inspector Bonham led to the institution of deportation proceedings against the pair. Takis and Kosakis were accused of sharing in and deriving benefits from the earnings of fallen women.

The two were held in the county jail. The writ will be heard in the United States court in a few days. Deputy United States Attorney Byron will represent the government in the proceedings.
