

HARDING'S FRIEND BACKED BY DRYS

Governor Edwards to Oppose New Jersey Senator.

TENT CAMPAIGN UNIQUE

George L. Record, Republican Candidate, Has Bugler Call Towns to Hear Talks.

WASHINGTON, D. C., Aug. 13.—(Special.)—Joseph S. Frelinghuysen, the senior senator from New Jersey, is a candidate for re-nomination. He is a republican. He is a personal friend of President Harding, who has visited the senator in his home during the present summer, and he is now being opposed for the republican nomination in much the same way and on some of the issues which brought success to various other progressive or radical, like Mr. Brookhart's victory over the regular republicans in Iowa, Mr. Frazier's victory over Mr. McCumber in North Dakota and Mr. Howland's victory over the regulars in Nebraska.

Superficially there is some resemblance between these western situations and the one now developing in New Jersey. It cannot be said, however, that this opposition to Mr. Frelinghuysen has as yet gone far enough to threaten his re-nomination seriously. His opponents point out that there are seven weeks to go yet.

Campaigner Uses Tent.

The anti-Frelinghuysen candidate is George L. Record of Jersey City. He is conducting an unusual campaign. He has a tent and a big truck that carries 160 folding chairs. Every morning Mr. Record with his tent and his truck and a band of helpers, including a skilled cornetist, strike out for new towns. By 12 o'clock the tent is set up. During the afternoon Mr. Record's workers go out and insert in the mail boxes or under the doors of all the houses in the town a pamphlet setting forth his platform with his ideas on the questions of the day, and his tent, with the same circulars carry an announcement of the time during the evening. When evening comes Mr. Record's truck, gaudily painted and otherwise decorated with the largest degree of effectiveness, starts around the streets of the town, with the cornetist sounding a bugle call and another helper with a megaphone announcing that Mr. Record will speak.

Socialism Is Repudiated.

Mr. Record makes his talk in favor of many of the familiar devices which have been successful in the west, government ownership of the railroads, higher taxes on the rich, further regulation through the federal government of the hours and other conditions of labor in manufacturing industries, and the election of senators by popular vote. Mr. Record has had practically a lifelong association with progressive movements with the old progressive party in a formal sense, and since the death of the progressive party with third-party movements.

Primary Law Fostered.

Among his achievements, as listed in his own campaign literature, Mr. Record was the author of the New Jersey direct primary law, the public utility franchise law, and the workmen's compensation act. He says he helped to make the New Jersey law giving the state the power to fix rates for gas, electricity, light and trolley companies. At one time or another Mr. Record has been a member of the Jersey City board of education, and the state board of railroad assessors, republican nominee for congress, Roosevelt delegate to the republican election for Charles E. Hughes in 1916.

As yet there is no sign that Mr. Record's effort has endangered Mr. Frelinghuysen, who is being endorsed by most of the regular party organizations. The thing that will probably make Mr. Frelinghuysen secure is the fact that he is "dry." Everybody knows that the democrats in New Jersey this year are going to give their senatorial nomination to Governor Edwards, who is one of the most conspicuous "wets" in the country and who, if elected, would be "wet" in the right to lead the "wet" fight in Washington. Under these circumstances Mr. Frelinghuysen is the white hope of the "drys."

FARMERS TO WAGE FIGHT

PROGRAMME OF NEW LAWS TO BE FRAMED.

Taxation Reform in Washington State Is Declared One of Greatest Needs.

TACOMA, Wash., Aug. 13.—(Special.)—The country farm bureau of Washington will formulate a programme of legislation which they want passed at the next legislature and will attempt to finance a fight for its needed laws. It was decided here yesterday at a meeting of representatives of county farm bureaus. A second meeting, at which a programme will be submitted and discussed, was set for September 13 at Yakima.

Taxation reform is one of the greatest needs of the farmers of the state. It was agreed by the representatives. A law to allow municipalities with electric power developments to sell power to farmers along their transmission lines was mentioned as an immediate need. Some manner of getting cheap power to the land settler was a third proposal. A committee named to formulate a legislative programme consists of N. H. Masie, Yakima, chairman; F. C. Johnson, Skagit county, and Thomas Spence, Pierce county.

S. A. Mansfield, president of the Oregon State Farm bureau and a national figure in the farm bureau movement, made an address to the gathering, declaring that co-operation is the salvation of the farmers and that when the farmers learn to use their united power, as in the farm bloc movement in congress, they can get what legislation they need. The farmer must spend some money to get what he wants, he said.

Then, too, it must be remembered that actors and actresses live in a make-believe world. More than often this make-believe extends into the very first days of their honeymoons.

PORTLAND FOOD CHEAPER

RETAIL PRICES ARE LOWER THAN IN SEATTLE.

Scale Also Under San Francisco. Declares Washington Deputy on Statistics.

OLYMPIA, Wash., Aug. 13.—(Special.)—Retail prices of foodstuffs in Portland, Or., average lower than in either Seattle or San Francisco, and while Chicago pays much higher prices for some commodities than do any of the cities, the cost of living there this year averages lower when all retail prices are considered, according to a compilation of comparative prices made recently by J. S. McIntosh, deputy commissioner of the bureau of statistics and immigration, in the office of J. Grant Hinkle, secretary of state.

Beef prices as a rule run a little lower in all cities this year than last, but other staple foodstuffs are considerably higher, making the cost of living on the whole this year above that of last year. As compared with 1913, prices this year range from 39 to 100 per cent higher.

Portland, paying 29.6 cents a pound for sirloin steak, has a lower price than San Francisco, which pays 30.3 cents. Seattle which pays 31.4 cents or Chicago which pays 36.7 cents. Prices for other cuts of beef range in about the same proportion except that for plate beef Chicago is paying 11.6 cents, Portland 13.6 cents, Seattle 13.8 cents and San Francisco 14.4 cents. Last year Portland paid 30.7 cents for sirloin steak, San Francisco 31 cents, Seattle 33.4 cents and Chicago 38.1 cents. In 1913 prices on the same commodity were 30.3 cents in San Francisco, 23.5 cents in Portland, 22.8 cents in Seattle and 22.6 cents in Chicago.

Portland also has the lowest price for pork chops this year, paying 31 cents, while Chicago pays 32.4 cents, Seattle 34.5 cents and San Francisco 38.7 cents.

Portland and Seattle pay more for hens this year than last, while San Francisco and Chicago pay less.

Portland again has the lowest milk price of the four cities, paying 11.5 cents a quart against 12 cents in Chicago and Seattle and 13 cents in San Francisco.

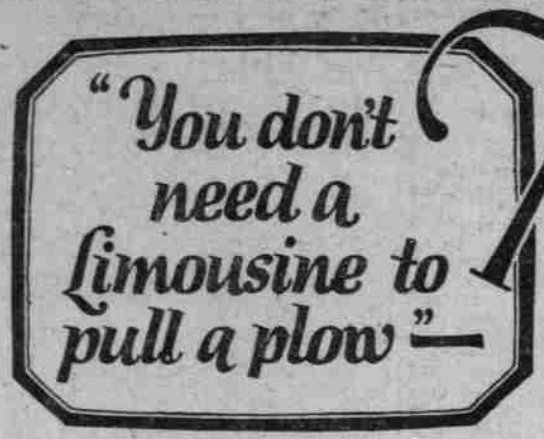

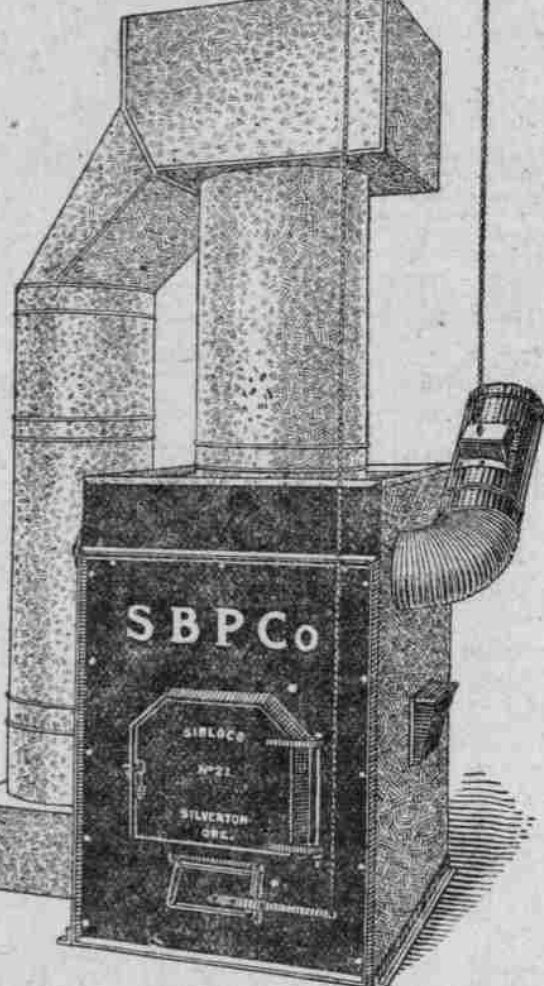
