

2 MEN DENY PART IN HIGHWAY CRASH

Hearing of Manslaughter Charges Is Begun.

SUSPECTS ARE JAILED

Frank A. Gilcrest and Stanley Pullin Appear to Be Sons of Wealthy Families.

THE DALLIES, Ore., Aug. 28.—(Special.)—Formal hearing of the involuntary manslaughter charges filed this morning against Frank A. Gilcrest of Pasadena and Stanley Pullin of Carmel, as a result of the automobile wreck in which Edwin M. Hill of DuPont lost his life, opened at 7 o'clock tonight. In order to save duplication, the coroner's inquest and the hearing were held conjointly. Justice of the Peace Allen swearing the witnesses in and he and Coroner C. N. Burget acting together in the taking of testimony, Gilcrest and Pullin today denied all knowledge of the fatal accident. Gilcrest said they were on the way to Lewistown, where they were on a wheat ranch. They were hurrying because the harvest is now at its height and he is needed there, he said.

Men Are Jailed.
Both Pullin and Gilcrest said their machine could not have struck the other car without their knowledge and they declared that the first they knew of the accident was when they were arrested in Arlington. Apparently the actions of wealthy families, judging from their dress and conversation, Pullin and Gilcrest had their first taste of jail today following a reading of the charges at an arraignment before Justice Allen. They were placed in the county jail by Sheriff Christman pending the outcome of the joint hearing and inquest which started tonight. No bail was set.

The hearing probably will extend over a period of several days, according to District Attorney Galloway, who is making arrangements to have the Arlington marshal, who made the arrests, appear as a witness. Singularly enough, both Pullin and Gilcrest are said to have broken down completely when arrested in Arlington, and to have been unable to give their own name for more than an hour.

Jury Visits Wreck Scene.
Members of the coroner's jury impaneled this morning, during the day visited the scene of the wreck where photographs were taken of the car and the general lay of the land. They visited also Mrs. Hill and the children in the hospital. Mrs. Hill, although seriously injured, is expected to recover, as are all of the children, who were riding in the car at the time.

Funeral services for Mr. Hill will be held tomorrow at 2 P. M. Burial will be in the DuPont Oddfellows cemetery, under the auspices of the Oddfellows lodge, of which he was a member.

DECISION IS DUE TODAY

JUDGE WOLVERTON IS TO ANNOUNCE CONTEMPT RULING.

Shop Workers Accused of Picketing in Violation of Federal Court Injunction.

The decision of Federal Judge Wolverton, in the contempt of court proceedings brought against 14 railroad shop workers accused of picketing in violation of the federal court injunction, will be announced this morning at 10 o'clock.

The case, which occupied almost nine days of the court's time, came as a result of a demonstration staged at the shop gates on August 1, three days after the federal court injunction became effective. Railroad attorneys, in their affidavits made in connection with the contempt charges, declared that the non-union workers, on leaving the shops that night, had been forced to walk through a double line of pickets and that abuse and vilification were hurled at the workmen. Some were spit on, others jostled and tripped, the complaint charged.

Fourteen men were ordered to show cause why they should not be punished. The hearing commenced two weeks ago today and was concluded last Wednesday. Almost 100 witnesses were examined, every point of law bitterly contested and free and open charges of perjury made by both sides. The union officials, admitting that there had been men in the vicinity of the shops, claimed that the strikers were forced to go there to draw back pay which they had coming from the company and that the officials took advantage of this fact to discredit the workers before the public.

POLAR FLIGHT TO WAIT

Exploring Ship Thought Returning to Nome.

Amundsen Believed to Have Given Up Aerial Dash Into North for Season at Least.

NOME, Alaska, Aug. 28.—(By the Associated Press.)—Captain Roald Amundsen's exploration ship *Maud* is in the ice off Point Hope, north of Kotzebue sound and the eastern entrance to Bering strait, according to a radio message received here today from the coast guard cutter *Bear*. It is believed here that the *Maud* is returning to Nome because of unfavorable ice conditions.

The message also gave definite information that Captain Amundsen, who left the *Maud* some time ago, with Lieutenant Oskar Omdal, aviator, and a motion picture photographer, will pass the winter at Wainwright, near Point Barrow, apparently having given up his proposed trans-polar airplane flight for this season, at least.

The *Bear* is due to arrive at Nome within the next 24 hours. Her arrival is anxiously awaited in the hope that more definite news of the Amundsen expedition may be obtained from Captain Cochran, her commander.

The *Maud*, bearing the Amundsen north polar basin scientific expedition, sailed from Seattle June 3, bound for Nome and the Arctic ocean. At that time Captain Amundsen expected to drift with the Arctic ice pack, making oceanographic and meteorological investigations, and in all probability to pass the North pole. He expected to be gone for from five to seven years. Later it was announced that Captain Amundsen had decided to attempt an airplane flight from Point Barrow to Grants Land, stopping at the North pole if possible. The *Maud* became involved in heavy ice in Kotzebue sound and the explorer, with Lieutenant Omdal and another member of the party, transferred to the schooner *C. S. Holmes* in an effort to reach Point Barrow. Cablograms from Nome yesterday reported the arrival of Captain Amundsen at Wainwright, 100 miles southwest of Point Barrow.

CZECHS ARE ENVIABLE LOT

LITTLE REPUBLIC ENJOYS GREAT PROSPERITY.

Country Produces More Than It Needs and Carries on Thriving Trade.

PRAGUE, Czechoslovakia.—Although the Czechoslovakian republic is only three and a half years old, it is the one state in Europe which has set its house in order and has avoided the evils of the printing press. The Czechs, or Bohemians, are a hard-working and plucky race, full of common sense, and they have built up an economic and industrial fabric which has made the country one of the most prosperous in central Europe. Its industry today is beyond the needs of its own population. The Czech republic, which until last autumn had followed the fluctuations of the German mark, has now established its independence in the world's exchange.

Since the creation of the republic the bulk of trade has been with Germany, although the United States is gaining an increasing share of it. According to official figures, 47.7 per cent of Czech imports in 1921 came from Germany, the latter country taking 36.3 per cent of Czech exports. Every Czech realizes that the future of the country's trade is in central Europe, but he is anxious to avoid as far as possible any economic dependence on Germany.

Like many other European countries, Czechoslovakia's most vital problems concern the much-needed reduction in production costs, the cost of living, the reduction of taxation and amelioration of the housing situation. At present Prague is one of the most expensive cities in Europe. One of the causes is the tremendous national budget, which is swollen by heavy military expenses.

Compared with Vienna and Budapest, Prague presents an appearance of prosperity and alertness. There is not that sense of despair and uncertainty and indecision which the American traveler meets in Vienna. While other European capitals suffered from the great war, Prague was hardly affected until the revolution of 1918, when she awoke suddenly to find herself one of the great capitals of Europe.

Czechoslovakia's political system is based upon the strictest democratic principles. Her policy being one of innovation and evolution along republican lines. Bolshevism has been crushed. Drastic land reforms have been made to appease the appetite of the masses. No one is allowed to hold more than 250 hectares of arable land or 500 hectares of forest land. Owing to increased wages, the working classes live in comfortable content. There is little unemployment.

As in most other European cities, the housing problem in Prague is acute. Any owner of a flat or house is liable to have his quarters commandeered by the state. In spite of the government's endeavors to encourage the erection of new buildings, the building trade has remained virtually suspended. Many of the poorer nobility have migrated to Vienna, Munich, Berlin, Poland or Hungary in order to benefit by the rate of exchange. Others occupy a small corner of the vast palaces which have been in the possession of their families for centuries.

RECORD SHOW PROMISED

BIG SOUTHWEST WASHINGTON FAIR OPENS TODAY.

All Available Space in All Departments Occupied and Tent Houses Overflow.

CHEHALIS, Wash., Aug. 28.—(Special.)—The gates of the 14th annual Southwest Washington fair will swing open tomorrow on the biggest show of its kind ever staged locally. In every department entries have filled all available space.

So great was the rush of late cattle and other livestock entries that Superintendent Fowler had to erect all the tents he had for the cattle and rustle added hog and sheep quarters. Thirteen cars of stock arrived this afternoon. Judging in practically every department will begin tomorrow and the racing programme also will begin. The latter will include the 2:24 trot in which there are 10 entries and the 2:17 pace, which will be a royal battle, there being 20 horses entered. The event was Tuesday has been designated as Grays Harbor and Willapa Harbor day.

Today was exhibitors' day and all day long and late into the night those in charge worked hard to complete their jobs so that tomorrow all will be in readiness. Record crowds are expected during the week. Viceroy sent word that on Thursday, which is governor's day, as well as Elks', Kiwanis and Rotary day, all business houses would be closed. Seattle and Tacoma promise large crowds Wednesday, which is also Portland day. On Friday, which is Chehalis and Centralia day, business will be closed in the afternoon. MURDER STILL MYSTERY

INQUEST FAILS TO CLEAR UP COLUMBIA RIVER CRIME.

Physicians Reveal at Pendleton Probe That Neck of Victim Had Not Been Broken.

TOOZE GUGGELS PIERCE

COURSE OF DEMOCRATIC CANDIDATE DENOUNCED.

Republican State Chairman at Pendleton Meeting Makes Plea for Party Solidarity.

PENDLETON, Ore., Aug. 28.—(Special.)—Walter L. Toozé Jr., republican state chairman, arrived in Pendleton today from Walla Walla county, where yesterday he met the leading republicans of that section. Mr. Toozé is in Pendleton not only to meet the Umatilla county central committee, but also to hold one of a series of conferences with state leaders. The congressional committee for the second district will be organized tomorrow, the first time it has been organized in years. Luke, a member of the committee, will call a meeting of all republican state representatives and hold-over senators from the second district will be held.

Mr. Toozé took occasion today to comment on the recent Scio speech of Mr. Pierce, democratic candidate for governor. In his Scio speech Mr. Pierce said: "Shame on you, Walter Toozé, for going about over the state trying to arouse party feeling when the farmers are trying to find some relief from the condition that confronts them."

"Just what I would like to know," is a party chairman for?" Mr. Toozé asked. "The very fact that there has been so little party feeling in this state, thereby enabling every candidate for public office to make his own platform and be responsible to nobody but himself, is more to blame for the conditions that Mr. Pierce complains of than any other thing. If I can succeed in arousing enough party feeling to create a cohesive organization that will stand for principles and be responsible for their enactment into law, I believe I will have accomplished more for the welfare of Oregon than all the demagogic ravings of candidates for office will ever accomplish."

"Political parties are absolutely necessary, and if they are to function as they ought to function there must be party solidarity and party responsibility. In unity there is strength, and in organization victory."
