

### FRANCE ASKS RULE OF TURTLE FINANCE

#### Complete Control of All Dealings Proposed.

### BARTHOU SUBMITS PLAN

#### Ability to Place Country in Position to Meet Reparations Is Claimed for Proposal.

PARIS, Oct. 20.—(By the Associated Press.)—Complete and rigid control of all German finances, power to veto expenditures and regulate taxation and authority to dictate the arrangement of the budgets of the various German states among the chief proposals contained in the plan of the French government for a solution of Germany's financial difficulties and for placing that country in a position to meet her reparations payments.

The plan was submitted to the reparations commission tonight by Louis Barthou, the French representative on the commission and discussion of the project will begin tomorrow. Although not mentioned in the official summary, M. Barthou's plan contemplates a meeting of the leading business men of the world to determine Germany's capacity to pay and to consider the question of inter-allied debts.

**Plan Is Reply to British.**  
The plan, in effect, is a reply to the British reparations project recently placed before the commission by Sir John Bradbury. It differs radically from the British point of view. M. Barthou urges the calling of a Brussels conference to deal with a broad reparations settlement and allied debts and the question of German payments in 1923 and 1924. France would limit the powers of the reparations commission to the application of new guarantees and reforms for Germany, leaving the more comprehensive issues to an international meeting.

The proposition would gradually put Germany on a gold basis, beginning with an issue of gold treasury securities. M. Barthou would have Germany pay her outstanding obligations in paper currency, and he calculates that then Germany's paper circulation would be 510,000,000 marks, which at the present rate of exchange is worth less than the reichbank gold reserve.

**Energetic Steps Needed.**  
The moment has come, according to M. Barthou, when the allies must take energetic steps or else be faced by a Germany proclaimed before the world as a ruined nation, despite the fact that her actual capital is intact.

"We don't accept the contention that Germany is totally incapable of paying," said M. Barthou in his plan. "Despite Germany's enormous budget difficulties, she retains tremendous riches and has great strength to continue production and maintain her national vitality."  
The French plan would so interpret the theory of prohibition of interference in Germany's internal affairs as to permit this radical control of German finances.

The budgets of the various German states would be supervised thoroughly to prevent extravagances, regulate expenditures and make provisions for indemnity payments. A committee would be permanently established in Berlin and would have charge of the carrying out of all new reforms. In case Germany should refuse immediately to observe the new conditions she would be declared involuntary default by the commission under the provisions of the treaty of Versailles.

### MARTHUR LAUDS PARTY

#### ECONOMIES IN SPENDING ARE CITED.

Public Debt Declared Reduced by \$1,014,068,844 During the First Year in Power.

Representative McArthur last night addressed a large republican rally at Siuslaw, and reviewed the work of the present congress and pointed to the large reductions that have been made in the operating cost of the government under republican rule. He said in part: "When the republican administration came into office the public debt amounted to \$2,577,450,322. On June 30, 1922, it was \$2,566,381,708—a reduction in the public debt of \$10,068,614 during the first year of the republican administration. "The public expenditures for the fiscal year ended June 30, 1922, were \$2,375,870,499. This is \$124,579,823 less than the public expenditures for the fiscal year ended June 30, 1921, and \$3,036,735,944 less than the public expenditures for the fiscal year ended June 30, 1920."
