

OREGON TO DEMAND TUBERCULAR CARE

Fight Will Be Made for Hospital Facilities.

CONFERENCE AGREED ON

Oregon Congressmen to Join Citizens in Effort to Get Treatment for Veterans.

Oregon will make a determined fight to have a hospital for the care of tubercular ex-service men established in this state, as well as the purchase by the government of the Hahnemann hospital in Portland, situated for the care of general patients.

Members of Oregon's congressional delegation now in the state will be invited to meet with the city council and a large group of veterans and citizens who are interested in bringing success to plans agreed upon yesterday after a long conference in the city council chambers. The time of the proposed conference will be left to the convenience of the Oregon senators and representatives.

Permit Held Requisite.

J. J. Crossley, commander of the Portland post of the American Legion, and George E. Sandy, commander of Over the Top post, Veterans of Foreign Wars, urged action by the council to permit treatment of tubercular patients at the Hahnemann hospital, both said they had information to the effect that the government would not purchase the Hahnemann hospital unless this permission was granted.

Campaign Is Urged.

Miss Viola Orschold, who has devoted much time in the interest of disabled war veterans, held that it was shameful that a city and state that did as much during the war as did Oregon and Portland, must beg for the care of its disabled veterans. She urged a campaign to obtain the purchase of Hahnemann hospital and an energetic campaign to procure the establishment of a tubercular hospital for Oregon disabled veterans with opportunities for vocational training.

Boys' Welfare Paramount.

The welfare of the disabled ex-service boys should be considered above everything else, according to the views of Mrs. George Williams, another prominent war and post-war worker.

Congressional Action Wanted.

George Mason, who appeared as a representative of the Rotary club, said he had talked to Colonel Forbes recently in the east and that Colonel Forbes said the government had but little money remaining for acquisition and for that reason it was desired to centralize the care of veterans at the Hahnemann hospital.

Query Sent to Forbes.

Bureau Head Asked to State Policy Regarding Hospital Here.

United States Senators McNary and Stanfield of Oregon yesterday sent an outline of the controversy which has arisen over the use of Hahnemann hospital for the care of tubercular patients to Colonel Forbes, head of the veterans' bureau. A definite statement as to his policy was requested in the message which read as follows:

Two modern establishments immediately adjoining the city, Portland has repeatedly urged you to purchase, lease or establish a suitable hospital in the vicinity of this city for tubercular veterans.

LEGION BACKS UP BONUS COMMISSION

Discharge of Deschutes Appraisers Held Justified.

COMMITTEE REPORT OUT

Prompt Action by State Body Declared Beneficial to All World War Veterans.

Unstinted approval of the action of the world war veterans' state aid commission in the recent removal from office of H. J. Overturf and O. B. Hardy, appraisers for Deschutes county, charged with malfeasance, was voiced by the special committee of investigation named by the American legion, whose members have returned from Bend after complete and exhaustive inquiry.

"We believe that the commission is to be commended for its diligence and vigilance," read the report submitted by the committee by H. J. Warner, chairman. "It is our opinion that the commission has rendered the public, and particularly

the veterans of the world war, a distinct service by its prompt investigation and decisive action." Announcement of the removal of the two appraisers was made on October 2, following a session of the commission at Salem, and subsequently led to the publication by the commission of a statement revealing the evidence upon which its members acted. Inspired by Overturf there was then in circulation a report that the dismissal of the appraisers was a political move on the part of Governor Olcott, who is chairman of the commission. Other members are Secretary of State Kosor, Adjutant-General White, Arthur C. Spencer and Lyman G. Rice.

A specific instance of the sort of malfeasance with which Overturf was charged concerned a false affidavit made by an ex-service man, who declared that the appraiser persuaded him to swear that the value of the property was \$1900, whereas he was to pay \$2200. The reason for such distortion, it was advanced, was that Overturf desired to procure the maximum loan of \$3000. The property was owned by Overturf. It was also declared by the commission that in other instances the appraiser had been guilty of padding his findings, for purposes of his own.

So prevalent was discussion of the case and so wild was rumor, that Fred E. Kiddie, vice-commander of the American Legion for Oregon, whose home is at Island City, named a special committee of inquiry. The committee report was self-explanatory and strongly indicated the position of the state aid commission. As forwarded to the Vice-Commander Kiddie, by Chairman Warner, it is as follows:
