Portland Business Men Meet
Head of Suzuki House.

COMMERCE IS KEYNOTE

Felicitations and Closer Trade
Relations Feature of Banquet
Given in Honor of Guest.

Though geographically separated by thousands of miles, in sentiment America and Japan were joined Monday night at a dinner tendered to I. Suzuki, head of the house of Suzuki & Co., and it was promised that commercially the relations would grow stronger.

The dinner was held in the Trolley room of the Hotel Benson and there were gathered men active in the financial, exporting, importing and general port affairs, as well as representatives of the municipality, to meet the guest of the evening, who will depart today for Vancouver, B. C., to embark for Kobe, ending a tour that the last few months had taken him to the principal cities of Europe and the United States.

Suzuki & Co.'s connections at Portland, the headquarters of the organization on the Pacific coast, are of such importance that the presence of the chief owner of the great Suzuki interests was made the occasion for Portland business men to meet him personally. He and his party arrived late Sunday, Mr. Suzuki was accorded opportunity Monday to look over the shipping sphere and speak of his impressions in complimentary fashion.

Decorations Are Profuse.
Save that a large American flag draped the wall in the rear of the head table, no emblems were displayed, but evergreen palms and cut flowers were profusely used. William D. Wheelwright acted as toastmaster. His visits to Japan, his personal acquaintance with leaders in the Suzuki company and knowledge of Japanese customs fitted him for the responsibilities. He spoke of having been the recipient of Japanese hospitality and before calling on Y. Nakagawa, manager of the Portland staff of Suzuki & Co., asked that a silent toast be given to Madame Suzuki, reputed wealthiest woman in the Orient. The guest of the evening is the eldest of her family. Mr. Nakagawa expressed his appreciation of consideration and hospitality displayed by Portlanders from the time the company had established an office here.

"It is our wish to aid in the western and advancement of Portland, and while once we went to Seattle, we came back here and it was not like a new business to us, but as if returning among old friends," he said.

Mr. Wheelwright said that in talking with Mr. Suzuki he had been informed that Tokyo, which boasted a population of 6,000,000, contemplated extending its limits and that would increase the number of inhabitants to 9,000,000. He added that he knew of only one other city that could possibly grow like that, it being Portland.

Mr. Bigelow Represents City.
City Commissioner Bigelow, representing the city in the absence of Mayor Baker, presented the latter's regrets. He spoke of the importance with which the affairs of the company were regarded in Portland and said he hoped advantage would be taken of the commercial relations maintained through the company.

Y. Takeda, Japanese consul, said in all dealings Suzuki & Co. have invariably stood for what was stable in business, so has built a reputation for the institution that was not only profitable but a credit to Japan.

Harry L. Hudson, manager of the joint port traffic bureau, told of the start of Suzuki's affairs dating from a time when the father of the family was a small sugar merchant. On his death Madame Suzuki undertook to expand the business, taking initial steps that paved the way for the strength and wealth of today.

He enumerated 26 companies the Suzuki interests controlled in Japan, their agencies and representatives in Europe, North and South America, Australia, Java, the Philippines and the entire Orient, and said that of the 29 steamers in the Suzuki fleet to visit the northwest last year 46 had landed at Portland or in the Columbia river. He said for 11 months of 1922 was fixed at 81 steamers, 39 of which had landed in this district. He said the company first established a Portland office in 1912 and that it was transferred to Seattle in 1916, but in January, 1921, the headquarters was moved back to this city.

M. A. Kashiwa, general manager for the company in America, in personal charge of the New York establishment, who conducted the Portland office in 1912, said he wished to thank Portland business men for having assisted him on the occasion of his coming to this city, for they helped to educate him; taught him how to deal in wheat, flour, lumber and other commodities, and that in late years they had displayed the same consideration and interest for his successors.

Portland Second Home.
J. W. Gannon of Kerr, Gifford & Co., told of visits to Japan and his meeting there on later trips with representatives of Suzuki & Co., while he had enjoyed intimate association with those having in charge the Portland office.

Mr. Suzuki spoke in Japanese, though Mr. Wheelwright said he had been conversing with him in most excellent English. His remarks were translated by H. S. Tada of the Portland office, and were to the effect he had been decidedly limited in time for his journey, and should have proceeded direct to Vancouver, but had always cherished wish to revisit Portland.

Company Here to Remain.
"It was in this city ten years ago that Suzuki & Co. was really born, and while we went to Seattle, we came back and here to stay," he said. "America is a country of wonderful resources and great wealth. It is daily turning out products that Japan needs in the way of food and materials, while America is a patron of Japan, with its great silk production and other things to ship, so business relations should continue to prosper. I visited your mills, your wonderful docks and your elevators this morning. I was amazed on being shown how you are

spending money to make this port the biggest on the Pacific coast. "We rejoiced in Tokyo at news that you were to celebrate your advancement with a world's fair and we awaited news of the election as to support for it, only to learn that it was not carried out. Now I am informed of the decision of leading citizens to make it a success. I am glad to learn that and on going home I will urge our manufacturers and others to aid in its exhibition."

Then there was a toast to the "health and prosperity of Portland and the friends of Suzuki & Co." Wallace McCannan expressed the gratification of guests for the opportunity afforded to meet the travelers and those identified with the American affairs of the house.

NEGROES' PLEAS REFUSED

TWO OPIUM SMOKERS SENT TO ROCKPILE.

Suspended Sentence Denied Pair Found in Room With 22-Year-Old White Girl.

"Suspend our sentences, judge; we're only victims of circumstance; we've never had a chance," pleaded "Baby Joe" Chambers and Albert Ballard, negroes, in municipal court Monday.

"If this thing had happened in the south," Judge Eckwall told the pair, "you would have been suspended all right—to a tree."

The pair were arrested early Sunday at 657 1/2 First street on a charge of using opium, and in the room with them was found 22-year-old Elizabeth Wright, a white girl. All insisted that she had entered the room in search of a girl friend and had stopped to smoke the dream pipe.

"She just came in without asking us," Chambers said, "and we couldn't throw her out."

"Next time a white girl comes into your room try throwing her out. You'll be better off."

Their pleas for a suspended sentence seemed to have made some impression on the judge, when Deputy City Stadler recalled that Chambers had been given a suspended sentence of six months in October on condition that he leave town.

"And why didn't you leave?" he was asked.

"Well, judge, didn't say when I was to leave, so I took my time. I was getting ready to go just when these officers came in my room."

Both Chambers and Ballard were sent to the rockpile for six months. The girl was let off with a lecture. Six other negroes arrested in the hotel were released on condition that they leave town at once.

FIRE FRIGHTENS CHINESE

Burning of Strip From Bedquilt Causes Excitement.

Excitement prevailed in Old Chinatown Monday night when a strip six inches wide and two feet long was burned from a bedquilt in the store of the late Sue Kay Lang, 31 Second street.

Chinese were hugging their stoves when acid smoke began filtering through the fireproof door of the building. The street was deserted. A moment later half a dozen were racing toward police headquarters shouting, at the top of their voices, "Fire! Fire!"

Members of engine company No. 1 found a beehive after half a block run. Firemen forced their way through the throng and located the burning quilt on a balcony in the store. It was thrown to the street.

TRIAL FAIR PLAN FRAMED

PROJECT TO BE DISCUSSED THURSDAY NIGHT.

Exploitation of Caves, Crater Lake, Highway, Round-up and Beaches Is Aim.

A committee representing the various civic clubs of Portland will meet Thursday night at the Benson hotel to discuss plans for the proposed Old Oregon Trail exposition, which it has been suggested, should replace the old idea for a 1927 world's exposition. The old exposition committee will meet with members of the new committee and also make a report.

A subcommittee representing the new exposition committee offered the trail exposition proposal at a meeting some time ago with leaders of the old exposition committee. The latter group, an organization, will give way for the new committee to proceed with its plans. The chairman of this subcommittee is William P. Merry, originator of the plan to hold an Old Oregon Trail exposition.

The expressed purpose is to advertise Crater Lake, the Columbia River highway, the Oregon caves, the Pendleton Round-up and the Oregon beaches.

1927 FAIR IS TO BE HELD

Filing of Articles of Incorporation Is Authorized.

Original plans of the Hydro-Electric league for a world's electrical, industrial and highway exposition in Portland in 1927 were reaffirmed and the secretary instructed to file articles of incorporation with the secretary of state at the meeting of the league's executive committee Monday. It is proposed to finance the exposition by sale of a \$5,000,000 issue of capital stock.

The league is the organization which originally sponsored the exposition, said a statement issued by a publicity committee composed of Eugene E. Smith, John C. Boyer and George L. Cleaver. "The committee which have been promoting the exposition were appointed by and under authority of the league, which has never given up its position of sponsorship."

"The exposition as now proposed is to be dominantly electrical, featuring the great electrical discoveries of our time, and the opening of Oregon's water power and irrigation projects. It is expected that the immense hydro-electric projects on the Deschutes, upper Clackamas and Lewis rivers will be completed

and in commercial use by the time the exposition opens."

It is also planned to feature the Pendleton Round-up, union stockyard show and scenic attractions of the state.

"Whereas, a committee has been appointed by the Hydro-Electric league to file the articles of incorporation and call a meeting of the incorporators and make public the fact that this is to be an electrical exposition, devoted to the exploiting of the potential electrical possibilities, showing the equitable climate, the proximity of iron and other ores, the possibilities of the growth of the linen industry, and the numerous opportunities for tremendous development of the hydro-electric possibilities of this grand state, coupled with the celebration of the completion of the Old Oregon Trail, the further development of the Roosevelt highway and the completion of the north and south highway and the Pacific and The Dallas-California highways."

Third Recital Given by Chamber Music Trio.

Delightful Numbers Played With Subtlety and Charm.

THE Chamber Music Trio—Suzie Pennell Pipes, violin; Ferdinand Konrad, cello; J. Hutchinson, piano—gave the third recital of its series this season at the Woman's club auditorium Monday night.

The first number, "Brahms' C Minor Trio, Opus 101" was beautifully played. The Prelude, a movement of soft tonal texture, seemed to be particularly enjoyed. The Andante gave the cello a fine opportunity in the first few measures—a flowing melody which Mr. Konrad played with great depth of tone. In this movement, too, there was a lovely antiphony between the parts.

Friedrich Smetana's Trio in G Minor (Opus 13) is music of a foreign accent, distinctly novel in the treatment of its themes, and often whimsical. Smetana's name means "thunder" or "storm" in Czech. This particular trio is concerned, might indeed be tinged with this sweet, half-pungent flavor. But with all its charming trifling there are some noble moments in the trio, noble 20 bars or so, for instance, in the allegro, where the piano carries the theme, and again in the prelude. It was played with splendid dash and crisp accent.

Cecile Chaminade's delightful Trio in A-Minor (Opus 34) was played with subtlety and charm. Some music it is, and the three players made the parts flow like a tri-colored ribbon, so suavely and with beautiful tone throughout.

The work of the Chamber Music trio presents in all that they play an unusual musical blend, which comes either by frequent practice together or by monotonous familiarity. This lends charm to their work. Miss Pipes achieved lovely tone in the opening of the Smetana trio, and Mr. Hutchinson's piano was always interesting and provocative in phrasing and luscious in tone.

The audience was a very enthusiastic one, and the trio was granted no encores there were many recalls.

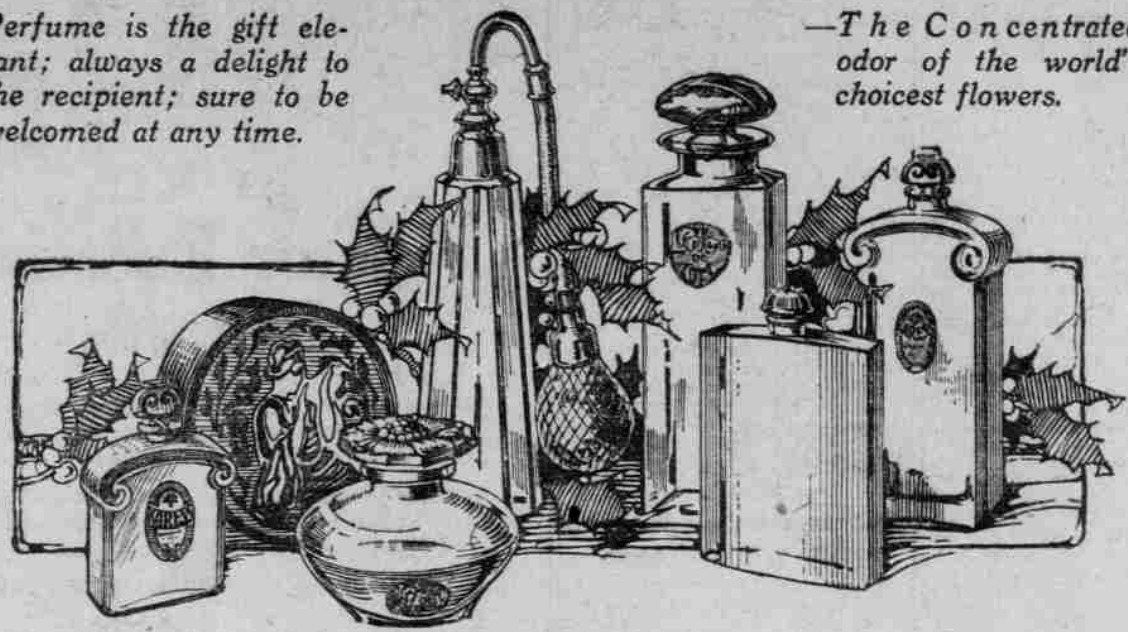
