

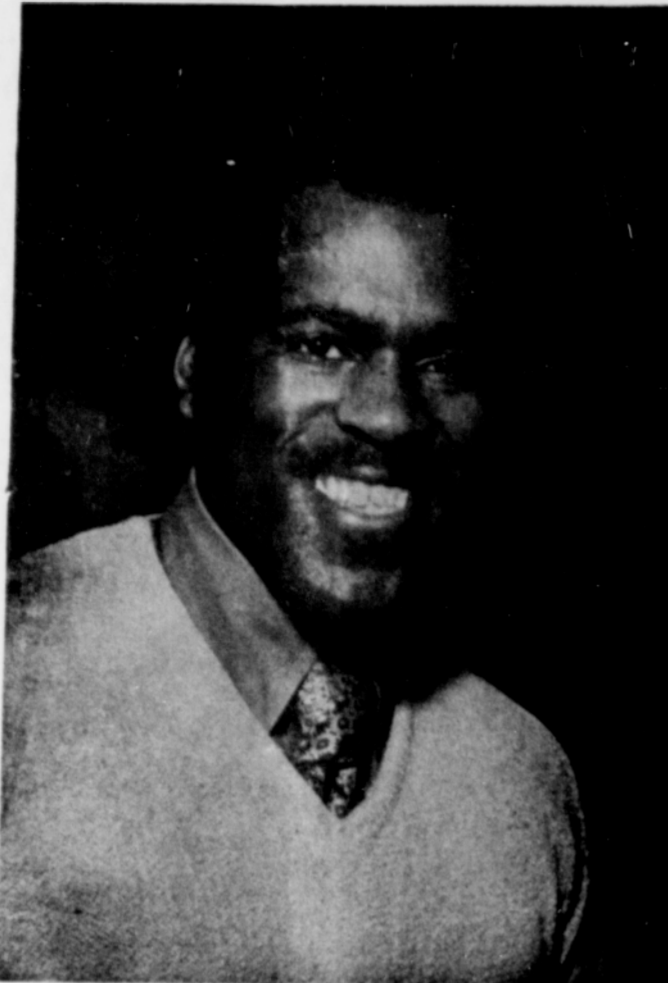
Black coach leads PSU

Ronald James Stratten, recently appointed head football coach at Portland State University spoke at the Cosmopolitan Motor Hotel, at a luncheon sponsored by the Top of the Cosmos Club. Coach Stratten emphasized the importance of athletics in building character and psychological and physical fitness. Stratten said that athletics affords the "individual the opportunity to strive for both personal and team success and that the realization that unselfish efforts are rewarded with the knowledge that one's best possible effort was expended is what should be sought by the athlete." He added that the "chance to compete for excellence in performance outside of merely seeking monetary rewards or personal recognition is paramount in the football program at PSU."

Coach Stratten was born in San Francisco and attended college at the University of Oregon, San Francisco State and Cal State. At the University of Oregon, he lettered in varsity football for two consecutive years. He was also appointed as defensive line coach for the University of Oregon from 1968 to 1971.

Coach Stratten said the prospects for PSU's football team are good for the coming year; that he had an exceptionally good offensive team—but not as much depth in the defensive positions. Stratten introduced to the Cosmos Club Daryl Bean, a young Black halfback from Hanzen High School in Renton, Washington, who was an all-stater and one of the outstanding football players in the Puget Sound area last year. Young Bean will be the only freshman in the starting line-up. Coach Ron Stratten's team makes its debut Saturday, September 16, against the University of Hawaii. The game starts at 7:30 p.m.

institution for rehabilitation. The result is that she was raped while in federal custody, and the fact that an order has been issued for her return to an institution where that occurred shows that it is our penal system which is in need of rehabilitation and not Cheryl James."

Sue Sherry, one of Cheryl's teachers at Jefferson High School presented a petition signed by her teachers at Jefferson and Adams High Schools.

The committee expressed appreciation for the support of money concerned persons and organizations have donated which has made Cheryl's freedom, thus far, possible.

The news of Cheryl's imminent return to prison was announced at a press conference held September 13th by the Cheryl James Fund Committee. The press conference was attended by a large number of concerned citizens including members of the clergy, teachers and representatives of community organizations.

Morse explains differences

Former Senator Wayne Morse briefly outlined the major differences between himself and Senator Mark Hatfield in response to a question asked Friday evening during a debate between himself and Dr. Richard Jones, Professor of History at Reed College, who represented Hatfield.

Speaking before 200 members of Common Cause attending the Candidate's Fair at the First Unitarian Church, Morse said, "I am first and foremost a Constitutionalist, and I cannot vote for legislation which, under the name of 'law and order,' seriously infringes on civil liberties provided by the 4th amendment. Senator Hatfield voted for the 'no-knock' and wiretapping provisions of the Omnibus Crime Bill in 1968 which in my judgment runs counter to the unreasonable search and seizure protection of the amendment. I did not. Nor would I have voted for a bill which provides for

arrest without reasonable cause or preventive detention," Morse continued, "but Hatfield did in 1970." "You would never have found me voting for applying compulsory arbitration in the settlement of any labor dispute," Morse said. "This denies to both labor and management their most basic

economic right of freely determining how they are to use their labor and material. But Hatfield did in regard to the Longshoremen's strike." "You cannot vote for the appropriations to continue the war in Vietnam and truly be opposed to it," Morse stated. "But Hatfield voted for many supplemental appropriations

that have allowed this war to continue." "I believe Congress must exercise its Constitutional check of the purse strings to give the Administration notice it has 9 to 12 months in which to end the war," Morse said. "And this is what I did in voting against those appropriations."

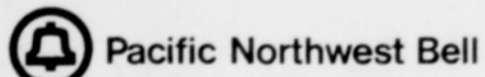

cies, this Act has tremendously hampered our political activities.

3. Resolution on Portland City Council.

WHEREAS, there is no Black on the Portland City Council and Blacks are not properly represented; and

WHEREAS, several Black community organizations have Blacks that they want placed on the City Council.

NOW, THEREFORE, BE IT RESOLVED that the Oregon Black Political Convention calls for a community convention which will allow Black people to select one Black person whom they endorse to be recommended to the Portland City Council to fill the forthcoming vacant seat.

4. Resolution on White Businesses.

WHEREAS, the white businesses in the Black community in Oregon have not been responsive to the needs, aspirations and desire of the Black people; and

WHEREAS, the white businesses in the Black community have historically refused re-investing part of their profit in the community; and

WHEREAS, the white businesses in the Black community have constantly refused to hire a representative number of Black people in relation to the Black trade; and

WHEREAS, the white businesses have constantly refused to advertise in the Black newspapers,

NOW, THEREFORE, BE IT RESOLVED that the Oregon Black Political Convention is-

sues an official statement in support of Black people, Black newspapers and the Black community; and informs the white businesses that the Black people in Portland will use all means at their disposal to eradicate all those injustices launched against us.

5. Resolution on Walnut Park and Follies Theaters. BE IT RESOLVED that the Black Political Convention pledges its full support to Meridian for Humanity, Inc., to assist in ridding the Black community of the Walnut Park and Follies Theaters. The type of entertainment shown at those theaters is insulting to the Black community and has dehumanizing and immoral effects on both the old and young.

Now that the Oregon Black Agenda has been presented to the public ALL Blacks in the state must first read it. Second, we must see what we as individuals can do to insure that ALL of the platforms are implemented. In other words, we must work individually, as well as collectively, to see that the platforms are fulfilled. Third, we must support, not only the Oregon Black Caucus, but also the NAACP, the Urban League, Black Panther Party, civic and community organizations, etc. because all are working to eradicate the social evils in this racist society. Fourth, we must always recognize the fact that Blacks must unite and organize. Fifth, we must realize that no Black is free from racism in the United States UNTIL ALL BLACKS ARE FREE!!
