Notice is hereby given that the City of Portland has filed a grant application with the Department of Labor for federal manpower funds available under the Comprehensive Employment and Training Act (CETA) of 1973, Title I. The grant application was prepared by the Division of Manpower Planning and Administration, Carl E. Simington, Director.

Programs funded by previous manpower legislation will complete servicing under contracts now in effect; therefore, most CETA activities, under Title I of the Act, will be performed and reported during the last two quarters of the fiscal year (July 1, 1974 to June 30, 1975). Approximately 1,280 economically disadvantaged persons will be served during this time period. An estimated 507 persons will complete the program by June 30, 1975. Of those completing, 365 participants will be placed in unsubsidized, permanent employment and 107 persons (primarily youth) will return to school or enroll in additional non-CETA training or activity. Thus, ninety-three percent of those completing the CETA program will receive attention under CETA as follows: Black, 409; Chicano, 286; American Indian, 286; other minorities, 180; Vietnam-era veterans, 255; youth, 189; older workers, 144; and ex-offenders, 64.

Anticipated expenditures by cost categories will be: Administration - \$343,000: Allowances - \$52,000: Client wages - \$989,000: Fringe benefits - \$167,000: Training -\$195,000: and Services to clients - \$411,000; for an estimated FY 75 total of \$2,157,000. An additional \$1,527,000 has been obligated for the forthcoming fiscal year; thus, the grand total will be \$3,684,000.

Estimated costs of the manpower system components for FY 75 will be: Intake, Orientation and Assessment -\$230,000; Pre-vocational training - \$630,000; Job Development - \$65,000; Job Placement - \$64,000; Management Information System - \$52,000; Youth Manpower System -\$450,000; Older Workers Employment Program - \$450,000; and CETA Administration - \$216,000.
