The winner is Mrs. Katie Ball Moore of Vancouver Avenue First Baptist Church. She was crowned by last year's "Grandmother", Mrs. Randolph of Mt. Olivet Baptist Church. Mrs. Moore won the honor by raising \$415. for the NAACP Fight for Freedom Drive.

be...the ceding of national sovereignty to international entities which alone will be able to make and monitor the necessary decisions concerning world allocation and control of populations, food, non-renewable resources, oceans and the like.

"This is a most unattractive environment for responsible elected officials.

"Congressional difficulties in accepting such sacrifices will be severe."

Simply put, the 'Murphy Commission' sees democratic procedures as inefficient - democratically elected officials would be reluctant to impose on their constituents the austerity required of them. Rhodes commented that it is of interest to look at the members and consultants of Murphy Commission, and other planning bodies: Peter Szanton (RAND Corporation); Robert Murphy (OSS agent; U.S. representative to the Nazi puppet Vichy

government); Robert Bowie (former head of the Rockefeller Foundation); David Abshire (member of David Rockefeller's Trilateral Commission); Morton Halperin (National Security Council advisor to Henry Kissinger); Ray Cline (ex-deputy director of Intelligence, CIA); Nelson Rockefeller, et al.

Who Does It Benefit?

Rusty Rhodes said that key to investigating assassination and terrorism is to ask the question 'who does it benefit?' "That question I haven't fully resolved yet," Rhodes said, "except the short-run expansion of federal police agencies like the LEAA, which terrorizes Los Angeles through the programs it funds." One thing especially concerns Rusty Rhodes - President Ford's protection from assassination, "because after Ford comes Rockefeller."

Women support Soviet Jews

One hundred women, Protestant, Catholic and Jew, representing some 17 different organizations, unanimously adopted the following resolution that the first Women's Plea for Soviet Jewry to be held in Portland, Oregon.

A DECLARATION December 10th, 1975

"As women representing Protestant, Catholic and Jewish women's organizations, we have assembled today to dramatize our solidarity with the struggle for human dignity by Soviet Jews.

We pay tribute to those courageous Jewish people who have foregone anonymity and safety to openly petition for the right to live freely as Jews in the country of their choice.

We are united in this effort to express our solidarity with our sisters in the Soviet Union, who daily risk harassment and arrest for their commitment to live as Jews, and transmit their Jewish heritage to their children.

We deplore the plight of those who have been deprived of their freedom and sentenced to harsh terms in prison.

We pledge our support to these prisoners of conscience and their loved ones.

We dedicate ourselves to these women of valor - armed with strength and dignity and declare our commitment to work on their behalf and on behalf of their families until full human rights are granted to all.

We urge all the citizens of Portland to familiarize themselves with the situation in a foreign country that threatens human rights everywhere on earth, and to give full and conscientious backing to the effort on behalf of Soviet Jews being made by men and women of good will and conscience throughout America."

Statements were read by Sally Weaver, the wife of 4th District Congressman, James Weaver, and Pat Straub, wife of Governor Bob Straub. Mrs. Weaver's comments stressed the writing of Shalom Aleichem and underscored the feeling of personal freedom that all persons should be able to enjoy.

In her statement, Mrs. Straub stressed that the oppression of Soviet Jews is not just a Jewish problem. She noted that "It is our responsibility to continue to communicate to the Soviet Government that in the best American tradition, we seek an end to all discrimination and that our commitment to support the right of emigration is steadfast."
