Wayne Morse house opens

Friends and admirers of the late Senator Wayne L. Morse are invited to the former Morse ranch, which will be dedicated Sunday, July 29th, at 10:00 a.m. as the Wayne Morse Historical Park, Jack Travis of Sandy announced this week. Travis, a long-time friend of the Senator, is President of the non-profit corporation organized to promote the historical significance of the ranch as a living tribute to Morse. The City of Eugene manages the park as a whole.

Prior to the dedication ceremonies a coffee hour will be held on the grounds beginning at 9:00 a.m. Mrs. Mildred Morse of Washington, D.C. will be present with her daughter Nancy Morse Campbell of Eugene, to greet old friends and meet new ones. Everyone taking part in the dedication was a personal friend of Senator Morse.

Ex-Governor Robert Straub, a political friend of Morse, will give the principal speech, with short remarks by Juli Johnson and David McTeague, former President of the Young Democrats. Monroe Sweetland will introduce Straub.

Federal, State and City of Eugene money was used in purchasing the 26 acres on Crest Drive in Eugene. Mrs. Morse donated the house to the City of Eugene.

The committee arranging the dedication is headed by Dorothy Leeper with assistance from Louise Beaudreau, Corvallis; George Alverque, Eugene; and Wanda Pengra of Springfield. Jim Klonoski, State Democratic Chairman, has invited all attending the dedication to take part in the 5th annual Wayne Morse summer picnic at Jasper Park, 15 miles from the Morse Park, beginning at 12:30 p.m.

NOTICE OF MODIFICATION OF DEADLINE DATE FOR RECEIPT OF PROPOSALS UNDER NOTIFICATION OF FUND AVAILABILITY OR16-0036

The Department of Housing and Urban Development will accept Preliminary Proposals for newly constructed or substantially rehabilitated housing units under the Section 8 Housing Assistance Payments Program, to be located in Eugene SMSA (All of Lane County).

Proposals may be submitted by private owners of Public Housing Agency (PHA) Owners for direct contracting with HUD, or by PHAs on behalf of Owners with whom the PHA proposes to contract pursuant to an Annual Contributions Contract with HUD.

Contract authority in the amount of \$528,000 and a special allocation to meet the Areawide Housing Opportunity Plan of \$301,000 are being made available to provide assistance for an estimated 215 units. The assistance to be provided for the various household types is estimated to be 21 units for the elderly and handicapped with contract authority of \$73,584; 27 units for large families (3 or more bedrooms) with contract authority of \$121,500; and 167 units for other families with contract authority of \$633,916.

Proposals must be received by 4:00 p.m., on August 16, 1979. This deadline may be shortened or extended by HUD. In such case HUD will notify all parties who have previously registered with the field office requesting such notification. Approvable applications received prior to initial deadline date will receive priority in funding.

Submission deadlines shall not apply to Proposals for projects in which the number of assisted units shall be limited to 20 percent or less of the dwelling units. However, such proposals received after the deadline will be reviewed only if sufficient contract authority remains from this Notification to fund the proposal.
