When I walked through the security gate, she was sitting on a blue setee clutching a locker key and occasionally straightening the change so evenly arranged on a formica table. It had been five years since I had seen her, longer yet since, in a fit of anger, she had told me where all bad children go. I remembered the fury in her eyes, the clenched fists, and the belts, hair brushes, and shoes, still warm from contacting my bottom side. The fury is gone now, replaced by a deep hurt, but the fists are still clenched, sweating and holding dearly to that key.

I hugged her, called her mom, and felt the dampness of a tear on my cheek. Taking the key from her hand, I noticed its number, fifty-four, the year of my birth, and returned it to her fingers, the look in her face telling me how much the irony meant to her, how hurt she was to be here. I hurt too, but I could not match the pain in her face.

Didn't she know of the grandfather clock, the green plants and colonial wooden entrance signs that cheered our movements from destination to destination? At her first words, solemn utterances of contempt, it was obvious she was not impressed. The back of her mind tained steel gates, uniforms, nine hours of freeway, and a question for me--why? Why had I hurt her so? And I'm prepared to explain how three hot meals a day, recreation and twice a week movies hurt, but I don't

Last time I hurt, lying in a hospital bed with thirty stitches in my abdomen, a journey to Reno kept ner from my side. When I needed a friend and sent her plane tickets from Atlanta, she had to work; I made the best of my need with an acquaintance. And now, separated by a small formica table, locked behind steel doors, and restricted by five pages of regulations, I need not explain what hurt is.

I thought about her yesterday while walking the track, the red cinder clinging to my shoes, and an old con resassuring me the world did not end with a prison sentence. Conversation drifted to a dialogue on mothers. Moms can put up with a lot, he said; fathers, friends, lovers and brothers are quick to desert an imprisoned one. But, regardless of the guilt she carries for me on her

shoulders, no matter the intensity of her son's hate, violence and crimes, Mother is the last person to abandon a son. When she doess, the old con explains, a guy has no one to blame, no one but himself--he has gone too far, messed up one too many times. He was so right. There in the visiting room, on a blue settee, sat Mom; all I had left.

Atlanta signs consent decree

The Community Relations Service (CRS) of the Department of Justice has obtained a negotiated settlement of civil suits charging the Atlanta, Georgia, Department of Public Safety (DPS) with racial discrimination.

CRS Director Gilbert G. Pompa said the agreement, which formed the basis for a consent decree, was won in negotiations involving representatives of the Afro-American Patrolmen's League, Fraternal Order of Police (FOP), and the city.

The settlement ends a seven-yearold dispute. The league sued the city in 1973, alleging discrimination against Blacks in hiring and promotion pratices. The FOP countered with a suit alleging reverse discrimination.

While the city expressly denies the allegations of discrimination, it has agreed to a number of actions, including the following:

--Black applicants rejected for entry-level positions in DPS's Bureau of Police between April, 1971, and December, 1974, may now reapply. If they pass the current selection process, they will be hired and awarded back pay.

--Certain white and Black officers who were demoted in late 1974 from the ranks of captain, lieutenant, and sergeant, and who are still with the Bureau of Police, may compete in a new promotion process to be developed by the city and an independent consultant.

A minimum of nine captains, 20 lieutenant, and 40 sergeant positions will be filled in this round of promotions.

The city also agreed to monitor constinuously its entry-level selection process to insure that racial discrimination does not occur. It is expected that the Bureau of Police will proceed to fill 200 officer positions that it is authorized.

Implementing the agreement will

cost the city \$370,000.


CRS was established by the Civil Rights Act of 1964 to help communities resolve racial and ethnic disputes. The agency conducts formal negotiations when the parties believe that it is a perferable way to seek settlement of their differences.
