NOTICE OF PUBLIC HEARING

Notice is hereby given that a public hearing will be held by the Tri-County Metropolitan Transportation District of Oregon (Tri-Met) at Portland State University, Smith Center, Room 328, 1805 S. W. Broadway, Portland, Oregon, at 10:30 a.m., June 9, 1980, for the purpose of considering a project for which financial assistance is being sought from the Urban Mass Transportation Administration, pursuant to the Urban Mass Transportation Act of 1964, as amended, to undertake final engineering specifications, construction, procurement, and acceptance testing of the transit elements of the Banfield Transitway Project, generally described as follows:

1. Construction of maintenance facility,
2. Purchase of approximately 26 light rail vehicles,
3. Land acquisition,
4. Construction of track system,
5. Construction of electrification, signalling, and communication systems,
6. Development of passenger stations,
7. Development of handicapped access facilities, and
8. Purchase of other miscellaneous equipment.

There will be significant environmental impacts of this project. These impacts and mitigation measures are detailed in the draft Final Environmental Impact Statement which is available for public inspection at the address listed below. The project is in conformance with and is a part of the Transportation Improvement Program of the Metropolitan Service District (METRO), and is in conformance with the comprehensive land use planning for the urban area. Persons, families, and businesses will be displaced by this project. The project is currently under review by the A-95 Clearinghouse.

The estimated cost of the project is approximately \$135,900,000. Federal participation will be approximately \$112,300,000; and the local share will be approximately \$23,600,000.

At the hearing Tri-Met will afford an opportunity for interested persons or agencies to be heard with respect to the social, economic, and environmental aspects of the project. Interested persons may submit oral or written evidence and recommendations with respect to the project.

A copy of the application for a federal grant for the project, together with a copy of the draft of the Final Environmental Impact Statement and the Five-Year Transit Development Program, are available for public inspection at the Tri-Met Light Rail Project office, 4012 S. E. 17th Avenue, Portland, Oregon, 97202.
