## Minit Market success

Raphael "Ray" Peterson and his wife Barbara have operated Barb's Stop-a-Minit Market for one year, but in that short time their store has caused a comeback for the corner of Killingsworth and Williams.

The store was a tavern before they moved in. Another tavern across the street is also closed. But when the taverns were open, the corner was a prime hangout for drug pushers and users, prostitutes and other nefarious people.

"You couldn't drive by here without getting flagged down," said Peterson, who lives in the neighborhood.

"I used to have a lot of people trying to come in here to buy weed," for a short time after the store opened," he said.

But the drug-trade and related problems have gone elsewhere, and the only people hanging out on the corner now are those waiting for the bus," said Peterson.

They couldn't get a liquor license at first, though, because of the corner's reputation.

"They said no one would ever get a liquor license on this corner again, so we just got some pop and candy and some chips and we proved to them that we could run a store here without any problems."

Business took off once they got the license, he said.

Things were really hopping at the store on a recent Saturday morning.

"Are you complaining about my prices?", he asked one customer. "That'll be 57 cents American money."

"Where's your hubby at?," he asked another. "Are you having coffee or

Barb's offers a unique food item -"chili fritos" - unavailable at any other store in Portland. It's corn chips smothered in homemade chili, a recipe Peterson brought with him from Los Angeles, where he grew up.

A carved wooden box on the counter offers single cigarettes for 10 cents each. "I haven't seen that since I was a kid," said a customer.

Peterson said business has improved steadily. He has been gradually able to expand the inventory from pop and chips to beer and wine, canned goods and household items.

He started out selling ice cream. Peterson's five ice cream wagons were known for their soul music. "They used to come out dancing to the truck," he said.

One of his brothers took over the ice cream business when Peterson branched out to open his first store on Williams near Going.

With what he was able to save with the ice cream business and his first store, he opened Barb's. It's a much better location, he said. "There's more foot traffic on Killingsworth than on almost any other street in the area."

His first store sponsored a women's softball team, and that's how he met his future wife, Barbara. She played left field on the team.

"The community supports the store," said Barbara. "I like it because it's something Ray and I put together with almost nothing and now it's doing pretty good."

Their plans include an expansion into the vacant storefront next door, where they'll have meat and fresh fruit and vegetables. "I still see us climbing up," said Barbara Peterson.

Among the discrepancies between the official police version and eyewitness accounts are the telephone calls to the police and the racial confrontation which drew in the gas station attendants. Sources close to Grassroot News said the 7-11 clerks detained the shoplifter for 35-45 minutes inside the store. "It was a long time before police came. They (police) said they were undergoing a shift

Apparently, there were two calls made to the police: one from inside the store and the other from the gas station attendant. Our sources said the attendant called the police and said an armed robbery was in progress

and he was going to get his '45. Sgt. Jay Decker, the police bureau's Public Information Officer, the Stevenson's attorney, and the shoplifter - Joe Nelson - have refused to discuss the case until the public inquest. But before we went to press, we learned the stolen item sparking the resulting tragedy was a bottle

FREEDOM News Journal's continuing investigation of the IRS has uncovered what appears to be a nationwide pattern of unconstitutional activities on the part of this agency, as reported to FREEDOM by current and former employees of the IRS across the country. In recent months, hundreds of responses to FREEDOM's request for information have been received, not only from IRS employees but also from American taxpayers who have been harassed and had their constitutional rights violated by this agency.

Information which has been reported by FREEDOM has included:

· IRS employees are often compelled to make a certain number of seizures of taxpayer property within a specified period of time or face adverse consequences from IRS

· A day care center in Detroit was raided by seven IRS agents, and 30 children were held as hostages in guarded rooms while the agents pressured parents to pay money to the IRS which should have gone to the day care

· Millions of law-abiding American taxpayers are on discriminatory and harassive IRS 'hit lists," according to former agents. Examples given to FREEDOM have included lists of members of certain religions and lists of people employed by direct sales companies such as Avon, Shaklee and Amway;

 In 1969, the IRS created a "national office task force" to act as "an intelligence gathering operation" for the purpose of investigating and establishing files on "Ideological Organizations." The chairman of this task force was to work in liaison with the Assistant Attorney General, Internal Security Division, Department of Justice, to "coordinate matters" with regard to the targeted organizations. Documents received by FREEDOM indicate that similar task forces may be in operation today; · Some IRS management personnel are generally more concerned with their bonuses, received by forcing their employees to meet unrealistically high quotas, than they are with honest treatment of taxpayers;

· The IRS directed its agents to go on what one former agent described as "fishing expeditions," auditing the books of such businesses as furriers, jewelers, antique shops, travel agencies and interior decorators to locate names of customers to be targeted for

FREEDOM, the independent journal published by the Church of Scientology®, is interested in interviewing anyone with information on illegal and discriminatory IRS policies and practices, or evidence of harassive and threatening measures taken by the IRS against taxpayers. FREEDOM is particularly interested in interviewing current or former IRS employees who have worked in the Criminal Investigation Division or who have knowledge of so-called "Special Task Forces" concerning specifically targeted groups.

The constitutional rights and basic freedoms of the citizens of the United States are being threatened and, in some cases, destroyed by this government agency. Reform is clearly needed, and FREEDOM can play a major part in bringing this about by reporting specific abuses to the public. By making this information broadly known, action can be taken to make the IRS an agency that truly services the people of this country.

If you have knowledge of unconstitutional acts or violations of the law committed by the IRS against taxpayers, groups or even IRS employees, and you feel it is time for these acts to be exposed, and our tax system overhauled and turned into an equitable one,
