

## Handicapped free zoo day

Handicapped persons and their escorts will be admitted free to the Washington Park Zoo on Handicapped Citizens Day, Tuesday, May 21, from 9:30 a.m. to 3 p.m. The free day is sponsored by the mobile telephone company, Cellular One.

The day will open at 9:30 with a concert by Pacer Fusion of Lake-ridge High School, and at 11:15, visitors will be entertained by the stage band from Pleasant Valley Intermediate School of Vancouver, Washington.

At noon there will be a basketball game featuring the Wheelblazers. Visitors willing to risk their ball-playing reputation in a hot game of basketball may join in. To ensure that rules of wheelchair basketball are strictly adhered to, referee for the event will be none other than — a Wheelblazer!

Zoo guides will be on hand with games, quizzes and hands-on activities featuring bears, penguins, elephants and birds. There will be a Cascade trivia table, and displays at the new Alaska Tundra exhibit will focus on this far northern region of our world.

The Zoomobile will have small animals to touch, pet and hold, and pelts, bones, skins and other animal specimens will be displayed on the Sidewalk Zoologist cart.

The zoo train will operate all day, with regular fares in effect.

Helping to make the day possible will be the Pacific Northwest Bell Tri-Cities Community Relations team, members of the West Linn Lions Club, and eighth grade students from St. Clare and Our Lady of the Lake Schools.

## PCC schedules
