The project is located on the campus of Oregon State University, Corvallis, Oregon. Bids will be opened and publicly read aloud in the Administrative Services Building "A", Room A110 by the Undersigned or his designated representative.

The projects consist of re-roofing approximately 10,054 sq. ft. of roof area on Kidder Hall, including but not limited to tear-off of existing asphalt shingles, application of new asphalt shingle roofing system and gutter repairs all in strict accordance with the plans and specifications.
