## ADVERTISEMENT TO BID

THE OPEN GATE PROJECT

Sealed bids will be received by the Owner, Tualatin Valley Mental Health Center, no later than July 22, 1985 at 1:00 P.M. at the office of Gary Dombroff, 14600 N.W. Cornell Road, Ptld.

The project consists of interior construction of new wall partitions, suspended ceilings, cabinet work, wall and floor finishes in an existing single story prefabricated metal building. Augmentation of existing mechanical, electrical, plumbing; and repair and addition of some exterior walks is also part of the work.

The contract will be awarded to the lowest responsible bidder provided that the bid has been submitted in accordance with the requirements of the contract documents and does not exceed the funds available and completion time stipulated in the proposal. The Owner wishes to occupy the building by September 9th, 1985. No bid will be considered unless fully complete in the manner provided in the "Instructions to Bidder" upon the bid form provided, accompanied by a bid bond.
