THE OPEN GATE PROJECT

Sealed bids will be received by the Owner, Tualatin Valley Mental Health Center, no later than July 22, 1985 at 1:00 P.M. at the office of Gary Dombroff, 14600 N.W. Cornell Road, Ptld.

The project consists of interior construction of new wall partitions, suspended ceilings, cabinet work, wall and floor finishes in an existing single story prefabricated metal building. Augmentation of existing mechanical, electrical, plumbing, and repair and addition of some exterior walks is also part of the work.

The contract will be awarded to the lowest responsible bidder provided that the bid has been submitted in accordance with the requirements of the contract documents and does not exceed the funds available and completion time stipulated in the proposal. The Owner wishes to occupy the building by September 9th, 1985. No bid will be considered unless fully complete in the manner provided in the "Instructions to Bidder" upon the bid form provided, accompanied by a bid bond.

Bidders shall be prequalified in accordance with Chapter 279 of Oregon Revised Statutes. Prequalification forms shall be completed and returned to the Owner 10 days prior to the date of the bid opening.

NONDISCRIMINATION: Bidders on this work will be required to comply with the provisions of Federal Executive Order 11246. The requirements for bidders and contractors are explained in the Specifications.

The project is funded in part with Community Development Block Grant funds and subject to all federal compliance requirements.

Sealed bids will be received by the Oregon State Board of Higher Education in Administrative Services Building, Room B100, Oregon State University, Corvallis, Oregon until 2:00 PM, PDT, August 6, 1986 for the Farrier School Manchester Arena, OSU Horse Center Project located on the campus of Oregon State University, Corvallis, Oregon. Bids will be opened and publicly read aloud in the Administrative Services Building "A", Room A110 by the Undersigned or his designated representative.

The project consists of furnishing all labor, Material, equipment, supervision, and doing all work to construct a Farrier School, consisting of site work, interior walls, new doors, window, skylights, forges, associated mechanical and electrical work, cutting and patching, and miscellaneous items all in strict accordance with the drawings and specifications.
