Sealed bids for the Rivergate Industrial District, N. Lombard Street/N. Marine Drive Landscape Improvements Between N. Simmons Road & T-6 Entrance Road, will be received by the Purchasing Manager of The Port of Portland, 700 N.E. Multnomah Street, Portland, Oregon, (mailing address: Post Office Box 3529, Portland, Oregon, 97208) until 2 p.m. August 29, 1985, and thereafter publicly opened and read.

MINORITY BUSINESS ENTERPRISE (MBE) INCENTIVE PROGRAM: A 2 PERCENT BIDDING ADVANTAGE WILL BE GIVEN TO BIDDERS WHO:

1. HAVE BEEN CERTIFIED BY THE PORT OF PORTLAND AS MBEs, OR
2. EMPLOY SUBCONTRACTORS THAT HAVE BEEN CERTIFIED BY THE PORT OF PORTLAND AS MBEs AND ARRANGE FOR THEM TO PERFORM WORK THAT REPRESENTS NOT LESS THAN 10 PERCENT OF THE TOTAL DOLLAR AMOUNT BID.

Scope:

Grade, irrigate, sod, and plant trees and shrubs for approximately 2,800 lineal feet along the north side of N. Marine Drive and N. Lombard Street from the Terminal 6 entrance road to Simmons Road in the Rivergate Industrial District.

Bids must be on the bid form which will be provided to prospective bidders and must be accompanied by a certified or cashier's check drawn on a United States bank or a bid bond payable to The Port of Portland in an amount equal to at least 10 percent of the total amount bid.

Bidders are required to prequalify. Prequalification statements must be received at least 5 days prior to the time set for bid opening. Applications for prequalification may be submitted less than 5 days before bid opening, but consideration by Port cannot be assured.

The drawings and the contract manual may be examined at Port offices. Copies may be obtained by prospective bidders at no cost.

Attention is called to the provisions of the Oregon Revised Statutes 279.350, providing that workers be paid prevailing wage rates.

FOR THE CONSTRUCTION OF A SECURITY FENCE

FRANZEN RESERVOIR

Sealed bids will be received at the office of the City Recorder, City Hall, Room 205, Salem, Oregon, until but not after 11:00 a.m., Local Time on September 4, 1985, at which time all bids will be publicly opened and read aloud at the Council Chambers, Civic Center, 555 Liberty Street S.E., Salem, Oregon for the "Construction of a Security Fence at Franzen Reservoir."

The proposed work consists of: Construction of 3,200 lineal feet of 72 inch chain link fence and miscellaneous appurtenant work.

Plans, specifications and other bid documents may be inspected and obtained at the office of the City of Salem, Department of Public Works, 555 Liberty Street S.E., Room 325, Salem, Oregon. The bidder shall not file the book of "Standard Construction Specifications" with his bid.

Bids shall be made on the forms furnished by the City, addressed, and mailed or delivered to the City Recorder, City Hall, Room 205, Salem, Oregon 97301, in a sealed envelope plainly marked "BID ON FRANZEN RESERVOIR SECURITY FENCE PROJECT," and the name and address of the bidder.

A surety bond, cashier's check or certified check of the bidder, made payable to the City of Salem, in the amount of ten percent (10%) of the bid must accompany each bid as security. Bid security of all save the three lowest bidders will be returned following the bid opening; all bid security will be refunded upon execution of the contract by the successful bidder.

No bids will be received or considered by the City of Salem unless the bid contains a statement by the bidder the provisions of ORS 279.350 shall be included in his contract.

Contractor's Prequalification Applications must be submitted to the City Purchasing Supervisor (1340 20th Street S.E., Salem, OR 97302) for approval, on or before August 27, 1985, which is at least five working days prior to the scheduled bid opening date.

Upon approval the bidder will receive a valid proposal for bidding purposes.

No bid shall be received or considered from any bidder who does not have an approved prequalification application on file with the City Purchasing Supervisor.
