## Attention

The Oregon Employment Division announced today a slight drop in the state's seasonally adjusted unemployment rate in July; down to 9.5\% from 9.8\% in June. The number of unemployed Oregonians fell by 6,300 while the number of employed Oregonians slipped 2,500.

The national civilian unemployment rate has made no movement for six months, remaining at $7.3 \%$ in July. The lack of improvement in this key indicator and the weak $1.7 \%$ annual rate of increase in the nation's Gross National Product during the second quarter is generating concern over the national economy, especially at a time of declining interest rates.

Oregon's nonfarm wage and salary employment fell 20,100 between June and July: 1,700 greater than anticipated based upon seasonal expectations. This prompted a 2 percentage point drop in the nonfarm wage and salary employment index to 108.5; the July 1984 level was 106.8

The U.S. Labor Department's Wage and Hour Division administers the Migrant and Seasonal Agricultural Worker Protection Act.

Vehicles used to transport farm workers must be properly insured, operated by licensed drivers and meet federal and state safety standards, according to a U.S. Department of Labor fact sheet.

The Fair Labor Standards Act applies to most of the workers in the U.S. It covers all workers who are engaged in or producing goods for interstate commerce or who are employed in certain enterprises, according to a U.S. Department of Labor fact sheet.
