Notice is hereby given that the Clackamas County Board of County Commissioners through its Community Development Division, will receive sealed bids until 2:00 p.m. on Thursday, October 10, 1986, for improvements to Risley Park, Oak Grove, Oregon. This project had been previously advertised incorrectly as being due on November 10.

Work includes installation of a new play structure and other site furnishings, improvements to the existing tennis courts, installation of new metal roofing at the existing picnic shelter, and installation of a new light fixture.

Bidders are invited to attend the bid opening in the Main Conference Room, Community Development Division, O'Hara Hall, Maryhurst College, Maryhurst, Oregon, at the above named time.

Bid security in the amount of ten percent (10%) is required in accordance with Instructions to Bidders.
