### Crime money should go to King & Eliot

The City of Portland recently received \$104,000 in federal grant money from the U.S. Department of Justice, Crime Prevention Division. The purpose of this grant is to provide aesthetic improvements and crime prevention measures in communities with a high crime rate.

This federal grant should be allocated to the King and Eliot neighborhoods. Although many neighborhoods throughout the city have felt the impact of the crime wave, none have been hit as hard as these communities. Both communities have experienced a high degree of crime for years.

Residential burglaries, prostitution, drug trafficking, and assaults occur regularly in the King and Eliot neighborhoods. Many run-down buildings and houses in these neighborhoods provide a haven for prostitutes and their customers, along with drug dealers and users. Church parking lots are even being used by prostitutes and drug dealers.

If this federal grant is allocated to the King and Eliot communities, it could be used to purchase lights for areas where crime is likely to occur and to secure vacated dwellings which will help deter acts of assault and robbery. Other ways the grant could be applied is to install locks in homes that are easy targets for burglars; trash and tall weeds in vacant lots could be cleaned up; signs could be placed along Union Ave. warning "Johns" (who usually reside outside the community) that soliciting the services of a prostitute is illegal and they run the risk of being arrested.

Decent citizens living in the King and Eliot neighborhoods have repeatedly demonstrated they are sincere in their efforts to eradicate crime from their communities. The King and Eliot Neighborhood Association, Crime Prevention Committee along with other community groups such as the Christian Women Against Crime have organized to fight crime.

On Oct. 8 last year, more than 130 residents marched in the rain along Alberta St. and Union

Ave. protesting the problem of drug dealing and prostitution. The march was sponsored by the King and Eliot Neighborhood Association, Crime Prevention Committee. The Committee has also held numerous pickets on the corner of N.E. Alberta and Grand Ave., in an effort to stop drug dealing on that corner. Although the Committee's efforts haven't ceased the sale of drugs on this corner, their work has resulted in a decrease in the number of young Black males who openly sell

Recently, more than 150 residents living in the King and Eliot areas voiced their frustrations at city and county officials during a panel discussion at the King Neighborhood Facility. The panel included Portland's Mayor Bud Clark; Multnomah County Commissioner Gretchen Kafoury; Program Coordinator Council for Prostitution Alternatives Susan Hunter; Community Service Multnomah County Corrections Harley Lieber; and Multnomah County District Attorney Michael Schrunk.

The Crime Prevention Committee of the Eliot and King Neighborhood Association should be congratulated for their efforts. However, the Committee is aware of the fact that their efforts to clean the streets of criminal activities is far from complete. For in order to eradicate crime, the residents living in these communities need the resources and cooperation of city officials. Toni Williams, an Executive Board member on the King Neighborhood Improvement Association, stated, "For years city officials have been ignoring the problem of crime in the King and Eliot communiites."

The new administration can demonstrate to residents living in the crime-prone neighborhoods that the city and the Police Bureau are concerned about crime in their communities. This can be done by using the \$104,000 federal crime prevention grant in the King and Eliot neighborhoods.

## **Shriners Hospital in Portland**

Portland is fortunate to have one of North America's 19 Shriners Orthopedic Hospitals. The Shriners have operated specialty orthopedic children's hospitals since 1922, and in Portland, have recently moved to a facility at 3101 S.W. Sam Jackson Park Road

The new 40-bed hospital provides a wide range of services including rehabilitation, education and research as well as treatment for a variety of orthopedic problems. The truly unique aspect of this hospital is that there is no charge for the services rendered.

The Shriners literature states: "All children from infancy to 18 years of age are eligible for treatment if, in the opinion of the hospital's chief of staff, there is a reasonable possibility that treatment will benefit the child and that treatment at another facility

would place a financial burden of the patient's family or guardian." Write to the Shriners Hospital, 3101 S.W. Sam Jackson Park Rd., Portland, oR 97201 for more information, or call

I was recently given a tour of the new Portland facility by Jill Laurence of the hospital's public relations department. Unlike most general hospitals, this one is geared toward children and the atmosphere does much to remove the sterility and threatening nature of most facilities. children who are about to undergo surgery "play-act" the actual surgery so as to minimize fears.

While the hospital can hold 40 children at a time, there are normally around 20 children at the hospital. The average stay is 10-12 days, although there are specialty outpatient clinics which serve a broader short term need, including one for cast removal and one for cerebral palsy patients

Though the "Shrine of North America" funds the Shriners Hospitals, there is no requirement that children served have any relationship to a Shriner. The special fund raising events like the circus and high school sporting events are but a few of the ongoing Shriner activities that help provide free care to needy children. All children are eligible to apply regardless of race or religion. ## **Escalation in Nicaragua**

Recent news that U.S.-backed Contras shot down a Nicaraguan Army helicopter with a Soviet-made surfaceto-air missile was coupled with administration charges of increased Cuban participation in Nicaragua's defense efforts. The events and the charges indicate a new escalation of the ugly war in Nicaragua-and a new round of scare tactics to pressure Congress into stepping up the United States'

According to U.S. government sources Nicaragua's Army has about 700 of those missiles, known as SA-7's. In July 1984 a State Department official predicted ominously that SA-7's would soon appear in the hands of rebel forces in El Salvador, presumably transferred from Nicaragua. That has not occurred, despite administration claims of a continuing flow of arms in that direction. Ironically, the missiles have instead been obtained and used by Contra forces. A spokesman told the Los Angeles Time that private contributors in the United States provided the money to buy them, and that retired U.S. Army General John Singlaub arranged for the Contras to receive essential training in their use and maintenance.

The State Department says that two of the 14 people killed in the downed helicopter were Cubans, and calls this evidence of a Soviet, Cuban and Nicaraguan "caner in the region." Whether or not there actually were Cubans present, condemning foreign involvement in Central American conflicts is a strange line for our government to take. U.S. pilots and ground personnel, working for the CIA or as mercenaries, have made numerous trips over and into Nicaragua to supply and assist Contra

groups, and at least two of them have died there. The CIA has mined Nicaragua's harbors and attacked its port facilities. In El Salvador's civil war, U.S. Air Force pilots regularly fly training and reconnaissance missions for the government forces and sometimes find themselves in combat. If "outside" (Cuban) participation in Nicaragua's Contra war is so wrong, how can the United States justify its own deep and growing involvement?

In rationalizing its military and economic campaign against Nicaragua, the Reagan administration stands reason and justice on their heads. An impoverished little country of barely three million people is pictured as a threatening military giant. Nicaragua, many times in this century the victim of U.S. aggression, is accused of unprovoked hostility toward us. Nicaragua is constantly denounced for human rights shortcomings, although its record is far superior to that of U.S. allies in the region such as Guatemala and El Salvador. Not least strange, terrorists and murderers become, in President Reagan's words, "freedom fighters" and "the moral equivalent of our founding fathers." It is consistent with this record that the current escalation of the war by the Contras is presented by U.S. officials as if it were somehow a provocation on the part of the government they seek to overthrow!

This logic doesn't work. The campaign against Nicaragua, which the administration wants to expand, is a mistaken policy that hurts U.S. interests in many ways. For example, the United States is increasingly at odds with its most important allies, none of whom support the U.S. embargo on trade with Nicaragua. Earlier this month a United Nations resolution calling for an end to the

embargo passed by a vote of 84 to 4; only Israel, Gambia and Grenada voted with the United States.

The credibility of the United States as a peaceful and law-abiding nation is eroding badly. Our government's refusal to answer Nicaragua's charges in the World Court looks very much like an admission of guilt. The damage these policies do to the role of law in international affairs may in the long run become one of the greatest costs of the administration's anti-Nicaraguan vendetta.

Secretary of State George Shultz was quoted as being "all for" Contra use of the SA-7's against Nicaraguan government forces. "I hope that the United States might itself take "further steps" against Nicaragua. This is shocking and sad. Escalating the war in Central America is not in the interest of the United States or any of the peoples in the region.

Elsewhere in the world Mr. Shultz sees things with different eyes. On Dec. 11 he said that "A country cannot be expected to make a concession to those who resort to terrorism and who treat negotiations as only a way station on the road to its ultimate destruction." He was speaking at that time of Israel's policy toward the Palestine Liberation Organization. It is unfortunate that the Secretary does not see that these words accurately describe the position of Nicaragua in relation to what, elsewhere, he would not hesitate to call external aggression.


