INVITATION TO BID

FOR THE REHABILITATION OF A 15-INCH SANITARY SEWER SYSTEM IN UNION STREET NORTHEAST, MILL CREEK TO WEST OF WINTER

Sealed bids will be received at the office of the City Recorder, City Hall, Room 205, Salem, Oregon, until but not after 11:00 a.m., local time on March 19, 1986, at which time all bids will be publicly opened and read aloud at the Council Chambers, Civic Center, 555 Liberty Street S.E., Salem, Oregon for "THE REHABILITATION OF A 15-INCH SANITARY SEWER SYSTEM IN UNION STREET NORTHEAST, MILL CREEK TO WEST OF WINTER."

The proposed work consists of: construction of 1,554 lineal feet of 12-inch polyethylene liner pipe, 118 lineal feet of 8-inch and 112 lineal feet of 6-inch sewer pipe, three (3) manholes, and miscellaneous appurtenance work.

Plans, specifications and other bid documents may be inspected and obtained at the office of the City of Salem, Department of Public Works, 555 Liberty Street S.E., Room 325, Salem, Oregon. The bidder shall not file the book of "Standard Construction Specifications" with his bid.

Bids shall be made on the forms furnished by the City, addressed, and mailed or delivered to the City Recorder, City Hall, Room 205, Salem, Oregon 97301, in a sealed envelope plainly marked "BID ON UNION STREET NORTHEAST SEWER RELINE PROJECT," and the name and address of the bidder.

A surety bond, cashier's check or certified check of the bidder, made payable to the City of Salem, in the amount of ten percent (10%) of the bid must accompany each bid as security. Bid security of all save the three lowest bidders will be returned following the bid opening; all bid security will be refunded upon execution of the contract by the successful bidder.

No bid will be received or considered by the City of Salem unless the bid contains a statement by the bidder the provisions of ORS 279.350 shall be included in his contract.

Contractor's Prequalification Applications must be submitted to the City Purchasing Supervisor (1340 20th Street S.E., Salem, OR 97302) for approval, on or before March 11, 1986, which is at least five working days prior to the scheduled bid opening date. Upon approval the bidder will receive a valid proposal for bidding purposes.

No bid shall be received or considered from any bidder who does not have an approved prequalification application on file with the City Purchasing Supervisor.

NOTICE TO CONTRACTORS

Sealed bids for the construction of a Water Treatment Plan for the City of Vernonia, Columbia County, Oregon will be received by the City until 7:00 p.m. P.S.T., April 1, 1986. Bids submitted prior to the opening will be received by the City Recorder, City Hall, 919 Bridge Street, Vernonia, Oregon.

Bid opening will be conducted in the Council Chambers of the Vernonia City Hall, and publicly opened and read aloud.

The project includes a basic bid for the construction of a 1.0 mg water treatment plant with package treatment units, masonry structure and appurtenant mechanical and electrical construction, an intake structure and Rock Creek channel stabilization improvements. An alternate for construction of a 1.5 mg water treatment plant is included.

Contract documents may be obtained by pre-qualified prospective bidders upon receipt of cash or check made payable to the Engineer in the amount of \$50.00 for each set. Deposits made upon procurement of drawings, specifications, and forms within the Contract Documents will be refundable upon their return in good condition after the opening of bids.

Bidders must pre-qualify with the Owner through the Engineer, on Standard Oregon Review Board Pre-qualification Forms, ten days prior to the bid opening. If a pre-qualification form is on file with the Engineer and is not over one year old, re-filing is not necessary unless there has been a substantial change in Contractor's status.

Bids must be accompanied by a Bid Bond executed in favor of the City of Vernonia in an amount of ten percent of the total amount of the bid.

Any bid awarded pursuant to this Notice to Contractors will be subject to approval by the City of Vernonia, the U.S. Department of Housing and Urban Development through the Community Action Team of Columbia County and the Farmers Home Administration as to form and content of the Contract between the City of Vernonia and any successful bidder.

The City of Vernonia reserves the right to reject any or all bids and to waive all informalities. No bidder may withdraw or modify their bid after the hour set for the opening and thereafter until after the lapse of sixty (60) days from the bid opening.
