**INVITATION FOR BIDS**  
**WATER SYSTEM IMPROVEMENTS**  
**WATER MAIN REPLACEMENT**

Sealed bids for the construction of water system improvements will be received at the Banks City Hall, Banks, Oregon, until but not after 8:00 P.M. local time on September 15, 1986, at which time and place all bids will be publicly opened and read aloud.

The proposed work is essentially as follows:

Watermain replacement consisting of:

- 3,643 lineal feet trench excavation and granular backfill
- 980 lineal feet trench excavation and native backfill.
- 4,713 lineal feet of 14 inch ductile iron pipe
- 67 water service installations
- 8 fire hydrant installations
- 9 connections to existing pipelines
- 3,638 lineal feet of paved street restoration
- 1 pipeline boring under railroads

The work is located in and adjacent to the City of Banks, Oregon.

Bid documents may be obtained from Klein Consulting Engineers after receipt of \$25.00 deposit which is non-refundable.

This project is financed through the Community Development Block Grant Program with funds ob-

tained from the U.S. Department of Housing and Urban Development. The contract will be subject to regulations of the Departments of Labor and Housing and Urban Development.

Attention is called to Federal provisions for Equal Employment Opportunity, Affirmative Action, HUD Section 3 requirements, and the minimum salaries and wages as set forth in the contract documents.

Bids shall be in a sealed envelope clearly marked "Bid for Bank Water System Improvements" along with time and date of bid opening and name and address of the bidder, addressed and mailed or delivered to City Recorder, City Hall of Banks, P.O. Box 428, Banks, Oregon 97106.

All bids shall be accompanied by a bid bond equal to ten percent (10%) of the total bid, to be forfeited to the City of Banks in the event of failure of the contractor to execute the contract within ten (10) days after acceptance of the bid and award of the contract. A one-hundred percent (100%) payment bond will be required to guarantee the faithful performance of the contract.

Bidders must be prequalified in accordance with the laws of Oregon. Completed prequalification applications are to be submitted to Klein Consulting Engineers not later than seven (7) days prior to bid opening.

The City of Banks reserves the right to reject any or all bids, to postpone the award for a period not to exceed sixty (60) days from the date of the bid opening, and to accept that proposal considered to be in the best interests of the City of Banks.
