

## INVITATION TO BID

Notice is hereby given that Clackamas County, through its Community Development Division, will receive sealed bids until 2 p.m. October 21, 1986 for the Kennell Avenue Storm Sewer Improvements, Molalla, Oregon.

The proposed work consists of furnishing all labor, materials and equipment for the construction of approximately 1050 lineal feet of storm sewer improvements and appurtenances.
